FUNDRAISING EVENT



REGARDING THE DISPOSAL/DISPOSITION OF MOUNTED SPECIMENS: DID YOU KNOW?

According to Virginia law, you may now sell any part of, or all of, a deer to anyone at anytime. Any mounted specimen (including bears) may be sold but the sale must be through a licensed auction house such as an estate sale.

Migratory birds are subject to Federal law, as are species not native to Virginia.



PRIZE DRAWING INFORMATION

VIRGINIA PENINSULA SPORTSMEN'S ASSOCIATION

This day and age there is much confusion out there regarding deer, bear, and turkey citations in Virginia. You have the "Richmond" show which has already come and gone in August, the Izaak Walton League Show, which happened in Harrisonburg in the early part of September, but please don't forget about the Virginia Peninsula Sportsmen's Association (VPSA) show in Southampton County.

The VPSA hosts its annual BIG GAME CONTEST in September to recognize those successful sportsmen who harvested citation size Deer, Bear, and Turkey last season. The VPSA is the only show in Virginia that still scores under the traditional VIRGINIA SCORING SYSTEM. Each qualifying entry receives a Virginia State Citation and is placed in the contest. This year the contest includes a Western Regionnal, Eastern Regional, and State Competition under one roof. VPSA's goal is to have a western regional held annyally in the west but the VPSA is in need of a western partner to host the event in the future.

The VPSA, headquartered in Williamsburg, is a group of sportsmen who serve sportsmen. We founded the BIG GAME CONTEST in 1940 and developed the Virginia Scoring System for deer and bear. We hold a 78 year old record book that can most accurately determine where a deer ranks all time in the Commonwealth. In the early years we assisted the game department with the Whitetail Deer recovery effort in the Commonwealth. Our members had a deer holding pen in Newport News, which is today known as Deer Park. Our contest is the oldest in the country and we have 78 years of records from the Commonwealth of Virginia. 
