- **Electricity is NOT provided.** Quiet generators are allowed. Electrical cords must be new or in good condition and not frayed, taped, or spliced. They must be taped down or covered for safety.
- **Set Up:** Vendors may begin set up at 9 a.m. Booth items will need to be carried to the vendor area. The unload location is the intersection of 11<sup>th</sup> Street & G Street.
- **Take Down:** Vendors may begin take down at 3 p.m. Vendor space must be left clean.

### Rules and Regulations:

- All vendors must be students ages 6-20.

- I understand that there is a fee of \$30 to participate which includes the cost of a City of Reedley temporary business license. Forms and payment should be submitted to the Greater Reedley Chamber of Commerce.
- I acknowledge that all products must be handmade by the student(s) and cannot include food items or store-bought/resale items.
- I agree that all vendors must stay for the entirety of the event and assist with clean-up afterwards.
- I am aware that parents or guardians must assist vendors under the age of 12 with sales and clean-up.
- I understand that selling raffle tickets independently of a product purchase is not permitted, but offering a raffle ticket for free or with a purchase is allowed.

**Agreement:**
