Cleanup

You may bring food to serve during the birthday party. Please do NOT bring outside drinks. Canned sodas and additional drinks can be purchased at regular menu price. Alcoholic beverages are prohibited on Sweet Kuppz property at all times.

Guest Conduct

All guests are expected to behave responsibly at all times. Children must be supervised by an adult at all times. Sweet Kuppz will issue a single warning for unruly conduct prior to asking guests to leave the premises.

Liability

By signing this birthday party contract, you release Sweet Kuppz from any potential liability. You agree to indemnify and hold harmless Sweet Kuppz and its employees for any damages, loss, or injury that may occur. Should Sweet Kuppz property be lost or damaged due to the activities of any of your party’s attendees, you agree to reimburse Sweet Kuppz for replacement or repair of said property.
