NEW for 2025: Families are responsible for a non-refundable \$30 deposit per week at the time of registration. This deposit will be applied to the total balance owed for camp. Camper registrations are not solidified until parents pay in full or begin making payments for camp through CRFP by the assigned deadline. Payments may begin as early as January 28, 2025. The last day begin payments using
