1. PROTECTED SPECIES

Mangroves, namely *Rhizophora mangle*, *Conocarpus erectus*, *Avicennia germinans*, and *Laguncularia racemosa*

2. PERMITTED ACTIVITIES

- The placement of coir rolls on the coastal ridge of 15D/75 and 21E/58 to provide temporary shoreline stabilization with bioengineering for natural coastal planting. The coir rolls are a 100% natural product made from coconut fibres which will be fixed in place with wooden stakes by hand.
- The planting of the following species as indicated by the applicant in the parcels and on top or inside of the coir rolls that will be supplemented with seaweed, soil and possibly hydrogel: *Rhizophora mangle* (Red Mangrove), *Conocarpus erectus* (Green Buttonwood), *Sesuvium portulacastrum* (Sea Purslane), *Tornefortia gnaphalodes* (Sea Lavender), *Bacopa monnieri* (Water Hyssop), *Batis maritima* (Saltwort/Beachwort), *Avicennia germinans* (Black


SPECIAL CONDITIONS

- Public access along the shoreline shall not be blocked, hindered or restricted at any time.
- Works shall take place behind the sargassum line outlined in the application.
- No sand or stones shall be removed from the existing beach ridge.

STANDARD CONDITIONS

- Report of activities to be submitted to Department of Environment upon completion of project, indicating whether report is a confidential or public document. Report should include a map of all collection sites, showing protected areas.
- Copy of any public reports, publications, etc., if significantly different from public document submitted above, to be remitted to Department of Environment for archival and reference purposes.
- Actions will be conducted as described, including in any submitted application documents, and abide by the terms, conditions, procedures, etc., of this Permit.
- Property rights and other laws of the Cayman Islands will be respected. This permission covers no other potential regulation, including Customs, Immigration, Trade & Business, Port Authority, etc.
- This Permit or application may be published, reported or decided in public by National Conservation Council.
- This permit will be subject to periodic review, and can be revoked at any time for any violation of the permit the Act or other Cayman Islands regulations, or in the interest of affected protected species.
- Issuance of this permit does not guarantee the issuance of future permits for the same or similar activities. Including for ongoing activities.
- Department of Environment may conduct inspections of activities to check compliance with Permit requirements, restrictions, conditions, etc.
