MEETING MINUTES

OCTOBER 14, 2021

Participants: Dirk Benson, Donna Karl, Frank Ammirata, Ralph Fox, Deidre Crabtree and Corry Meyer. Debbie Martorano and Dan Ellis were not in attendance.

Meeting called to order at 6:35 by Dirk Benson. Guests: Dan St. Germain

The Board decided to send a ballot to decide two issues: whether to deed our small portion of Rae Road to the city, and what to do with the East Pond. This ballot was sent via email and U.S. Mail to all HOA members on October 22. If you did not receive yours, please contact Terrie Harris at HOA Mgt (terrie@hoa-bend.com)

Commons:

JR and the crew will continue to pickup debris until November 15th.Please do not put any piles on the street past then. After mid-November, please use your yard waste bins or haul to the dump. The crew also focused on limbing up trees we marked for fire danger. They are gathering large debris piles in the commons and will pick them up with a tractor when the ground hardens.

Treasurer:

Dan Ellis provided a report of our balance sheet and bank statements to Dirk a day prior to the meeting. All were in order and reconciled to each other. The Board reviewed and approved the budget report 6-0.

Firewise:

Frank reported that he collaborated with Marie Phyllis and Bert Neumeier and submitted a grant request for funds to continue our fire fuel reduction and education efforts. Tillicum Village received the full \$5,000. Thank you, Frank, Marie and Bert! Excellent work.

CC&R Compliance

The Board addressed a concern from one homeowner who wanted to know when the Board had implemented rules to prohibit short-term rentals in the **Rules for Rental Properties in Tillicum Village** document. We replied that short-term rentals have never been allowed in Tillicum Village. A **No Boarding Houses** rule existed in the original founding Building Use Restrictions document and had been clarified and language modernized in two versions of the Rules for Rental Properties document over the years to read (no AirBnB, Vacation Rentals, etc.)

Roads:

Crack sealing on the village owned private streets was completed in early October for a cost of \$10,800. The Board had budgeted \$8,000 this year for road maintenance so we only had to dip into the Road Reserve fund for about \$2,800. Crack sealing should be performed every 2-3 years.

Projects:

Ralph reports that the mailbox project is mostly complete. The crew fixed many wooden supports, painted where necessary and replace all address numbers on all stands. Many thanks to Ralph Fox, Bob Karl and Dan Sempert for their excellent work and dedication. The same crew will now focus on repairing and replacing aging rail fencing along walkways and roadways as needed. If you would like to volunteer your help, please contact Ralph (716) 307-2858

As stated above, the East Pond Project put two questions into the voting pamphlet and ballot that was sent October 22.







You can make your home safer from wildfire. Learn how with these helpful tips!




Home Safety Checklist

Simple fixes from roof to foundation to make your home safer from embers and radiant heat.

HOME SAFETY CHECKLIST

- Clean roofs and gutters of dead leaves, debris and pine needles that could catch embers.
- Replace or repair any loose or missing shingles or roof tiles to prevent ember penetration.
- Enclose under-eave and soffit vents or screen with metal mesh to prevent ember entry.
- Cover exterior attic vents with metal wire mesh no larger than 1/8 inch to prevent sparks from entering the home.
- Repair or replace damaged or loose window screens and any broken windows.
- Screen or box-in areas below patios and decks with wire mesh to prevent debris and combustible materials from accumulating.
- Move any flammable material away from wall exteriors – mulch, flammable plants, leaves and needles, firewood piles – anything that can burn.
- Remove anything stored underneath decks or porches.
