

# KAYLEIGH'S LAW:

#### LIFETIME NO-CONTACT INJUNCTIONS



### What is a Lifetime No-Contact Injunction?

Victims of certain **felony** crimes that occurred in Arizona may be eligible for a court order prohibiting a defendant from contacting them for their lifetime under A.R.S. § 13-719.

### Am I Eligible for a Lifetime No-Contact Injunction?

To obtain a lifetime no-contact injunction, the following conditions must be met:

- · There must be a qualifying conviction.
- · The conviction must include at least one:
  - Dangerous offense as defined by A.R.S. § 13-105
  - Serious offense or violent or aggravated felony as defined by A.R.S. § 13-706(F)
  - Sexual offense as set forth in A.R.S. § 13-1401 to 13-1428, or
  - Sexual exploitation of a child offense as set forth in A.R.S. § 13-3551 to 13-3562
  - Strangulation (a form of aggravated assault) as set forth in A.R.S. § 13-1204(B)
  - . Stalking as set forth in A.R.S. § 13-2923

Preparatory offenses (attempt, solicitation, conspiracy, and facilitation) involving the crimes listed above are eligible for the lifetime injunction.





## How do I obtain a Lifetime No-Contact Injunction?

A lifetime no-contact injunction may be requested directly from the court by a victim or an attorney on behalf of the victim.

A lifetime no-contact injunction can be obtained by:

- Preparing and submitting the following forms to the Clerk of the Superior Court in the jurisdiction where the crime occurred:
  - · Petition for Lifetime No-Contact Injunction
  - · Confidential Victim Information Sheet

Once the court issues the lifetime no-contact injunction, it must be served before it goes into effect. The injunction is not in effect until it has been served on the defendant.

## How do I get my Lifetime No-Contact Injunction Served on the Defendant?

Arizona law requires that Arizona law enforcement for the city in which the defendant resides must serve the lifetime no-contact injunction. A.R.S. § 13-719(D). There is no provision for service on defendants residing outside of Arizona; a process server must be used at the victim's expense.
