Darley Civic Association Meeting Wednesday November 6, 2024

In attendance:

President (Dan Schmick) calls the meeting to order.

Secretary (Ken Velasquez ) reads the minutes from last meeting. Minutes accepted.

## President takes over meeting to talk on old/new business:

Representative Cartier is not with us tonight. Dan reached out to see if someone from Hanby would come to talk about the estate/Chestnut Street, has not received a response yet. Reached out to local politicians, no one else with us tonight.

#### Meeting passed to Treasurer (Mark LaVere)

Talked through our financial statement, not much new.

- Jason is still interested in doing the neighborhood plowing, needs to talk to Anthony about a new contract.
- Still need a co-signer for bank, Francis West is currently on it. Talked to bank, just need someone to go to bank with ID. There is a question on how to do it Dan (President) agrees to do for now. Motion to have Dan do passed.
- Mill race vacant house was going for Sheriffs sale list, but paid fines/taxes of about \$25K, still an issue.

#### **Back to Dan**

- Spoke with Sean Matthews on Chestnut Street, didn't have much to report. There is a new system for car rating, and it has been re-paved.
- Sink hole in Indian Field was fixed, though there is another on South Trail (drain collapsing). There was a water main brake, grates are collapsed. Deldot said they would come back but haven't been seen. Sean Matthews sent email, but haven't gotten any movement.

- Shannan asked about block party. It was great success. Transferred site to Mill Race worked out great and is happy to do it again next year. Steve and wife along with Wendy (other house) happy to have it back by their house next year. New date scheduled for June 7, 12-4PM, same location, first weekend in 2025. Will ask Joe to put on the Darley Civic website. Shannan has a Facebook group running, will also post there.
- Steph Hummel new neighbors moved in next door to Steph and Steve. We have not sent a 'welcome' gift to Ann (new neighbor). Mark asked if she has info on neighborhood, dues, etc. We have not sent a 'welcome' gift yet. Mark asked Steph to ask for a reimbursement for the gift. Also "new" neighbors at 25 Indian Filed Rd have been there 1 year already.
- Talked about documents on the Darley Civic website by-laws are up, need to add meeting minutes from the last couple of meetings.
