Dan Schmick (President) brings the meeting to order. Agenda is discussed.

Ken Velasquez(Secretary) reads meeting minutes from May 2023 meeting. Minutes accepted by association members in attendance.

Mark LaVere (Treasurer) reports on association financial statement - hand out with expenditures and total balance (statement attached). Highland Woods dues are about 100% paid, Indian Field unknow at this time. Questions from the group? We have home owners at the meeting (7 years) that didn't know of the association - they live on Darley road. Mark explains dues (\$15 for Darley Rd residents - state plows road). Susan Hartnett (Vice President) asks if we have additional info on how dues are paid by assocition members. Mark explains the current process with payment on the new website (darleycivic.com). Paper checks still ok? Process?

Lorraine Hewit (Welcoming Committee) question: can we put a little library for books (?) on a corner in Indian Field? Any money available for it / where would that money come from? Dan asks we come back to the question shortly. Treasurer report approved.

Anthony Uro (Director, IF) has a plowing update. Jason Shelton of HW (Turf Landscape) will now do the plowing and salting for HW and IF. Plowing is automatic if ther is 2 inches of snow. He will salt entrances, Big Oak, and (other hill) in Indian Field. Anthony says we have missed (salting/plowing) in the past, but can reach out to him if we have any issues with plowing. Snow barrels with sand in them are at entrances to IF/HW. Passed time to order additional barrels, but we can order more next year if done earlier.
