The October financials were approved with a motion from Tonya Sharp, second from Cynthia August, the motion carried, no public discussion.

In old business, the first item on the agenda was the Occupancy Tax update -Director, Patty Alford gave an update from recent inquiries of the new Occupancy tax with the new collection that were effective July1, 2025. An email was read from Jamie Butts of the Washington Parish Sheriff's Tax Collection Department.

Next in new business, the Executive Director's Report was presented. A motion to accept the report came from Krystal Peterson, second by Lorraine Hall, no public discussion, the motion carried, no public discussion.

Edna Kennedy next made a motion to enter in a CEA with the State of Louisiana for \$25,000 for what would be labeled as Wyble Funds, as those were legislative allocations awarded by our State Representative John Wyble for 2025-2026. Tonya Sharp seconded the motion, the motion carried by all, no public input.

Cynthia August made a motion to accept the revised 25-26 budget to include the Wyble Funds, seconded by Edna Kennedy, the motion carried unanimously, no public input. Edna Kennedy brought attention to the salary of the Executive Director, and President Ella Bickham, noted that it would be discussed at the next Building/Budget Committee meeting upcoming to be presented at the December meeting.

Cynthia August made a motion to submit Commissioners Lorraine Hall, Ella Bickham, and Kim Windham to the Washington Parish Council for reappointment without hesitation, the motion seconded by Edna Kennedy, the motion was approved by all, no public input.

Nick Gagliano from the Gagliano Group presented a new advertising campaign that encompassed the Wyble Funds. Kim Windham made a motion to accept that proposal, a second from Krystal Peterson, the motion carried by all, no public input. A December 4, action news video would be recorded highlighting Christmas activities. May 3-9, 2026 was noted a State Tourism Week.

In sponsorship and advertisements, a motion came from Cynthia August, second by Edna Kennedy that the Tourism Office would only support parades in the form of parade throws. No monetary sponsorships would be made to Parish Parades. The motion was carried unanimously, no public input.

Krystal Peterson made a motion to adjourn, seconded by Tonya Sharp, no public discussion, the motion carried unanimously. The next meeting is scheduled for December 19, 2025 at 10:00 am, with Christmas luncheon to follow.
