JRSRA CODE OF CONDUCT

The code of conduct for any contestant, parent, guardian, family member, a person associated with a stock contractor and/or producer, will include but it is not limited to the following:

- NO display of unsportsmanlike behavior.
- NO consuming alcoholic beverages nor the use of any illegal substances.
- NO unbecoming language; including swearing, belittling, and harassing.
- NO bullying.

In the case of violations, the JRSRA Board of Directors my impose:

- o First Step: Warning
- o Second Step: \$100 fine
- o Third Step: Indefinite suspension

The disciplinary action will be progressive however the Board reserves the right to combine or skip steps depending upon the facts of each situation and the nature of the offense. In addition, a contestant may also be subject to disqualification should a parent, guardian, or family member disrespect the code of conduct.
