Terms/Definitions

Performer - Refers to the person **(You)** performing for the role.

Product - Refers to the audio, video, photo etc. the **Performer** will appear in

Written Notice - Refers to email, text, letter, and any form of electronic, or handwritten communication.

Verbal Notice - Refers to any verbal communication including telephone, voicemail, verbally in person, and via any form of verbal electronic communication.

Quarterly - Refers to every 3 months (e.g., January, April, August, December) etc.

Terms and Conditions of Service

The **Performer** agrees to the following **statements**:

- I am of legal age.

- I agree that I have the right and competence to enter into this Agreement, and that I am not restricted by any commitments, or third-party interest.
- I agree to discuss any pre-existing injuries prior to filming and take responsibility for any injuries caused by my own negligence.
- I understand my likeness, image, name, voice, and appearance is being recoded and is being used as part of a production.
- I give the **Producer** the permission to use my likeness, image, name, voice, and appearance in any way they see fit (video's, audio's etc.).

 all clearances and copyright etc. for use of my likeness, image, name, voice,
 and appearance in the *Product*.
- I grant the *Producer* permission to use, sell, broadcast, exhibit, market and distribute the product in which I will be appearing in
- I agree that the *Producer* has no financial obligations, or commitment to me
 as a result of entering into this Agreement.
- I release the *Producer* from all claims known and unknown arising from the use of my likeness, image, name, voice, and appearance etc.

The **Producer** and **Performer** agree to the following **terms and conditions**:

- To discuss any boundaries, and pre-existing injuries prior to filming.
- For wrestling scenes where close body contact is required the *Producer*and *Volunteer Performer* will disclose any contagious skin conditions; will
 ensure they are clean prior to filming.
- Should the *Producer* need to cancel the production, Written or Verbal Notice will be given within 12 hours of the start of the production.
