# STANDING RULES GOVERNING RESOLUTIONS

(Revised April 29, 2022)

## A. GENERAL

- a. The subject matter of all resolutions shall be germane to the interests or work of GFWC Virginia and must be statewide in scope.
- b. Proposed resolutions shall be submitted to the Resolutions Chairman.
- c. Proposed resolutions may originate within the Resolutions Committee.
- d. Upon adoption, all resolutions become an integral part of the program of GFWC Virginia.
- e. Responsibility for carrying out the intent of resolutions rests upon the President, the Community Service, Standing and Special Committees to whose work it is germane, the Legislation Chairman and member clubs.
- f. General Federation of Women's Clubs resolutions in effect become a part of the program of GFWC Virginia.
- g. An index of GFWC Virginia Resolutions is listed in the Yearbook. A complete copy can be found on the GFWC Virginia website.

## B. PRESENTATION OF RESOLUTIONS

- a. Any member wishing to propose a resolution shall first submit the proposal for opinion to the Community Improvement Program Chairman, Standing and Special Committee Chairman to whose work it is germane.
- b. Proposed resolutions shall be submitted to the Resolutions Committee Chairman, accompanied by proper supporting documents by November 1. Only emergency resolutions shall be accepted after November 1. A copy shall be sent to the President.
- c. Any resolution involving legislation or legal document must be accompanied by a copy of the legislation or legal document to assist the Resolutions Committee in interpreting the resolution.
- d. When appropriate, specific methods of implementation shall be outlined in the resolution.
- e. Except for emergency resolutions and resolutions originating under new business, all resolutions to be presented to the Annual Convention shall be included in the Call to the Annual Convention.
- f. A proposed resolution which is not approved by the Resolutions Committee may be introduced by its proponent as a motion at the next Annual Convention as a matter of new business. The President and the Resolutions Committee Chairman shall be notified prior to the start of the Annual Convention.

## C. EMERGENCY RESOLUTIONS

- a. Emergency resolutions are those whose subject matter has arisen since the distribution of the previous Call to Annual Convention or those which are governed by a definite time limit and upon which delayed action would be disadvantageous.
- b. Emergency resolutions to be presented at the Annual Convention must have the prior consent of the President.
- c. Emergency resolutions to be presented at the Annual Convention shall be distributed to the delegates prior to presentation.

#### D. LIFE OF RESOLUTION

- a. Resolutions establishing the program of GFWC Virginia shall continue in effect until their purpose has been accomplished or the resolution has been rescinded by the delegate body.
- b. All resolutions which have been in force for four years shall be automatically reviewed by the Resolutions Committee.

#### E. RESCINDING RESOLUTIONS

- a. Intention to rescind a resolution must be included in the Call to the Annual Convention.
- b. Proposals to rescind shall follow the usual procedures for consideration of resolutions.

#### F. MINORITY OPINION

- a. A Minority Opinion shall be recorded in the Minutes.
- b. When a club wishes to register a minority opinion, it shall send a letter to the President.

#### G. DISSENT FROM GENERAL FEDERATION OF WOMEN'S CLUBS RESOLUTIONS

- a. Proposals to dissent from General Federation of Women's Clubs resolutions shall come from at least two of those persons or groups eligible to present resolutions: the Executive Board, the Junior Executive Board, a District or Club, a Community Service Program Chairman, Standing or Special Committee Chairman, provided the President has been notified of proposed action ten days prior to the opening of the Annual Convention.
- b. Should the members present and voting at Annual Convention approve a proposal to dissent from a resolution adopted by the General Federation of Women's Clubs, written notice of such action shall be forwarded to the General Federation of Women's Clubs International President and the GFWC Chairman to whom the resolution is germane.
- c. In supporting the action taken, GFWC Virginia members shall state that this is a minority opinion of the General Federation of Women's Clubs.

## **AFFIRMATION OF WOMEN**

WHEREAS, More and more women, due to death or divorce, are heads of single parent homes; and

WHEREAS, The complexities of modern society offer financial, social and educational challenges; and

WHEREAS, GFWC Virginia, since its founding, has endeavored to enlighten the lives of women and has been an advocate of social and economic change for the advancement of women; therefore

RESOLVED, That GFWC Virginia encourages each member club to include in its yearly planning, programs and projects which address financial, social and educational needs of its members.

## **COMMUNITY GROUP HOMES FOR JUVENILES**

WHEREAS, Juvenile delinquency and youth in need of services are increasing at an alarming rate; and

WHEREAS, The best hope of preventing and controlling juvenile delinquency is through programs of adequate community-based services; and

WHEREAS, The juvenile court has too few alternatives to the commitment of children into State care because of the absence of local treatment and training programs; and

WHEREAS, It is estimated that some children presently being committed to the State can be rehabilitated within the locality if adequate resources are available; therefore

RESOLVED, That GFWC Virginia recommends that State reimbursements, similar to those provided in the development of juvenile detention facilities, be made available to communities for the promotion of family-oriented community group homes programs, which will work, insofar as possible in conjunction with the Family Courts, Probation Departments and the Department of Social Services.

WHEREAS, One of the most important functions of government is to protect the inalienable right of the citizen to be secure in person and property within his home and in his movement through the streets, parks and countryside; therefore

RESOLVED, That GFWC Virginia urges its member clubs to work with other organizations and law enforcement agencies to study the crime situation in their communities, examine the resources available to prevent and reduce crime, initiate and promote programs, in cooperation with law enforcement agencies, that combat crime.

## **ECONOMIC WORTH OF HOME PARENT**

WHEREAS, The home parent provides an invaluable service to her home and family; and

WHEREAS, Laws affecting homemakers, including those dealing with property ownership, divorce, and death, may exclude or understate recognition of the homemaker's contribution to the family, especially because they receive no income; therefore

RESOLVED, That GFWC Virginia works to change existing laws affecting homemakers that undervalue their economic value; and further

RESOLVED, That GFWC Virginia supports legislation that fully recognizes the economic worth of homemaking.

## **FAMILY VIOLENCE**

WHEREAS, Family violence in the United States is widespread, cutting across age, ethnic, racial, educational, and socio-economic lines, resulting in physical abuse and deaths within the family and among law enforcement officials responding to situations of domestic violence; and

WHEREAS, Family violence is a cause of emotional and behavioral disturbance in children and adults and battering and battered spouses often batter their children who, in turn, become violent adults, thus perpetuating the cycle; and

WHEREAS, There is a need for emergency shelters for victims of family violence as well as confidentiality of address; therefore

RESOLVED, That GFWC Virginia shall initiate and actively support legislation and programs which will:  
Identify violence-prone families and suspected cases of child abuse and battered spouses;  
Provide emergency aid and shelter for those who are forced to leave family settings; and  
Provide treatment for victims and perpetrators of family violence; and  
Provide for a system to assure confidentiality of addresses of victims of family violence; and further

RESOLVED, That GFWC Virginia will enlist the help of health care professionals, legal and law enforcement agencies, court advocates, religious and civic organizations, and the general public to recognize and eventually eradicate family violence.

## **FOREIGN OWNERSHIP OF LAND**

WHEREAS, There are ever increasing purchases of American land by other than American citizens; and

WHEREAS, Many of the purchasers are unknown with purchase negotiated through representatives with undisclosed intent of the usage of the property; therefore

RESOLVED, That GFWC Virginia urges local and state authorities to exercise more control and to place adequate restrictions on the purchase of Virginia properties by foreign interests.

## **HUMAN TRAFFICKING**

WHEREAS, Human trafficking is considered to be a modern-day form of slavery involving victims typically forced, defrauded, or coerced into sexual and/or labor exploitation; and

WHEREAS, Human trafficking is a \$150 billion global criminal enterprise and a fastest growing global crime that cuts across race, nationality, gender, age, and socio-economic background; and

WHEREAS, The International Labor Organization estimates that there are 40.3 million victims of human trafficking globally; and

WHEREAS, In 2018, Virginia ranked 10th in the US for reported cases of human trafficking; therefore

RESOLVED, That GFWC Virginia urges its member clubs to:

- promote awareness and prevention by educating their members and communities about the seriousness, prevalence, and warning signs of human trafficking
- advocate for victims' support, protection and recovery, and support related legislation
- work towards ending human trafficking

## **MANDATORY SENTENCING FOR SEXUAL ABUSE AND MOLESTATION OF CHILDREN**

WHEREAS, Sexual exploitation of children causes permanent psychological and physiological damage; and

WHEREAS, Statistics reveal many sexually exploited children, as young as eight years old, are runaways and others even as young as three years old are used by their parents or guardians for sexual exploitation; and

WHEREAS, The present criminal justice system often fails children and society in general in adjudication of child abuse cases, and children are not capable of protecting themselves; and

WHEREAS, The billion-dollar pornography industry's newest growth area is child pornography; and

WHEREAS, There is evidence of an alarming misuse of internet sites by sexual predators; therefore

RESOLVED, That GFWC Virginia demand enforcement of existing laws concerning sexual exploitation of children and actively initiate and support new legislation where needed; and further

RESOLVED, That GFWC Virginia shall encourage and support awareness programs that are designed for a child's understanding of sexual exploitation so that he/she can communicate with a responsible adult if a problem exists and to deal better with the emotional trauma if he/she has been abused; and further

RESOLVED, That GFWC Virginia urges the adoption of laws which will provide that any proven involvement with the production and sales of explicit sex pictures of minor children, or the use of children in live performances exhibiting sexually explicit conduct or for the purposes of prostitution or any other sexual exploitation of children, shall be considered a felony with mandatory minimum prison sentences and fines for convicted individuals.

## **PRISON REFORM**

WHEREAS, The concept of punishment alone as a deterrent to crime has been outmoded by statistics and by modern scientific studies of treatment of criminals which take into account the physical, sociological, mental and spiritual aspects of personality; and

WHEREAS, Use of enlightened modern methods often develops reasonable, law abiding citizens with consequent reduction of repeated offenses and recommitments; therefore

RESOLVED, That GFWC Virginia urges its member clubs to continue study, and to urge their legislators to study recent advances in the conservation of human resources through psychological evaluation and wise use of all available methods of rehabilitation, and further, to encourage prison boards and administrators to take advantage of every possible resource in order that prisoners may be provided with and make use of:  
Psychological evaluation and psychiatric treatment when indicated;  
Adequate health standards and correction of physical defects where possible;  
Remedial education;  
Suitable job training;  
Opportunity for religious education and counseling;  
Opportunity for development of constructive use of leisure time; and further

RESOLVED, That efforts be made to improve rehabilitative services through raising educational and training standards of prison personnel and to provide adequate follow-up services upon release of prisoners in order to assist them in their adjustment as productive members of society.

WHEREAS, Many private pension plans have no provisions for income payments for a widow of any age;

RESOLVED That GFWC Virginia urges the government, at all levels, to enact legislation to assure equitable security benefits for women in all pension plans.

WHEREAS, There is need for continuing study, reevaluation, and supervision of the temporary aid to needy families to assure wise and proper use of funds; therefore

RESOLVED, That GFWC Virginia urges its member clubs to cooperate with proper authorities to avoid misuse of funds and correct inadequacies and inequities where they exist in the temporary aid to needy families; and further

RESOLVED, That GFWC Virginia urges that related state/local agencies and community resources be used to maintain a complete family unit and to assist the family to achieve economic independence.

WHEREAS, Alcohol/Drug related traffic crashes are the greatest single cause of death for young people and a leading cause of death for persons of all ages; and

WHEREAS, concerned persons are demanding permanent solutions to the problem of drunk/drugged driving; therefore

RESOLVED, That GFWC Virginia urges its member clubs to cooperate with other organizations in supporting community-based alcohol and drug prevention programs/projects; and further

RESOLVED, That GFWC Virginia urges its member clubs to support legislation to strengthen, update, and strictly enforce state laws regarding alcohol/drug sales and driving under the influence; and further

RESOLVED, that GFWC Virginia urges its member clubs to support laws which guarantee immediate arrest and speedy trial of offenders and tough, standardized penalties assessed by the courts.

**ROADSIDE REFLECTIVE MARKERS**

WHEREAS, GFWC Virginia has been active in accident prevention on our highways and streets; and

WHEREAS, The painted white lines on our highways and streets are highly ineffective at night when driving in inclement weather; and

WHEREAS, The Raised Reflective Markers have been tested extensively and found to be an outstanding driving guide at night and during rain and fog, and have proven to be a major factor in the reduction of accidents involving injuries and fatalities; therefore

RESOLVED, That GFWC Virginia calls upon its member clubs to urge the Commonwealth of Virginia to continue in an acceptable scientific manner its study, research and use of Raised Reflective Markers on State and Federal highways in the Commonwealth of Virginia.

## **TERRORISM**

WHEREAS, Terrorism continues to be a grave threat to all persons throughout the world, and

WHEREAS, The Office of Homeland Security was created in 2001 to lead, oversee, and coordinate a comprehensive national strategy to safeguard against terrorism, and

WHEREAS, National, state and local governments need to be better prepared for fighting and responding to terrorism; therefore

RESOLVED, That GFWC Virginia urges its member clubs to support anti-terrorism efforts including:  
Educating members to better understand the vast forms of terrorism in order to be better prepared  
Supporting legislation that develops and implements a domestic anti-terrorism strategy providing strong counter-terrorism programs, and further

RESOLVED, That GFWC Virginia urges members be vigilant and observant of their surroundings at all times; and further

RESOLVED, That GFWC Virginia urges the United States to work collaboratively with international organizations and governments to combat terrorism; and further

RESOLVED, That GFWC Virginia strongly reaffirms its conviction that any terrorist act against the United States or other countries be investigated, and necessary action taken to identify and apprehend those responsible and to have them prosecuted.

## HISTORIC LANDMARKS

WHEREAS, The gradual erosion and disappearance of the physical reminders of our cultural and historical heritage through disinterest, neglect or destruction is a nationwide occurrence; and

WHEREAS, The Commonwealth of Virginia is richly endowed with historic sites and homes whose identification, preservation and restoration, in order to prevent the loss of the visible forms of Virginia's heritage, should be a paramount importance to the citizens of the Commonwealth; and

WHEREAS, the Virginia Department of Historic Resources is the State Historic Preservation Office whose mission is to foster, encourage and support stewardship of Virginia's significant historic architectural and cultural resources; therefore

RESOLVED, That the GFWC Virginia urges appropriate government entities to implement an overall program which will ensure the necessary supply of water for future generations by:

Protecting watershed lands while encouraging proper and adequate management for all privately owned watershed lands by providing technical and cost-sharing assistance Encouraging further research into water filtration and desalination methods Enforcing the Clean Water Act and other relevant laws; and further

**ESTABLISHMENT OF STATE LICENSE FOR RESPITE CARE OF PHYSICALLY  
DISABLED & MENTALLY DISABLED**

WHEREAS, The Commonwealth of Virginia recognizes that there exists an acute need for respite care facilities for the physically disabled and mentally disabled individuals, especially for children and young adults, in most communities of Virginia; and

WHEREAS, The closing of mental health facilities will result in returning more patients to community care; and

WHEREAS, The Commonwealth of Virginia does not provide a respite care license expressly for physically disabled and mentally disabled individuals; and

WHEREAS, To provide respite care for the physically disabled and mentally disabled, license requirements and standards are identical to those who wish to provide day care or foster homes for normal children; and

WHEREAS, The care of the physically disabled and mentally disabled differs from the care required of normal children, qualifications need to be more demanding, appropriate standards and regulations need to be required; and

WHEREAS, The minimum standards for family day care homes and individual foster homes for normal children are not adequate to meet the needs of respite care for the physically disabled and mentally disabled; and

WHEREAS, The well-being of physically and mentally disabled and the interests of their families need to be protected, and the best possible care be provided; therefore

RESOLVED, That GFWC Virginia urges the Governor, the General Assembly and appropriate State Agencies to determine the certainty of adequate community care before closing any mental health facilities; and further

RESOLVED, That GFWC Virginia urges the Governor, the General Assembly and/or the appropriate State Agencies to provide adequate licensing expressly for those who will provide respite care for the physically and mentally disabled of all ages; and further

RESOLVED, That GFWC Virginia requests that the highest quality standards appropriate to the needs of the physically and mentally disabled be required for issuance of licenses for respite care.
