Timeline of Post-War UK Legislation relating to LGBTQ+

- 1957 The Wolfenden Report
- Recommended decriminalising homosexuality, arguing that private acts between consenting adults should not be illegal.
- 📜 1967 The Sexual Offences Act
- Partially decriminalised same-sex relationships between men over 21 years old, but only in private.
- 1980 Scotland Decriminalises Homosexuality
- Scotland follows England and Wales, legalising same-sex relationships.
- 📜 1981 Northern Ireland Decriminalises Homosexuality
- Northern Ireland adopts similar legal changes, finally extending rights across the UK.
- N 1988 Section 28 Introduced
- Banned the "promotion of homosexuality" in schools, reinforcing discrimination.

© 2000 – Armed Forces Ban Lifted

LGBTQ+ individuals are allowed to serve openly in the British military.

✓ 2003 – Section 28 Repealed

- The discriminatory law is removed, allowing LGBTQ+ issues to be discussed in schools.
- 5 2004 Civil Partnerships Act
- Grants same-sex couples legal recognition similar to marriage.

₩ 2010 – Equality Act

- Strengthens protections against discrimination based on sexual orientation and gender identity.
- 💒 2013 Same-Sex Marriage Legalised
- The Marriage (Same Sex Couples) Act allows same-sex couples to marry in England and Wales.
- **1** 2017 Turing's Law
- Posthumous pardons granted to men convicted under historical anti-LGBTQ+ laws.
- 1 2020 LGBTQ+ Inclusive Education
- Schools required to teach about LGBTQ+ relationships as part of the curriculum.



Lesson Title:

Legal and social changes in Britain that affected LGBTQ+



Activity: Legal & social changes affecting LGBTQ+



This is a straightforward task designed to help you acquire the knowledge that you will need later to help understand how social changes can influence the law, and the effects that this can have on different groups of people.

- You have been given a set of cards, each with a sentence relating to a particular change in the law affecting LGBTQ+ people.
- Arrange the sentences into the correct order (there is only one!) and then copy them into your book or on paper. To make the task a little more difficult, not all the sentences have a date!

Legal and Social Changes Affecting LGBTQ+ People

- 1. In the 1950s, being gay was illegal in the UK, and men could be arrested, imprisoned, or forced to undergo harmful medical treatments just because of their sexuality.
- 2. The Wolfenden Report argued that private relationships between consenting adults should not be criminal, laying the groundwork for change.
- 3. In 1967, the UK passed the Sexual Offences Act, making same-sex relationships legal, but only in private and only for men over 21 years old.
- 4. LGBTQ+ activists continued fighting for rights, protesting against discrimination and laws like Section 28, which banned schools from discussing homosexuality.
- 5. Music, fashion, and sport helped change attitudes—artists like David Bowie, footballers like Justin Fashanu, and movements like Pride marches made LGBTQ+ identities more visible.
- 6. The Rainbow Laces Campaign (2013) encouraged acceptance in football and other sports, challenging homophobia on and off the pitch.
- 7. In 2013, same-sex marriage was legalised in England and Wales, showing society's shift toward greater equality and inclusion.
- 8. Turing's Law pardoned thousands of men convicted under old anti-gay laws, recognising the injustice they suffered.
