MINUTES OF THE 2020 ANNUAL CONGREGATIONAL MEETING & SPECIAL MEETING AUG. 30

St. John Lutheran Church Minutes of Annual Congregational Meeting January 26, 2020

Council Members Present: Karl Yunghans, Fred Beuttler, Ada Henrich, Glen Stewart, Bob Oberg, Janice Mruz and Maria Shumsky.

Karl Yunghans called the meeting to order at 12:45pm. Rev. Ferreri opened the meeting with a prayer.

The Tellers, Rick Adamson and Sonya Adamson, reported that we had enough members present for a quorum.

Motion was made to adopt the Agenda for this meeting by Barbara Ross and seconded by John Wilcox. The motion passed.

Karl gave opening remarks. At that time, he mentioned that there is a signup sheet for anyone interested in helping form a committee for the Ham, Oyster, Chicken dinner. With a possibility of resuming it this fall.

REPORTS

All reports are included in the Annual Meeting packet handed out to all present.

Nominating Committee Report:

Diane Bechtold spoke for the Nominating Committee. She announced that one nominee, Debbie Pruitt, had to respectfully decline due to scheduling conflicts. She then asked for any other nominations. None were offered. The motion to close the nominations was made by Janet Yunghans and seconded by Carol Piechoski. The motion passed. Ballots were handed out for Janice Mruz, Susy Wilkins and Karl Yunghans for 3-year terms and Paul Best and Alexia French for 2-year terms. The results are that all the nominees were voted in by a majority. Then nominations were opened for the 2020 nominating committee. Nominees are Glen Stewart, Sonya Adamson and Bob Oberg. No other nominations were offered. The motion to close the nominations was made by Rick Adamson and seconded by Katrina Caine. The motion passed. Ballots were handed out. The results are that all the nominees were voted in by a majority.

Approval of Minutes

The minutes of the January 27,2019 Annual Meeting were reviewed. An addition was made to include that before the meeting closed, Pastor Mark Bruesehoff announced that he would be retiring as of June 1, 2019. The motion to accept the minutes of the Annual Congregation Meeting of 01/27/19 with the addition, was made by Rick Adamson and seconded by Janet Yunghans. The motion passed.

The minutes of the March 24, 2019 Congregational Meeting were reviewed with no corrections. A motion to accept the minutes were made by Rick Adamson and seconded by Judy Bailey. The motion passed.

Pastor's Report: Rev. Ferreri pointed out that we are a people rooted in faith. That we remain faithful in worship and service. As we live the passion to follow Christ, we need to look at ways to help our church grow. Including inviting someone to worship with us or to one of the many events of our church.

Minister of Music Report: Julia's report was conveyed by the anthem sung by the choir before the meeting. *We are all a Part of the Family of God.* Judy Bailey spoke of the value of Julia's leadership and her willingness to do so much to help the choir and the congregation.

Church Secretary Report: Report was reviewed. Judy Bailey stated how grateful she is to Melissa for all of her hard work.

Council President Report: Karl conveyed that he enjoys the challenge of being council president and is proud of the progress made this year. Janet Yunghans spoke of the time and effort that Karl puts in at our church and that we are lucky to have him.

Committee Reports:

Additional comments

Property reports that in addition, a drainage problem on the 10th street side was solved using a contractor. Noted that we still need to address the problem with the roof.

It was asked that we help with the difficulty in hearing the Lay readings during worship. This will be looked at and rectified.

Social Ministry added that we are looking for someone to head up the Thanksgiving Dinner for 2020. Deb Beuttler thanked Barb Piston and Carol Piechoski for their service chairing Social Ministry.

Brenda Greene spoke about Stewardship in the community. She knows personally how grateful the people were for the packages of toiletries that were given out in September. Also that we all need to continue to support the Ocean City Ecumenical Council.

A motion to accept all the committee reports was made by Judy Bailey and seconded by Sonya Adamson. The motion passed.

Treasurer's Report: Maria Shumsky spoke of the good news for 2019 with respect to the financial position of St. John Church. The church is in the black with \$17,846.60. There is now an Unrestricted Reserve of \$13,202.05. To help in case of emergencies. This is all thanks to the generosity of our congregation for sharing Gods blessings. Maria thanked Barbara Ross and Janice Mruz for their help with the accounting.

Questions were asked about the details of the disbursement of the $100^{\rm th}$ Anniversary funds.

After tithing to the Synod, 50% went to Mission and Ministry of St. John, and \sim \$900.00 went to Family of Promise.

Questions about the Interim Pastor salary were raised and if the budget considers options for after Rev. Ferreri's contracted year is up. Answer was that the amount ends at the end of May.

It was stated that Bishop Bartholomew will be at the council meeting in February to discuss options for St. John Church. There is also a Cluster meeting at Messiah Lutheran in Ocean View on Feb. 8th. Anyone interested in attending should let Rev. Ferreri know.

Motion to approve the Treasurer's report was made by Sonya Adamson and seconded by Becca Adamson. The motion passed.

New Business: Two representatives are needed for the 2020 Synod Assembly in Princeton, NJ on May 1st to 2nd. Anyone interested should let Pastor know.

2020 Proposed Spending Plan:

A question was raised about the "Additional Sundays". It was explained that that is for the months with extra Sundays above the contracted amount of 4 Sundays per month. A question about the money for the roof problem. The answer, looking into a Capital Campaign to replace the roof and the heating / air system.

A question about the possibility of building a pitched roof and possible solar panels was asked. Answer, the structure cannot support a pitched roof. Justin Adamson offered to look into solar options.

Question about the education budget. Answer is that we now have a 3 year curriculum so we will be able to recycle this and cut down on expenses.

Question about VBS. We have started getting info. Would like to look into the possibility of partnering with other Lutheran Churches.

Motion to accept the 2020 spending plan was made by Diane Bechtold and seconded by Becca Adamson. The motion passed.

Rick Adamson asked about time frame. Mike said they will begin right after Labor Day. Will take less than a week.

Karl- Existing units over 30 years old.

Diane Bechtold- wants to be sure we've gotten all needed permits. Mike K- said Duckett has taken care of all permits as part of our contract.

Fran Davish has agreed to be project manager. Will be on the property throughout.

Sonya A. asked- Does the price of new units include a warrenty? Mike- comes with one year service and maintenance for new unit. First year service contract is included (valued at \$2800 per year). Original warranty for mechanical is for one year. Mike got another question from Barb Piston, but Mike Kern will confirm warranty.

Meryn- asked about condition of roof. Just prior to project a roofer put a new coat around perimeter to stop leaks. He was going to finish but HVAC unit went. We will replace units and then the roofer will return to finish the job. No leaks since he sealed. Next step will be for roofer to finish his job of sealing the roof.

Sonya- Does roof repair still need to be paid? Everything has been paid for except for labor. Karl estimates that will be around \$1200. All materials have been paid for.

Janet Oberg- Will we need a new roof down the road in a few years? Karl- according to the roofer, his work this year and an additional coat next year (no more than \$5000) should last us another 10 years.

Vote: Karl called for vote to approve expenditure for HVAC units in amount of \$39,875.

All Aye No opposed

Motion carries. Vote Yes.

REPORT OF THE PRESIDENT OF CONGREGATION COUNCIL

In the beginning of 2020 I felt the church was continuing on a positive path of transition. Then COVID-19 hit! St. John Lutheran Church had to close our doors for seven months. During that time, Pastor Ferrerri had to resign due to health concerns, our secretary resigned, our church treasurer relocated out of state, and we were in the middle of conducting a capital campaign for major repairs to our HVAC system. Our situation was definitely not looking so good.

Now as I sit here writing this President's message on January 1, 2021, I can look back on all the accomplishments the church has made. First, we were successful in providing a quality virtual service. Second, we were able to hire Pastor Kevin Hilgendorf as our new interim pastor. Third, we were successful with a capital campaign that raised over \$40,000 through the generosity of our members and replaced the HVAC system. Fourth, members of the church council and the congregation kept up with the secretary's duties and other administrative work. Fifth, we were able to reopen the church for in-person worship in fall, 2020. How did we accomplish all of this? We were forced to change and we persevered by having faith in Christ.

I am hoping in 2021, we can return to some normalcy. I pray that we will be able to hire a parttime pastor and secretary. I am also hopeful, that with God's grace, we will be able to resume all of our ministries that we all sorely miss. I pray for continued growth of the church.

We gather, pray and act to live out our mission statement to continue in this place and in the world as the Body of Christ!

Again, we continued to feel an extended Evangelism/Stewardship Committee, meeting occurring on a regular basis, would best suit our congregation's needs at this time. Sharing commonality between evangelism and stewardship, the committees continued to meet together. As one of Church Council's committees, summaries of our meetings and recommendations are presented at Council meetings.

It has been at best an interesting yet challenging year. The first few months we can look back as being somewhat "normal." As we all know we came to live with a pandemic that turned most things upside down. Due to COVID-19, our committee has been meeting via ZOOM conferences at least once a month, and very often twice depending of the circumstances at the time. We have been fortunate and blessed to have the technical expertise of Glen Stewart to set up availability of the ZOOM meetings.

Our committee was able to keep in contact with most of the St. John family through phone calls and mailings, checking on their general wellbeing and offering a helping hand where and when needed. We were also able to let the congregation know the family of St. John is there for them and the mission of our church is ongoing.

A major problem surfaced with our heating and air-conditioning system necessitating a replacement of the three units located on the roof—the St. John Property Committee worked diligently to rectify the problem and determined the only viable solution was to replace the units. Council approved and we established a Capital Campaign, spearheaded by Rich Deaney, which raised, thanks to the generosity and commitment of our church family and friends, over \$43,000.00 which covered the cost of the replacement.

We were also involved with a food drive in response to an appeal received by our church to help folks associated with the Cape May County Special Services School District. Beth Hendrickson was instrumental by letting us know of the need and delivering food generously donated by the St. John family to the school in Cape May Court House.

Once again, thanks to the generosity of the St. John family, we prepared "Necessity Bags" for delivery to the folks living in Peck's Beach and Bayview. The ninety some bags consisting of useful toiletry items were delivered in early December. This will be the second time we have done this.

The committee also considered presenting and encouraging the congregation to enter an automated giving program such as Simply Giving.

FINANCE COMMITTEE REPORT

COMMITTEE CHAIRPERSON AND LIAISON TO CONGREGATION COUNCIL: Janice Mruz, Treasurer COMMITTEE MEMBERS: Janice Mruz, Treasurer, Susy Wilkins, Assistant Treasurer, Karl Yunghans, Mike Kern, Rick Adamson, Financial Secretary

COMMITTEE MISSION STATEMENT: We will annually develop a spending plan to be presented to the congregation and council. Along with the Treasurer and Council, we will monitor all congregational spending and maintain the expenditures in accordance with the spending plan. This year presented different challenges, with our Treasurer and Accountant stepping down simultaneously in September. Maria relocated to South Carolina due to a new business venture and Barbara moved backed to her hometown in Pennsylvania to be close to family. Susy and I volunteered to fill the positions with Council's approval. Barbara graciously volunteered to train us her last month in town before her move. Justin Odell continues to be our investment adviser with Wells Fargo. With the shutdown of the church in the middle of March and not reopening until the middle of October, this force us to furlough our church secretary and reduced our Music of Ministry salary to quarter time. We did apply for the PPP loan with the federal government to maintain our employees' full salaries, but were not approved. We continued our ministry virtually until in-person service was available. Once we were up and running, our Minister of Music's full salary was reinstated. Unfortunately, during this time our church secretary found another position. When things are back to "normal" we intend to fill the position of part-time secretary. Our interim Pastor Ferreri resigned October 2020 and our new interim Pastor Hilgendorf started November 2020. The call application for a new part-time permanent pastor was completed and sent to the ELCA and NJ Synod during the summer of 2020.

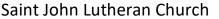
