#### REPORT OF THE PRESIDENT OF THE CONGREGATIONAL COUNCIL

Every year I hear a message from one of Pastor Kevin's sermons that makes me pause and reflect. The quote I have selected from 2022 is "humility is the cornerstone of faith." As council president, I try to value all member's ideas and interests above my own. Everyone has a place in the church and it involves participation in time, talent and treasures in any amount that can be given. I want to personally thank every member of the congregation for their participation in our ministries and the daily commitment that is involved to keep the church moving forward.

I also want to welcome all of our new members that joined the church last year. All are welcome! It is especially exciting to see young families with children attending worship service and Sunday School. Membership and participation are essential to continue on with all of our ministries. I am hopeful that more in our community will join St. John in 2023.

In 2022 I had the sense that St. John was returning back to normal after dealing with the Covid 19 pandemic for the previous two years. Our events included a first ever craft show, a rummage sale, Christmas Bazaar, blood drive, packing event for Hope Pregnancy, and a Harvest Hope project with Grace Lutheran Church. St. John hosted Vacation Bible School, a youth group from Pennsylvania and opened our doors on a weekly basis to Easter Seals, Al Anon, and El Tabernaculo. We are now in the process of sponsoring Bellor Venus Chea, a niece of one of our members, who was displaced as a refugee from the Ukrainian war conflict. She is currently living in Germany and we hope to assist in bringing her to the United Sates as soon as the diplomatic process allows.

All of the above events and activities requires participation, which rewards one with fellowship and a sense of community. I, personally, had the opportunity to deliver the packing items to Hope Pregnancy. The show of appreciation and thanks was such a rewarding experience.

God has blessed us with Pastor Kevin, who has done a tremendous job with worship services, leadership, and providing comfort to the elderly. I remain hopeful that St. John will find a part-time or full-time permanent pastor in the near future. In 2023, St. John plans to hire a part-time secretary to help ease the burden of everyday bookkeeping, paperwork, and communication. Church council agrees that this is another important step that we need to take after losing our secretary during the pandemic.

As president of the church council, I am always thinking of how we can improve and grow as a church. I constantly rely on our members. Many have particular areas of expertise, which enable the church council and myself to make the right decisions. We have taken a few steps back at times, but it always followed by steps progressing forward. Experiencing humility when things do not always seem to go right strengthens my faith and resolve.

On May 7, 2022 Pastor Kevin and I attended the NJ Synod Assembly Annual Meeting via Zoom. One of the main highlights of the meeting was the Bishop's Challenge. The Bishop's Challenge was directed at all of NJ ELCA to raise \$50,000 to help fund African American seminary students. St. John participated by donating the requested amount of \$375 along with a quilt square, which was included in a "tapestry of love" quilt. St. John's quilt square is a beach scene with three crosses in the foreground and is located at the top right-hand corner of the finished quilt. #### **EVANGELISM & STEWARDSHIP**

We gather, pray and act to live out our mission statement to continue in this place and in the world as the Body of Christ!

We continued to feel an extended Evangelism/Stewardship Committee, meeting occurring on a regular basis, would best suit our congregation's needs. Sharing commonality between evangelism and stewardship, the committees continued to meet together. As one of Church Council's committees, summaries of our meetings and recommendations are presented at Council meetings. Our committee met via ZOOM conferences at least once a month.

For "God's Work, Our Hands" Sunday this year, members of St. John donated, then packed and delivered items requested by Hope Pregnancy (a local charity that helps pregnant mothers in need). Items delivered included detergent, deodorant, soap, shampoo and toothpaste. As part of the "Feed the Northeast" program, our congregation partnered with Grace Lutheran Church in Somers Point to collect over 500 food items to feed the hungry in our shared community. Since we surpassed our goal, Thrivent donated \$500 to the Grace Place Food Pantry to continue that vital ministry.

The concept of Estate Planning and how it can have a positive effect on the mission of St. John in the now and in the future was examined. An Endowment Fund, known as The Cedar Fund, was established following approval of Council and seed money of \$10,000.00 was approved by Council to begin the Fund. A special pew envelope was approved for people who wish to contribute to the Cedar Fund. In conjunction with the Cedar Fund, we instituted a series of seminars about legacy concerns entitled, "The Last Hurrah." About once a month, we had guest speakers deliver information about financial, medical and funeral planning. We will hold sessions on spiritual and legal legacy issues in 2023. Due to the popularity of these seminars, we may also hold a few repeats of previous speakers to make sure everyone in the congregation has a chance to take part. There will be further information about how people may donate through Estate Planning and how contributions may be made through retirement required distributions while saving on taxes from that distribution.

All of us, the family of St. John, gathering, praying, and acting to live out our mission statement are being the Church. Though this past year has been difficult, when we pray, let us be thankful for what God has given us---His Grace!
