**AGREED DECREE FOR DISTRIBUTION OF PERSONAL PROPERTY TO WARD
 PURSUANT TO §1151.051(c)(3) OF THE TEXAS ESTATES CODE**

On this day came on to be considered the foregoing Application for Authority to Make Distribution of Personal Property Pursuant to §1151.051(c)(3) of the Texas Estates Code filed by Applicant, ASHLEY N. REINER, Permanent Guardian of the Estate of ELVIE LOU CRUZ KINGSTON, An Incapacitated Person.

The Court finds as follows:

1. that all interested parties have been provided notice of the Application for Partial Distribution and have made an appearance in this proceeding through their attorney of record or filing a waiver;
2. that the personal property to be distributed is described generally as unsold jewelry which was already marketed to the public, jewelers and wholesalers, and failed to garner any interest at six (6) public estate sales, and will otherwise be sold for gold value only and melted;
3. that Nubia Devine, Guardian of the Person of Elvie Lou Cruz Kingston, An Incapacitated Person is entitled to such personal property on behalf of Elvie Lou Cruz Kingston in accordance with §1151.051(c)(3) of the Texas Estates Code, which consists of the 14K yellow gold diamond ring without the extracted diamond and replaced with cubic zirconia, as well as all unsold jewelry of minimal value in Guardian's possession belonging to the Guardianship Estate, to NUBIA DEVINE, Guardian of the Person of ELVIE LOU CRUZ KINGSTON, further described as follows:

4. that there are no known creditors of the Guardianship Estate, and the debts and expenses of the Guardianship Estate consist of only standard administration expenses including attorneys' fees, CPA fees;
5. that after the partial distribution is made, there will be sufficient assets to satisfy any remaining debts of the Guardianship Estate; and

6. that authority should be granted to the Applicant to make the distribution to Nubia Devine, Guardian of the Person of Elvie Lou Cruz Kingston, An Incapacitated Person, as it is in the best interest of the Guardianship Estate to make such distribution for the use and possession of the Ward.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Ashley N. Reiner, Permanent Guardian of the Estate of ELVIE LOU CRUZ KINGSTON, An Incapacitated Person, is authorized to make a distribution of all unsold jewelry, as well as the 14K yellow gold diamond ring without the extracted diamond and replaced with cubic zirconia, belonging to the Guardianship Estate, to Nubia Devine, Guardian of the Person of Elvie Lou Cruz Kingston, An Incapacitated Person, for the use and possession of the Ward, pursuant to §1151.051(c)(3) of the Texas Estates Code, as further described in the Application.
