1. Application Timetable - expires after one (1) calendar year

Applications for ARC approval must be submitted to the Homeowners' Association Manager's Office located in the Pavilion not later than **2 days** prior to the ARC meeting. **Incomplete applications will not be considered.** ARC meetings are held on the **3rd Tuesday** at the Pavilion Office at **7:30 p.m.** (Meeting dates subject to change, please contact the office to confirm date). 2. Fees

A **\$100.00 refundable deposit** will be required for the review of an application for Driveway Painting. This fee **will be deposited into an escrow account** and will be **fully refundable** upon satisfactory completion and final inspection. Any changes to the application must be approved by the ARC. **Any construction and/or work changes made without prior ARC approval will result in the forfeiture of deposit.**

NOTE: The Board of Directors has recognized the need to address some of the aging and stained driveways located within Windover Farms. After careful review and considering proposals given by the Architectural Review Committee (ARC), the Board of Directors decided to allow homeowners to paint/stain their driveways on May 6, 2015.

These are the only colors the ARC will consider when reviewing any submission requests to paint and/or stain their driveways. Please note that this is a list of approved colors and DOES NOT authorize the painting of any driveway without pre-approval. It is the responsibility of the homeowner to submit a complete application along with a 2-inch color sample and \$750 refundable deposit and wait for approval from the ARC prior to proceeding with any proposed driveway painting or color coating.

Type: Concrete---Stain, Paint, Epoxy

All driveways and or walkways must be uniform in color and texture. **No patterns will be accepted.** Driveway must be stained/coated to include the total width and length in its entirety.

*Homeowner is responsible for correct application and maintenance once applied.
