We are working to make it a singular focus for the people on Virginia to stay present with the documents, events and information produced by our Lawful Governance Structure and it is updated regularly. Notice: If you choose to use Status Select for document preparation, please have them prepared using a State of State notary box rather than a Recording Secretary notary box! You will utilize a De-Facto notary and one of our Recording Secretaries will record (not notarize) them on the Land Recording Office (LRO).

The Assembly acknowledges that each of you finds yourself on our doorstep from an individual and unique path and with variable levels of available time for research and study. Currently, many are finding it expedient to use the International Land Recording Service to record their 1779 Declarations and other documents for a quick return to the Land and soil. This also provides the option and benefit of setting up an account with the Global Family service that will connect you to the new Bilateral Banking and Prosperity system. For more information you may use the search feature at the website and archives of Anna Von Reitz (AVR) where she discusses the Global Family Group, as it applies to The Global Family International Trade Bank and The Global Family Bank of Commerce, a bi-lateral, blue-dot system that she terms a "Prosperity System", not a bank in the sense that we are





familiar with. This is the beginning of the return and recoupment of long stolen American assets.

For those that desire to complete the initial paperwork process (1779 Documents and others) with one of our Recording Secretaries on Virginia to be recorded on the Public Record on The Land Recording Office (LRO), please jump to the attached document titled "Land Recorder's Page" to bring that process into focus with the guiding words of Shirley Bryant, a Virginia Assembly Recording Secretary. Please do your utmost to have your documents in proper recording form before submitting them to our Recording Secretaries.

If you would like to have someone in the States Assemblies prepare your paperwork for you for a fee, contact the people at http://mystatusselect.com/. Status Select is not directly associated with The Virginia Assembly but your completed paperwork will be forwarded to Virginia and then you will follow up with one of our Recording Secretaries to complete the process of recording on the LRO. If this is your chosen path you may want to consider also utilizing the recording system of The Global Family Group mentioned above, however, it is not necessary to use more than one Land Recording system for your paperwork. Please be patient with anyone assisting you as we are all volunteers and juggle many hats and full lives.

As always, Self-Governance requires that you research before you act and discern your own path. The way home to the Land and soil is not the same for each man or woman as we are each unique and arrive under different circumstance. We can no longer concede our choices to an external voice or pressure and must seek our Guidance from within. The Virginia Assembly is here to share knowledge and support; no one can "do it for" you. We





are grateful to have your interest in reinvigorating the Land and soil with the love, energy, and the vitality of "the people" and we wish you Godspeed on this incredible journey.

For those of you who may have additional interest in the workings and mission of The Virginia Assembly, please be with me for a few more paragraphs. Our goal is to facilitate your return to the land and soil and encourage you to regain (or continue) mastery of the trajectory of your Life, employ Self-Governance and ultimately find greater ease and joy in living.
