To all to whom these presents shall come, be it known;

we are the men and women, sons and daughters of The Creator and we are The Virginia Assembly, a people/People naturally born on the land and soil of the organic, unincorporated nation states/States of the Union; we stand in Original Jurisdiction as Vital Souls and we are the Living General Public; we are at Peace and stand in Honor and live by the maxim of Do No Harm;

we extend cordial, amicable, peaceable, and honorable greetings to you this 18th day of May, Two-Thousand and Twenty-Three, Anno Domini;

we the people/People of The Virginia Assembly are in full acknowledgement and awareness of the many immoral, illegal and unlawful crimes being perpetrated against the people/People on Virginia; The Federation of States, of which The Virginia Assembly is a part, has recorded and made public numerous International Notices documenting these crimes to the Lord Mayor of London, British Lords of Admiralty, the Holy See, the Vatican and the Vatican Chancery Court, the International Criminal Courts in the Hague and elsewhere;

any man or woman, who sometimes acts and/or operates as a corporate Officer, Agent and/or Trustee, who is in receipt of this Notice and Declaration, is hereby informed that crimes are being committed against the people/People on Virginia; this Notice and Declaration is to inform and require you to cease and desist from these crimes and begin operating in the lawful capacity

that is intended by your Office, Office Title and/or Trusteeship to include all Assigns and Successors and all other corporate State-of-State Agents, Officers, Employees and/or Trustees; this Notice and Declaration also requires each man and woman addressed herein to provide copies of their signed Oath of Office, risk bond or risk insurance information and Foreign Agent Registration Act (FARA) declarations as is required by your Office, to be submitted with the written remedy for the issues stated herein;

we the people/People of The Virginia Assembly, declare that an egregious trespass, among the many, is the crime of personage being committed against the Living people/People on Virginia, and of other nation states, through the Birth Certificate Bond which is an instrument of enslavement;

we the people/People of The Virginia Assembly, declare in full force of Divine and Natural Law, that we are and have been alive since the individual days of our nativity and we require acknowledgement of this fact by you, our Employees, Agents, Corporate Officers, and Trustees;

we the people/People of The Virginia Assembly, hereby claim our Nationality by demonym of the individual state on which we were born or the state which we individually adopted, and which are defined by physical land and geographical boundaries; we invoke our guarantees under all three (3) Federal Constitutions as they existed in 1860, and declare in full force that we are owed all protections, guarantees, rights, remedies, exemptions, and exceptions and while we, the Living men and women, sons and daughters, do not stand under corporate federal code or statute, we do include them herein for your education, edification and to further clarify our standing; these remedies and protections include but are not limited to the following:

1. Reversionary Trust Interest, 12 USC 95(a);
2. Regulation Z (adopted by the Board of Governors of the Federal Reserve);
3. Lawful Money (12 USC 411);
4. The Enabling Clause, before every act of Congress ("This Act shall not change.... any right thus previously established.");
5. The Brother's Keeper Clause, 18 USC 241 and 242;
6. West Virginia v. EPA (2022) and antecedent case Norton v. Shelby County, 118 U.S. 425 (1886). Municipal and Territorial Agencies are not enabled to enforce their Administrative Codes as if they were law related to Virginians, the people/People and our property in these States of the Union;
7. Lieber Code* (Geneva Convention) – personage (securitization of flesh) is a capital crime;
8. Hague Convention* – personage (securitization of flesh) is a capital crime;

*to confer or force citizenship obligations (personage) onto Living people/People by acts of Legislation is a capital crime, punishable by death;

the words, herein, provide you with Lawful Due Notice and Testimony, under solemn Attestation and Witness of The Public Law of The United States of America (unincorporated), and establish the same upon the Public Record that the following are absolutely true and correct to the best of our knowledge and belief, and will be attested to in a Lawful Court of Record;

1. that we the people/People of The Virginia Assembly are Peaceful, Non-Belligerent, Non-Combatant, Third-Party American State Nationals and American State Citizens; we are Duty and Tax Prepaid priority Creditors, Inheritors of, and Living and Present Heirs to, the Trust Indenture established by The Unanimous Declaration of Independence (1776), the Organic Laws of our State and Country, and the applicable Unrevised United States Statutes at Large as they pertain to the general populace; we are owed the Military Law of Peace; we are of the General Public known as the people/People, and Actual Beings-in-Possession and Naked Owners who are owed amity, protection of our lives and property, good-faith service, immunity, and aid from all Principals, Employees, Officers, Agents, and subcontractors of the British Territorial United States of America, Inc., and the Roman Municipal United States, Inc., military and civil;
2. that we have never knowingly been nor acted as British Territorial U.S. Citizens or Roman Municipal citizens of the United States or any other variety of Federal United States person(s), officer(s), employee(s) or elected official(s) engaged in any federally-connected Commerce or Business, nor have any of our lawful Trade Names/NAMES and/or Vessels/VESSELS ever engaged in or been connected to such activity, and have not been so at any point since our individual days of nativity;
3. that any and all records, data and/or Master File(s) purporting to show that we the people/People on Virginia, or any of our Lawfully Re-Conveyed Names/NAMES and/or Vessels/VESSELS are engaged in or connected to such federally-connected/privileged activity, or that we are functioning as Federal Person(s), Officer(s), Employee(s), Trustee(s) or Elected Official(s), are incorrect and falsified;
4. that any British Territorial or Roman Municipal Principal, Agent, Agency, Employee, Officer/Office or Subcontractor engaging in Unlawful Exercise of Right of Dstraint and Levy and acts of Personage, Peonage, Slavery, and Treason against the people/People on Virginia, our freedoms, property and/or assets, must bring forth firsthand proof of such federally-connected activity or Federal status of the people/People on Virginia, in the form of an affidavit under full personal and commercial liability, attested to under the pains and penalties of perjury and potential criminal and civil claims and/or liens, and under The Public Law of The United States of America (unincorporated);
5. that we stringently denounce, strongly object, and do not consent to any implications that we or our Names/NAMES and/or Vessels/VESSELS, are connected to or engaged in any such Federally-connected activity; we denounce any and all attempts to deem or mistake any of the people/People on Virginia to be Officers, Employees, Agents, Trustees or citizens/Citizens of a foreign corporate polity (the United States, Inc. or the UNITED STATES, INC. or the United States of America, Inc.);
6. that we have declared and claimed, on and for the Public Record, our true and correct birthright Living status, in Original Jurisdiction, which can be found at The Virginia Assembly Land Recording Office under the following Instrument Numbers for Kevin Barry Miller (2021-6VvAj7-LSVA000220212801) and Cheryl Ann Perko (2021-O3bKB2sZ-Va-211015-059-00000101) and Randell Alan Rimbey (2022-2bd017wj-Va-220617-011-00000102) and can be viewed at <https://verify.americanstatenationals.us>; additional Living

7. that we acknowledge the Soul, Breath, Heartbeat and Gift of Life of The Creator that is inherent in all people/People and pursuant to the 1666 Cestui Que Vie Act, no further presumptions may be made that we the people/People on Virginia are lost, lost at sea, lost beyond the sea, or otherwise dead or missing;
8. that any attempt to probate, seize or unlawfully take our property, lawful Estate(s), individual inheritance of The Creator, or arrest/alter our course due to presumptions that we are merely co-trustees of the Public Charitable Trust or debtors in-possession, shall be evidence of, but not limited to, the following crimes: Personage, Fraud, Inland Piracy, Kidnapping, Conspiracy Against Rights, Theft Under Color of Law and Taking Without Due Process;
9. that any action that improperly addresses a Virginia State National/Citizen as corporate Persons/PERSONS by any Principals, Agents/Agencies, Officers, Employees, Trustees, directly or indirectly, functioning individually or under the oversight of the U.S. Trustees or the Bankruptcy/Probate Courts known as U.S. District Courts, U.S. DISTRICT COURTS or their subsidiary Courts/COURTS shall be evidence of Personage, Fraud, Inland Piracy, extra-judicial malpractice, operating as Executors de son Tort, and malfeasance;
10. that any man or woman functioning as our Employee(s), Agent(s) and/or Trustee(s) who attempts to Act illegally or unlawfully in our Names/NAMES and/or Vessels/VESSELS is guilty by their actions of functioning as “Executors de son Tort”; and is liable in an individual, criminal and civil capacity, with no explicit or implied immunity, and is subject to the affixed The Virginia Assembly Notice of Intent - Fee Schedule on the Public Record at <https://members.americanstatenationals.us/member/?pid=76I1JL&tab=documents> under the link called “FEE SCHEDULE”;
11. that we claim our Mutual Offset Credit Exchange Exemption(s) pursuant to HJR 192 and Public Law 73-10, and codified at 48 Stat. 112, for any debt(s) or purported/alleged debt(s) against the LEGAL PERSON(S) (for example: JOHN MICHAEL DOE, JOHN M. DOE, JOHN DOE, and any other combinations and/or permutations) that may be attached to the Living men and women, sons and daughters who are the people/People on Virginia;

in order to ensure that our freedom, life and property are protected, any matter that violates The Public Law of The United States of America (unincorporated), must be remedied within thirty (30) calendar days of this Notice and Declaration unless otherwise noted below; we require written acknowledgement thereof, a written plan for the implementation of remedy for each item listed and ongoing updates by the end of each month as to progress toward completion of remedy;

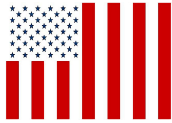

- A. that the Commonwealth of Virginia/COMMONWEALTH OF VIRGINIA Secretary of the Commonwealth, Kay Cole James and COMMONWEALTH OF VIRGINIA, SECRETARY OF THE COMMONWEALTH, KAY COLE JAMES, fulfill her duty to protect all American people/People on Virginia's land and soil, against corporate Federal Government overreach as she is the corporate Officer and Trustee responsible to the people/People on Virginia under the Naval Agency and Distribution Act of 1864 and we require her written acknowledgement and compliance within fourteen (14) days; corporate Commonwealth of Virginia/COMMONWEALTH OF VIRGINIA Dun & Bradstreet (DUNS) numbers are as follows:

- B. that all BAR Attorneys in the Commonwealth of Virginia/COMMONWEALTH OF VIRGINIA, and those in the U.S. Trustee Program, provide evidence of compliance with registration under the Foreign Agents Registration Act (FARA) as amended in 1938; if not registered, then we require your/their immediate registration within fourteen (14) days of the date of this Notice and Declaration, otherwise you/they remain as undeclared Foreign Agent(s) and are subject to the appropriate pains, penalties, sanctions, seizure of individual property assets and deportation under The Public Law of The United States of America (unincorporated); public and international Notice for FARA registration has been well established on the Public Record on the land and soil jurisdiction of our organic Federation of States;
- C. correction, regarding the matters attested to herein, of all records/databases (public, private, commercial, domestic, interstate, or otherwise) that are associated, affiliated, administered or maintained under your Office or the Office of your Principal(s), Agent(s), Employee(s) or Trustee(s), pertaining to the people/People on Virginia and all of our Names/NAMES and/or Vessels/VESSLES and/or Estate(s) and credit; in order to ensure swift correction of all records, we have enclosed a copy of the UCC Financing Statement for Virginia (Alaska Recording Office # 2016-016601-7) and Exhibit A which includes internet links to important Lawful Notices from our Federation Head of State and from our Federation Fiduciary, which are recorded on the Public Record;
- D. the full release and return of seized property, including but not limited to credit, homes, gold, silver, cars, trucks, boats, aircraft, motorcycles, tractors, trailers, firearms, and/or other assets, and businesses taken possession of and held under ersatz occupation in the Public Charitable Trust;
- E. release from coerced and unlawful taxation, adhesion, and litigation; and the unlawful practice of registration, including but not limited to, marriage, birth, death, insurance, social

security, bank accounts, vehicles, businesses, and other accounts; we are aware that all governments have been fully funded since 1941 by various benefactors and as such, the above money making schemes are illegal, unlawful and against the people/People;

- F. the honoring of our right to travel freely and release from coerced and unlawful conversion of our private automobiles, trucks and conveyances that are relabeled as motor vehicles; that we are provided with permanent private Regulation Z plates for our automobiles and conveyances and other assets that identify our property and our standing as American State Nationals and American State Citizens, in Original Jurisdiction; if there is a failure to do so, we the people/People of The Virginia Assembly will establish our own Z Plates and will then require your Agency(s)/Agents(s), Officer(s) and Trustee(s) to recognize it in Law; we also require release from the unlawful registration for the Commonwealth of Virginia/ COMMONWEALTH OF VIRGINIA Department of Motor Vehicles (DMV) Driver's License; additionally, we require that the General Public, who are not voluntary transactors in commerce, be excluded from taxation, fees, and penalties, to include free access through all toll roads and the perpetual ability to travel without harassment or encroachment on our freedom of movement;
- G. that you notify, educate, inform and otherwise hold accountable, all Roman Municipal, British Territorial and Federal Agents/Agencies and Offices/Officers and corporate Employees to include but not limited to policy/law enforcement (Sheriff and Deputies, Troopers, Police, and private Pinkerton security and mercenaries) in all venues and levels of corporate enforcement, County Tax Assessors and Collectors, County and District Clerks, County and District Attorneys, Judges, Magistrates, Virginia Department of Motor Vehicles, Principals and any other Agent(s) and Assign(s) and require that they come under The Public Law of The United States of America (unincorporated) and honor the nationality of the Living men and women, sons and daughters who have declared, recorded and published their birthright status on the Public Record, who hold allegiance to an American nation state and who are owed the Law of Peace (Department of the Army Pamphlet 27-161-1); the Federation of States has provided MANDATORY NOTICE of the Foreign Sovereign Immunities Act, Sections 1602 through 1611, and our Names/NAMES and/or Vessels/VESSELS are owed all material rights, duties, exemptions, insurances, treaties, bonds, agreements and guarantees including indemnity, full faith and credit, and protection from all British Territorial and Roman Municipal Officers, Agents and Employees who otherwise have no permission to approach or address us in their official capacity;
- H. release of the Living men and women, sons and daughters, who have been unlawfully kidnapped and held in possession by the British Territorial and Roman Municipal U.S. DISTRICT COURTS and/or their subsidiary Courts/COURTS, United States District and State and County Courts, DOD/DARPA/FBI/CIA, et alia, any other prison or jail system, child protective services or other foreign corporate entities/organizations that otherwise cause harm and trespass upon the people/People on Virginia; we are aware of the gross corruption within the various Agencies, Corporations and Organizations that are meant to provide good faith service to the people/People; in addition, charges against any man or woman, son or daughter being held under duress and without Due Process, or under contrived and fabricated charges, by any of the Agents/Agencies and/or Officers/Of fices named herein including their Assigns and Successors, and their subsidiary and franchise offices, are to be addressed and

remedied immediately; this notice requires all Agents/Agencies, Principles, Officers, Clerks, Bailiffs, Sheriffs, Deputies, and Employees and all British Territorial and Roman Municipal Officers, Trustees, and Appointees including their District/DISTRICT, State/STATE, and County/COUNTY Courts/COURTS, their Officers/OFFICERS and Employees/EMPLOYEES; or any other Agents/Agencies to come under The Public Law of The United States of America (unincorporated), solemn International Treaties, solemn Commercial Contracts, International Law, The Constitution for the united States of America (1787), The Constitution of the United States of America (1789), The Constitution of the United States (1790), and the International Will of the Living men and women, in accord with the The Unanimous Declaration of Independence (1776) and do so within fourteen (14) days; we require a response to include specific action(s) taken or to be taken and a timeline for release of people/People that are held unlawfully;

- I. release of the Living men and women, sons and daughters, from any unlawful litigation, lawsuit, or administrative proceeding in Admiralty/Maritime (sea) jurisdiction; and uphold the three (3) Federal Constitutions under the Supremacy Clause, Bill of Rights, and Amendment XI, as we are not subject to any foreign or corporate law/by-law; we require that you close, cancel, revoke, expunge or otherwise remove any claim, charge, complaint, indictment, true bill, bill of attainder, impound order, seizure, foreclosure, repossession, destruction of assets, lien, levy, bond, attachment or any other order or instrumentality that brings harm or trespass to American men and women, sons and daughters, or their lawful persons, houses, papers, effects, property and assets;
- J. the acknowledgment that our individual Estate Trusts hold physical assets and credit that belong to the Living people on Virginia who are owed and require the return of their Estates, assets, patents and property without further impersonation or misrepresentation as corporations or intestate infant decedent estates; we denounce any public administration under any and all other false legal conventions and presumptions as we are not, nor have we ever been, lost, lost at sea, dead or otherwise missing; Virginia, an organic State of the Union, along with the forty-nine other organic States of the Union, and our unincorporated Federation of States are in Session, and in operation as The Lawful Government; we bring claim forward for settlement in behalf of our state and statesmen and require the release of all Public State and individual Estate Trust assets that have been subject to ersatz occupation under conditions of deceit and non-disclosure; the offending corporations, including but not limited to the State of Virginia, STATE OF VIRGINIA, Commonwealth of Virginia, COMMONWEALTH OF VIRGINIA, County of, COUNTY OF, City of, CITY OF, et alia, must immediately comply with our claim for the release of the Public State and individual Estate Trusts and assets that have been unlawfully seized and that they be returned to the rightful inheritors and the dejure Government on Virginia;
