Discussion had on the upcoming Mock Trial Process. Mock trial to be held on Thursday, July 10, 2025 at 1900 and on Saturday, July 12, 2025, starting at 1000 and continuing until presentment. Education provided on protocol for the audience of the mock trial as the trial will be via Zoom platform, noting the audience does not engage with the process. Audience is asked to take notes/write down questions/suggestions to bring to the post review. A request made for additional jurors with Elliott volunteering. Steve Just to make Scott Sevart, Court Clerk, aware of Elliott for the jury pool. Everyone involved in the mock trial strongly encouraged to review the court process document. Education and awareness offered to remind all present of the work to be done individually on retraining our thought process from the "defacto" to the "dejure". Common Law focuses on facts - not emotions. Focus is on truth.

Lorrayne gave a detailed review of the recent Ohio common law civil case. The case initiated due to WISCONSIN court issuing a summons against one of the party's. The accused was found not guilty by the Ohio jury. The presentment was sent to the WISCONSIN Court arriving on day the accused was to appear in WISCONSIN court. The presentment noted a superior court had found the accused not guilty. A true bill is now being worked on to present to the WISCONSIN court.

Lorrayne sharing Lisa with Ohio is willing to do training with Virginia on the true bill process.

Discussion initiated on punishment decisions for the court process. The goal of discussion is to be able to put in writing the sentencing process. Discussion on Identification on the use of death sentence as an option. Point made during discussion the jury needs to be aware of all options when considering a presentment, ultimately the jury makes the final presentment decision.
