Old Business:

1. Sheriff Notice updates.
 1. KBM advised the group that he has sent all but (2) sheriff packages out to clusters 6 & 7 – tracking information has been emailed to Steve
 2. Cheryl Perko advised the group that she has sent Cluster 9.

3. All notices have now been sent. We have had a few returned due to postage/address issues. It is estimated that 85% of ALL sheriffs have now received these notices.
2. any other old business?
 1. Randy Rimbey requested that we update the agenda to include voting on the minutes to these general assembly meetings. KBM will add this to our next agenda. All ASN's are reminded to go to the website prior to each meeting to review all minutes.
 2. Lorraine Ham advised the group that the Election Notice has been published in the Richmond Times Dispatch and also requested that someone find and save a printed copy of the newspaper so we can have a formal record of our notice

New Business:

1. Hector's new baby: Lorraine advised the group of Hector's baby announcement. Hector is in the process of learning how to navigate the "Recording" process and will update the group accordingly upon the baby's release from the hospital.
 1. Karen Lehman expressed concerns regarding the term Natal record vs. Birth Record. After some discussion, KBM advised the group that this is an individual choice and not one that is dictated by the Assembly. Therefore, in the event someone has a baby, they are free to record a birth announcement or a natal announcement. Additionally, all were reminded that anything associated with "birth" is technically under the SEA jurisdiction.
2. LRO Problems: Shirley
 1. Shirley advised the group that the LRO is having issues with NEW recordings when updating the "Nationality" field. For any newcomers, this will delay their recordings. This is ONLY affecting NEW ASN's. Existing ASN's can record documents as needed without issue. The issue has been sent to the Federation for troubleshooting.
3. Thoughts on Committees – Lorraine
 1. A reminder to the group was provided in regards to the need for participation. We have a ton of committees (see the Assembly website for a complete list) that we need to fill. Anyone who has been an ASN for 6 months can chair a

committee. Please review the list and if you have a passion about any of these, please make it known and begin brainstorming for the future.

2. KBM gave a quick update – there is NO Global Family Bank training for coordinators. Apparently there was a “rumor” going around suggesting that coordinators were being trained on GFG. This is not currently happening.
4. Cheryl stepping down from Outreach Committee: Lorrayne and Cheryl
 1. Lorrayne advised the group that she is going to start making some brochures and handing them out at her local farmers market. She suggested that everyone consider ways in which they can update the public about the Assembly. She also advised the group that she will add Scott Severt’s presentation to the website. Scott advised the group that he has had little to no success in presenting this to folks. They just aren’t able to grasp what all has happened.
 2. Kimberly & Melanie have stepped up to assist in outreach. Thank you!
5. Personal US Trustee Notice, my examples
 1. KBM emailed his trustee notice for the group to use as a template if they haven’t already recorded their notice and “schedule of charges”. It is highly recommended that ALL ASN’s do this.
 2. Lorrayne recommended that everyone tune into the most recent Ohio podcast on Youtube with Anna (Some Assembly Req’d)
6. Schedule next En Esse? When? Where?
 1. KBM suggests having our next en esse meeting in October. Crozet was suggested since it is central to the group. Aaron asked if there were alternate locations. The group advised for him to research possible locations closer to Richmond with the understanding of drive time for all participants.
 2. Patty Rimbey suggested that the Outreach committee work on the date/time and location for ALL events.
7. Committee Reports to include Treasury Report.
 1. Treasury report – Our current balance is \$2127.58. We have (3) outstanding checks which will leave us with ~\$1850 once they have been cashed.

2. Court docs committee will resume meetings starting Wednesday, 4/30 at 7PM. We need to discuss Capital punishment and we have received more information in regards to the bondsman.
3. Jural Assembly is focusing on the Mock criminal trial. All ASN's NOT working on the case itself will be needed to fill the jury pool when the time comes to do the presentments.
4. Dominick has completed the claimant incident report and will be reviewing this in Thursday's meeting
5. Steve Warden is our Public Health Chair. He is working on birth/natal announcements/procedures. This will tie in with Hector's recent baby announcement.
6. Cheryl advised the group that the next outreach meeting will be on 5/8 and thanked Melanie and Kim for their assistance.
7. Lastly – Lorrayne reminded the group to please review the website as it is being updated and refreshed almost daily. Eventually the goal is for all focus group meetings and general assembly meetings to be recorded and posted to the website. We will need to verify we have storage space on the website, and decide how long meetings remain available.
8. Lorrayne Ham made a move to adjourn the meeting for the night. Randy Rimbey 2ndd the move. Our next meeting will be **Tuesday, May 13th of 2025 at 7 PM EST.**
