- e. Cheryl put a call out for Outreach this Thursday (2/6) at 5PM. We need to have materials prepared for our in esse meeting on 4/6 in Crozet. She also is still looking for someone to take over new member orientation. We need someone to take over this roll.
- f. It was also discussed that we need someone to manage our emails. Specifically our ASN's email addresses so everyone who has declared their status receives ALL communications from the assembly.
