We are men and women standing as the People for The Virginia Assembly, unincorporated, and we operate and orchestrate our lives on the original Land and soil Jurisdictions on Virginia; we uphold and administer the unincorporated State of the Union (1776); one of fifty (50) nation-states comprising The Federation of States (*The United States of America, unincorporated*); we are the Lawful Self-Governing Body on Virginia which arises from an assembly of the Living people; we abide by the Highest Law and the Universal Principles of Free Will and Honor;



We are pleased to inform you that we have the Provenance, standing and status to provide American Common Law Living Courts of superior Concurrent General Jurisdiction on Virginia; these Living Courts of Record are populated and utilized by the Living people; they **hold supremacy over all courts of inferior, limited jurisdiction as stated in the Constitutions**; our Courts are now fully operational and will determine any issue or claim that presents evidence of factual harm and/or trespass against the people on Virginia; we consider the facts of any individual case and the Law itself; we hold the power to nullify foreign “law” implemented on our Land and soil and any law, legal statute, municipal code or “executive order” that is unjust, unlawful and/or harmful to our true nature as the Living people and our right and ability to live a life without corporate servitude and enslavement by foreign governments and courts;


International Peace Proclamation and Grand Peace Treaty
