Liening the Defacto (July 21st) Updated Credential Cards, see below (August 25th). Nothing past 2 weeks. Traffic Stop: Here is a section from the minutes of one of The Idaho Assembly meetings: (New Process, Notice of Liability, we will discuss later).

"There have been some misconceptions with traffic stops; he reiterates the do's and don'ts; the first thing to do when stopped is ask "what is the emergency and how can I help?". If there is no emergency you calmly say "well that's interesting, because your emergency flashers on; are you aware that it is a felony to utilize emergency flashers in Idaho (KBM's note: I don't think this applies in Virginia. I've tried to find the statute to no avail.....) if there is no emergency?". Smile, be kind and cordial. They will say "license and registration". Calmly put your palm out holding your credential card and insurance card, and nothing else; you do not hand it to them, you allow them to take it from your hand (which is an important distinction); Be accommodating but not over eager. If they say "there's no registration or license" you say "well, what indication do you have that I'm functioning in commerce?" They'll usually come back with some sort of retort. Just smile be cordial, and say "well, I don't know what premise you're operating under, but here are my credentials, and here's my proof of insurance; is there anything else?". And that's all; if they write you a ticket, smile and say "thank you very much". The biggest issue that people have been getting into is trying to argue or claim their status, which isn't going to get you anywhere. If they give you a ticket, make sure within 72 hours you send an endorsed version of that ticket back "accepted for full satisfaction and accord". Make sure you include a certified copy of your fee schedule. That is why it is important to make sure your fee schedule is recorded on the de facto. The time to get your fee schedule is not after something has happened. If it's not provided at the time, it's not going to be useful. Optimally, if you do have a certified copy of your fee schedule, you can provide that at the same time as the traffic stop by handing it to the privateer. Additionally, you can obtain their business card (which is a very important thing to do). It's critical to film the entire encounter, from the moment the stop begins until it's over. If they comment on it, you just ask them if they are wearing a bodycam; if the answer is yes, then there shouldn't be any issue. You're just "making sure the interaction is filmed for the safety of both parties". Aside from that, after the ticket is endorsed, send it to the address on the ticket along with your certified copy of fee schedule, and if you want, a cover sheet explaining who you are and your status; you can include a copy of your credential card. And that's it. If it does go to court, record a certified copy of your 928's into the court docket. At that point, things should be dismissed fairly quickly."

It was asked if are there others who can assist those seeking help with documents, questions, etc.? We have Chris, Beth and Lorrayne who are also recording secretaries. Kevin will forward some documents to Chris for recording. Kevin Barry does not want notices printed by different printers and wants to use the same paper and printer.
