Old Business:

1. Sheriff Notice updates. Updates are in the committee reports.
2. any other old business?
 1. Lorrayne provided an update on GFG training. There is currently coordinator training available, however there is NOT specific GFG banking training as of NOW. GFG is global and thus we must be patient.
 2. The group voted to approve the minutes for our last (6) General assembly meetings (2/4, 2/18, 3/4, 3/18, 4/15, 4/29) Randal Rimbey made the 1st move to adopt the minutes, Aaron Ashanti 2ndd the move. The vote carried unanimously!

New Business:

1. Personal US Trustee Notice, my examples
 1. KBM advised everyone to read his Trustee notice and if YOU feel guided, you are free to copy his and record it In your LRO.
2. We will have a discussion of...
 1. A statement has been added to the Assembly website outlining what the assembly is, and what we are able to assist ASN's with in regards to personal citations. Currently the Assembly has no power or authority or standing, therefore ALL personal issues are the responsibility of the individual to rectify. ASN's can make suggestions, however we do NOT have authority to mitigate your problems.
 2. KBM reminded everyone to attend the International Litigation meetings or to review Eugene's process if you have issues.
 3. Randy Rimbey also provided an update on what the Marshal At Arms can do, and that he has no authority or power in terms of dealing with the de facto.
3. "What an assembly is and is not"
 1. Lorraine summarized the challenges associated with ASN's and the de facto. The Assembly is focused on the new court process. Soon, the assembly will send out our Ex Parte Milligan notice. We ask that you read this message before our next General Assembly meeting so we can vote on this for approval.
4. Other than that aspects of committee work will be briefly discussed...
5. Discuss issues with zoom connectivity.
 1. Lorraine advised the group to please clear out your cache and history for the Assembly website. All ZOOM links have been updated.

8. Committee Reports to include Treasury Report.
 1. Steve Just gave an update on the militia committee – We have several focus groups/committees that need "chairs". In holding down the fort while we get

populated. The top committees in need are: Operation support, Enrollment, Procurement and Education. Dominick is also looking into Hazmat containment and Aaron may have some additional public health oversight. Steve and Bruce Clements are also trying to meet with some of the sheriff's on Virginia – they are trying to coordinate their time. 109 out of 123 Sheriff's have been noticed. Some mailings were returned due to address issues.

2. Cheryl Perko – is still in need of someone to take on the outreach committee. We had previously had Kim and Melanie to assist however due to unforeseen circumstances, they are unable to take on this role.
3. Randy Rimbey - We are still updating our court docs and procedures. We have adjusted the bondsman to a new "title" which will be "The Court Guarantor". Instead of paying bonds, people in need of court assistance will make an assurance pledge and whomever "wins" the court case will receive their money back. This information will be included in the updated handbook.
4. Randy also gave an update on the elections committee. Friday, 5/16 a focus group will be held to review and revise the elections process.
5. Lorrayne gave an update on the Jural committee. Essentially this committee is kind of on hold while the court docs & procedures get finalized and so we can work on the mock trial. Dominick will need new witnesses due to Kim and Melanie departing the assembly.

Randy Rimbey makes the 1st move to adjourn till 5/27, Steven Just 2ndd the move. Meeting adjourned!
