VIRGINIA PUBLIC STATEMENT Regarding the WHO and other NGO's

We, the living men and women on Virginia, present this Public Statement to provide the people on Virginia with the current position and perspective of The Virginia Assembly on the Policies and Regulations of the World Health Organization/WHO and any other incorporated Non-Governmental Agency (NGO) who may pretend or presume to have authority over the people of any nation or country.
