All facts stated herein are true to the best of our knowledge and comprehension, and we reserve the right to refine and clarify these facts moving forward.

We live by the clear and simple precepts of: **Do No Harm, Be in Honor, Act in Kindness and Leave Life Better.** We hold our responsibility to act for the benefit of the people, and to nourish and restore the Land, Air and Water (LAW) on Virginia to be of primary importance. We affirm that we have declared Peace, will Keep the Peace and uphold the Public Law for the people on Virginia (see Federal Record <https://tasa.americanstatenationals.org/federal-record/>). **We extend our Honor and our hands in friendship and Peace.**

American Common Law Courts of superior General Jurisdiction

We are pleased to inform you that we have the Provenance, standing and status to provide proper American Common Law Courts of superior General Jurisdiction on Virginia and these Living Courts of Record hold supremacy over all courts of limited jurisdiction. Our Courts will determine any issue or claim that presents actual or potential harm or trespass against the people/People on Virginia. We consider the facts of any individual case and the Law as it applies to the American people, their rights, property and effects. We hold the power to nullify foreign "law" implemented on our Land and soil and any law that is unjust, unlawful and/or harmful to our true nature as the living people.

We bring your attention to *Ex Parte Milligan*, 71 U.S. 2 (1866), where it was decided by the corporate U.S. Supreme Court, that the quasi-military (carpetbagger) courts are required to stand down and defer to the superior authority of our civilian, American Common Law Courts. This decision was instituted at the time of the usurpation of our Lawful American Government after the mercenary conflict known as the Civil War. The Lawful American Common Law Courts for the Living people were purposefully maligned, and their existence so obscured from the eyes and awareness of the people, that we scarcely know that this is the structure that America is founded upon.

On Virginia, our American Common Law Courts are reinstated by our Land jurisdiction State, and soil jurisdiction counties, and all other (incorporated) courts are required to acknowledge that they hold only limited jurisdiction and must cease misaddressing the Living, American people in foreign court systems.

On Virginia, the Lawful enforcement of Ex Parte Milligan is invoked upon notification by The Virginia General Assembly and will be forthcoming. The Virginia Jural Assembly has Justices and Jurors in place to call forth a Grand Jury. Our civilian courts will soon be called into service, and we will be utilizing the court houses already established on Virginia. We realize that due to hierarchy, compartmentalization, blatant withholding of information and the presentation of outright lies, you may not be fully apprised of what is True; however, **we consider this to be additional Notice.**

In law, as noted above, Notice to Principals is Notice to Agents, assigns, and successors, and vice versa. We believe that if those in Office who have received prior Notice from The Federation of States and/or The Virginia Assembly have performed their duties and responsibilities appropriately, then you will already be informed of the facts contained herein. **If you are unaware, know that your principals have failed you by withholding this imperative information** and that each man or woman who stands in continued opposition to, or ignorance of these facts, will be held liable in both a private and public capacity for continuing in harm and trespass to the people on Virginia. **All men and women in receipt of this Notice have cause to know that their actions allow impersonation and enslavement through press-ganging the living people into foreign (incorporated) courts and foreign jurisdictions that deal only in legal fictions and that generate income for criminals and malicious intent.** Be it known that you are complicit in the approval of harmful legislative acts and funding of every imaginable avenue of harm to the people through enabling corporate crime and genocide to enrich yourselves. It now comes to an end.

For over a decade, the factual American (not U.S.) government; the unincorporated Federation of States, doing business as, The United States of America, unincorporated (1776), has provided International Notice and informative materials to educate those holding office in the incorporated, U.S. “Government”, its State-of-state franchises, successors and subcontractors, and other nations of the world regarding the crimes of treason, personage and usurpation that began at the time of the Civil War (mercenary conflict), and that is still occurring against the American people/People and the true American Government today. The Federation has completed proper Due Process in Land and Sea Jurisdictions and continues to address the criminality amidst the law of the Air Jurisdiction where those responsible have retreated to escape accountability for their actions in the realm of the physical. These Notices, Declarations and other actions taken by The United States of America, unincorporated, on behalf of the living people, bring clarity regarding the actual duties and responsibilities of your office and the continued fraudulent and criminal nature of your actions while impersonating our Lawful government. In addition, The Virginia Assembly has sent Notice and informed key Principals of the incorporated Virginia and incorporated U.S. “Government” of our Provenance and standing as the people/People on Virginia. Among those notified are Governor Youngkin, Executive U.S. Trustees, county Sheriffs, the Virginia Supreme Court Justices, and others (This information may

In acknowledgment of these facts, **any further usurpation beyond this additional notification will be seen as clear betrayal of, and trespass against the people/People on Virginia and our Country.** We require you to administer your Office in favor of the living souls and Life in general, and not for your incorporated employers who are acting in open treason against the people/People of the American nation-states.

We acknowledge and act upon our responsibility to ensure and require that those holding a British Title of Nobility or Honor, Office or employment for any Federal Service contractor, their subsidiaries or any agencies arising from those organizations, act in accordance with the Virginia Constitution, the Organic and Public Law, and the three (3) Federal service contracts called Constitutions (The Constitution for the united States of America -1787, The Constitution of the United States of America -1789, The Constitution of the United States -1790) which are applicable to anyone acting as U.S. Citizens/citizens of the United States. **All must uphold the Constitutional Protections and the Natural and Unalienable Rights of the people on the Land and Soil on Virginia, and administer their delegated Duties and responsibilities from a place of Honor and Integrity.**

We bring your attention to the ruling made by your U.S. Supreme court on June 28, 2024, overturning the decision in the Chevron Deference Case (1984) as being averse to the Administrative Procedures Act. Following in the path of the *West Virginia v. EPA* (2022, and also *Norton v. Shelby County*, 1886) ruling, this case reinforces the fact that the responsibility and accountability for proper administration of legal statute was always yours to bear and now returns to your body politic where the results of the long-term divestment of those duties will come under the scrutiny of the informed people. It is your responsibility to be fully apprised of the statutes, codes and acts that are allowed to perpetuate through your action as a “delegate” and which are currently being deceptively misapplied to the living people through unconscionable contracts, bonds and trusts of which they are unaware. We recognize that our American system of government has been usurped by incorporated entities and your body politic has been responsible for financially and otherwise enslaving the people on Virginia and destroying their Freedom and health over time. It must be true that you are not thoroughly researching the proposals put before you and how they ultimately affect the people when passed into “law” by your alignment.

A cursory look shows the blatant harm that these choices are bringing upon the people of our state, and how it brings great benefit to corporate interests instead. **We will no longer tolerate the lack of Due Diligence and perpetuation of lies and harm (See *Public Notice of Harm – Cease and Desist and We See! We do not Consent!* on our website).**

Our country, our nation-states and our people are amidst a state of severe distress, harm and trespass purposefully inflicted by criminal, corporate, governmental service providers impersonating Lawful governments and using extreme force against the people. We are living under corporatocracy, and technocracy commingled with the Military/Medical Industrial Complex and an ancient lineage of Eugenicians with long term plans. These plans are orchestrated by unelected, globalist “elite” and implemented by misguided, misinformed and/or

malevolent employees of their incorporated “governments” such as those impersonating our Lawful American Government, Law Enforcement, Medical Doctors and Nurses, the Military, and the severely weaponized Maritime and Admiralty Court systems where our Names/NAMES are used by those **acting as public Usufructs in Breach of Trust, under Color of Law and false presumptions of war.**

Be aware that impersonation, identity theft, and misrepresenting your limited positional authority as broad sweeping powers and usurping our American political status in your Courts or incorporated governmental system is a capital crime in international jurisdiction. You are operating in a foreign capacity with respect to Americans and are required to provide full disclosure to the people and/or stand down immediately. The Maritime and Admiralty courts currently being staffed by British Accredited Registry (BAR) Attorneys, imposter Judges and Justices, Clerks etc., are operating under the British Crown corporation and any reference to Virginia as a Commonwealth (under British rule) speaks only to an overlay of foreign law on our Land and soil.

We require Due Diligence and provide this information as Notice to you of the breadth of our comprehension of facts. It is your Public and Official Duty to review all information herein and otherwise recommended in the attached documentation. In addition to three (3) physical copies, you will receive a digital copy of this message and all attachments may be found on our website. This will facilitate distribution to Principals, Agents, corporate Officers, and Employees, all of whom would benefit from access to this Notice and clarifying information.

It is time for full disclosure of the true nature of our current circumstances. We demand immediate course correction for the unfathomable harm and trespass that is occurring on our state and to our people. We will no longer tolerate the continued implementation of the destructive plans of unelected bureaucrats and their subordinates.

We, the living people on Virginia arrive in the present moment with a resounding We Do Not Consent!! Let there be no question or doubt. There is no one acting within these fictional, incorporated capacities or within the theater of your assemblies or court rooms (“venues of commerce”) that has authority over, nor even the right to address, the men, women, sons, and daughters who have declared their political status as Living souls; state nationals born on the Land and soil of our nation-states. We are the men and women on Virginia who acknowledge, embody and wield our Provenance and standing as properly declared American State Nationals. **We are not under your jurisdiction or positional authority; however, we do not stand “against” you.**

It is our belief that many transgressions and actions taken under duress may be forgiven when acknowledged in full disclosure, honesty, and remorse. The people require education, protection, cessation of, and relief from the assault on our physical, mental, emotional, financial, and individual energetic expression.



When one undertakes Due Diligence and engages with evidence of harm, **the facts cannot be avoided**. It is the responsibility of each man or woman in positions of perceived “authority” or otherwise, who comes upon what is true, to inform and notify those that remain unaware and may be reached through notification by their Office and influence. **It is essential that each man or woman undergo deep self-reflection and come to understand the results of their action or inaction.**

Notice:

Required Declaration of Political Status

All men, women, Officers, and Agents holding Office or Employment in any Foreign Corporation are required to Declare their chosen Political Status and their intentions.

The nationality of Americans has been usurped and hidden from the people for decades and this identity theft occurred at the time we were born through certification and birth registration. We were cast into foreign citizenship with obligations to Britain and Rome (see 5 *Types of Citizenship* and *Historical Data and Overview* documents on the Notices and Claims tab).
