Notice of Default & Opportunity to Cure

Notice to Agents is Notice to Principals and Notice to Principals is Notice to Agents

Dear Governor Mark James Smith,

We the People of The [YourState] Assembly who, on the 18th of June, 2022, noticed you by Registered Mail # RF 173645729 US that our State Assembly is reconstructing our unincorporated civilian government, are now serving you this **Notice of Default & Opportunity to Cure**, and reminding you of your duty to provide the constitutional guarantees of all American State Nationals and American State Citizens.

The [YourState] Assembly is populated and operated by those above named American State Nationals and American State Citizens (hereinafter ASNs). We have expatriated from all presumptions of political status as U.S. Citizens and citizens of the United States. We are not "sovereign citizens", which is a contradiction of

terms (an oxymoron). Nor are we to be considered terrorists or insurrectionists; however, we may be referred to as "Specially Designated Nationals" in your system of things. We are the lawful American people – at peace with our governmental service subcontractors - who have declared our status on the Land jurisdiction as [your demonym] who are owed a republican form of government and good faith service from our federal subcontractors.

It has come to our attention that, despite the lawful declarations of ASNs on the public record, many agents and offices of the State of [YourState], [YOURSTATEALLCAPS], and STATE OF [YOURSTATEALCPS] have often failed to recognize these declarations and have been, subsequently, unlawfully presuming that these status-corrected ASNs are operating in commercial Maritime or Admiralty and subject to the associated statutes and code; and also unlawfully presuming that they are U.S. Citizens or citizens of the United States; all of which is misaddressing the ASNs and a default of contract and a crime by way of Personage.

To address this default, with this notice we hereby express our wish to your office and all other agents and agencies of the State of [YourState], [YOURSTATEALLCAPS], and STATE OF [YOURSTATEALLCAPS] to cease and desist from misaddressing all ASNs traveling privately within the geographically-defined borders of the actual Land & Soil State called [YourState].

As we seek to provide an opportunity to cure, it is our wish that the above named legal entities provide all properly declared, recorded, & published ASNs with appropriate forms of identification documents - or recognize our current ASN Credential Cards issued by the Federation of States – distinguishing ASNs as domiciled on the national soil jurisdiction and outside the Federal or District United States, and set apart from any federally enfranchised citizenship, and also that you provide private license plates as this will aid your agents and agencies in properly recognizing ASNs and avoiding trespass upon ASNs.

As of the writing of this notice, no incorporated governmental service agency of [YourState] has openly provided private automobile identification plates as required by **Regulation Z** of the **Federal Highway Safety Acts**; and this has resulted in your agents, agencies, and courts repeatedly misaddressing ASNs. Nor have they provided private identification documents recognizing our proper and distinct political status; and these defaults have resulted in many unintentional, yet direct, violations of both 18 USC 241 & 242, deprivation of rights under color of law.

As you are aware, it is unlawful and illegal to suborn ASNs to register their private automobiles as commercial vehicles or cause them to be suborned to falsify public records to the effect that their private car or truck appears (on paper) to be a Motor Vehicle when neither the automobile nor the owner is in fact engaged in any commercial activity. It is our intention to bring this to light, to help your agents and officers avoid trespass against ASNs.

We require the compliance of all incorporated governmental agencies and their agents with these wishes of The [YourState] Assembly as other States of States have complied or are in the process of complying by providing both private unregistered automobile plates and private forms of identification or by accepting the credential cards we have already issued. Please see the enclosed images of sample private automobile plates and private identification cards for your reference.

We remind the Governor that all ASNs are owed every reasonable respect, every care, and every jot of the guarantees and limitations of the Constitutions that give contractual life to the foreign governmental service corporations that all public employees work for. As our State Assembly is in session, it is prudent to bear in mind that any public employees who deprive ASNs of their rights, physical assets, credit, or their proper political status under color of law are 100% personally and commercially liable for their actions.
