Public Notice of Harm 2023 -2024 Cease and Desist The People on Virginia are at Peace!

We, the men and women on the Land and soil of Virginia, standing as "the people" comprising The Virginia Assembly, recognize and enact our inherent Natural and Unalienable Rights and our Public Duty; we present write this notice to inform the Living people men, women, sons and daughters on Virginia of trespass and harm that is occurring against their bodies, minds and property; also, to inform and give notice to the men, women and all Beings thatr are in any way enabling this harm, of their responsibility and accountability; the following serves as a Living document and stands as our statement, observation and research of true events in this year of 2024 anno domini;

we state that the following list of biological, optical, frequency and sound weapons and destructive technologies, actions and ideologies are acts of treason, genocide and trespass and are intended to destroy Life; to the best of our knowledge and belief, the following are true and indicative of purposeful and elaborately planned harm (see Public Notice of Harm 2023-2024 – Exhibit A at https://thevirginiaassembly.org/notices-and-claims);

we require a cease and desist in all harmful activities including and related to, but not limited to, the following;

- 1. Weaponization of Frequency, Light and Sound 5G+ (5th Generation Warfare}, 6G (WBAN) infrastructure, bio-photonic weaponry, radar and drone surveillance and warfare, et. alia);
- 2. Bio-Digital Convergence and the use of the biofield of the living people as an internet data storage and routing system (WBAN, PBAN, MBAN);
- 3. LED optical weapons on streetlights, automobile, and vehicle headlights;
- 4. geoengineering, stratospheric aerosol injections ("chemtrails") and the polluting of our skies with nano and metamaterials;
- 5. HAARP High-frequency Active Auroral Research Program, weather manipulation, biofrequency, sound and optogenetic weaponry;

- 18. pornography and LGBTQ+ ideologies in public school programs and libraries and on social and public media;

we state that if you are among those acting in ways that are destructive to Life and Freedom then you are responsible for trespass by way of harm and will be required to provide remedy to the people;

if it is apparent that you have acted against "we, the people", it is our obligation to seek remedy in full force and Providence of the Public Law and the Laws of our Creator;

what is true will be revealed in time and acknowledgment of any role a man or woman has played in the attempted decimation of all aspects of a joyful life, is witnessed and will be reconciled;
