

## Virginia Assembly Meeting Minutes, December 13, 2022

This meeting was held on Zoom.

Kevin Barry Miller (KBM), Coordinator and Chairman of The Virginia Assembly

1. The meeting was called to order at 7:07p EST.
2. Tamara offered the opening prayer.
3. Kevin Barry Miller recited the Bevin's Declaration.

5. Announcements

- i. New Recording Secretary needed!!!! Thank you, Beth Doyle.

PKTF: Steve said they did not meet last week. Next Marshall’s meeting will be Friday (Randell). Randell said he is trying to reach another assembly to help him develop an affirmation statement. He has been working hard on jural assembly, reading the handbook. He is finding that through 80 pages of the book, 90% is history and not the nuts and bolts to help us put a jural assembly together. Some alarming things he found were that we need more people to create a jural assembly. (From the Jural Assembly Handbook) As of the Constitution of States in 1860, women and people of color could not join the jural assembly. Therefore, we will need to get a quorum of 15 white males to vote and change those rules to include women and people of color. To be a Jural Assembly juror, you must all have filed your 928’s and are fully expatriated. Once you are a state juror you are automatically a juror for your county. Women and people of color may be in the General Assembly. Thunder thought that this issue had already been addressed but according to Randell, after he attended the Marshall meeting, he understood that it is still in effect. Anna Marie said she will clarify this issue by sending Kevin an email with the data that disagrees with what the jural assembly handbook states about this issue. Kevin will contact Judge Anna directly for clarification of this topic.

Steve said that there are 35 members in the General Assembly.

New Member Orientation Committee: Tamara said that Troy is still with us. He has been busy but plans to rejoin us in January.

Thunder Lane said that there is a certain way for men and women of the land and soil to sign our names.

- v. Intel from the Federation – Banking, setting up banking and credit unions. Kevin is not conversant with this issue. Banking will be part of the 4<sup>th</sup> pillar, the business pillar.
- vi. Anna’s Monday night call, Tamara attended and said AVR spoke a lot about banking and the difference between credit and assets. You can watch her video to learn more.

## 6. Old Business

- i. Vote to adopt minutes from past 3 weeks. In spite of some attendance errors (which will be fixed), we did a summary vote on the minutes for 11/22 (unanimous); 11/29 (unanimous), and; 12/6 (unanimous). Scott corrected (under attendance) the 12/6



minutes to reflect that we had a quorum. Steve said that we have had a quorum at the past three meetings. After we initially did not vote on the 12/6 minutes, Patty made a motion to vote on the 12/6 minutes and Tamara seconded.

## 7. New Business

- i. Banking Chairperson. We need one.
- ii. Discuss: Invite Letter for new (potential) Assembly members. Tamara has written one and Kevin will finalize.
- iii. Discuss: Physical location for Recording Books and Assembly Documents – We voted last week to have this at the Coordinator's House in a Fireproof safe. Secondary Access (Shirley, Steve, Tamara, Scott). Kevin will let his mother and daughter know. Tamara made a motion that we vote on the 4 who have secondary access to Kevin's safe, Shirley seconded. Kevin wants to write a "contract" second, after we take this vote. Thunder wanted to do the contract first. Kevin tabled the issue and we will discuss this next year. We need to draft a contract.
- i. **Open Discussion:** What do we do next year? Start getting jural assembly up and running. Scott asked should we use social media? Hand out cards at farmer's markets, public places, etc.? Educate our fellow Americans; Claire said there are 385 members of Congress who may potentially be held accountable by the Supreme Court (Brunson Brothers v. Adams); Kevin stated that is not our business, it is their corporation's business; Kevin said Brazil and (Thunder said) Haiti are under martial law. Kevin has heard that the U.S. military may step in here in our country. There may be some truth disclosure involved. Kevin continued, we are the new founding mothers and fathers. We are the people who are going to save Virginia and the United States. There are a number of assemblies in Virginia. We are TASA and AVR. David Strait's assembly has lots of people, and they follow his process to file. Kevin has no qualms about that but the David Strait group wants nothing to do with TASA and they do not have any historical grounding. (People have claimed AVR is a Vatican agent. AVR has addressed this numerous times in articles and videos. She is not a Vatican agent). David Strait's group only went back in history to 1998, AVR went back much further. We are internationally recognized to the best of Kevin's knowledge. Thunder asked, "What about landowners from the 1300 and 1400's"? Kevin has no knowledge of this. Kevin has had federal judge Michael Howard Reed indicate that the very first treaty here in the United States was between the 13 colonies and an Ohio Indian tribe (Iroquois) about mid-1700's? There were also treaties between tribes. Thunder wants to know if anyone has been successful with any of the programs and processes? If so, share them. Rimbeys said we need to work on our jural assemblies. We need to have our own court up and standing to defend ourselves. Without that we cannot elect sheriffs and militias. We need to design our court. He wants to bring it to Appomattox County and restart our state and county. Karen agreed with the Rimbey's and with Thunder. We can use videos and teaching. Kevin has been researching on education on court (surety) bonding system (it is the entire backbone of their corporate system).

He has been in touch with the NJ and MD assemblies. They are working to hold these public agents and officials accountable under Army CID and Navy JAG. He will have info in one month or two. Kevin did a MOCEE process to the IRS a few weeks ago but has not heard back. Tamara submitted her letters to the IRS in June and she is not a taxpayer and has not yet heard back. Claire has also sent notice over a year ago and has gotten 3 letters from them that they received her inquiry. Her one concern is they keep asking her for her SS number. She was concerned about doing the W4. Randell said Claire can listen to the 30-minute URL video. It is the injunction link in the "to do list", it is #3: Injunctions: [https://www.youtube.com/watch?v=b\\_CXYUR-tFU](https://www.youtube.com/watch?v=b_CXYUR-tFU) Never give your SS# to anyone. Getting your State National passport is our golden ticket, we each need to get ours. Cheryl did a set-off demand letter to clerk of court and attorney, she requested a change of court date and later they dropped the case. She had lost her job and creditor(s) were going after her. Kevin said others have not had success with the set-off demand letter. Not all remedies are 100% successful. We are always trying to educate ourselves.
