He has not yet received the scandisk from the director yet. He sent it registered mail. They are pushing the Marshall at Arms to get positions filled. They want them to be billboards. They want a Marshall in each county. Tennessee supposedly has 8 counties represented. They want us to be more vocal. They want affirmations ready for when the positions are filled. They discussed due process and how the juries render their decisions. AVR suggested that the National Guard stand down and become our militia. The old militia was put into the National Guard. Tamara got an email from Mike Clark. They meet on Tuesdays and Thursdays and she might attend. Some in that group are dead set against AVR. - 8. Death of Maryland ASN Richard Antonio Joseph. He was gunned down/murdered Christmas Eve after finishing his security guard shift. He had been given questionable felony weapons charges in the D.C. Superior Court. They searched his car without a warrant and found a gun. He and the MD Coordinator entered into the courts records a UCC-1. They put liens on the case number and this upset the court and judge. Kevin played a 6-minute clip from the Coordinator call (John Sweem) from last Friday. AVR's article #3856 entitled, "The Long Night" demonstrates how Court Bonds are the true Achilles Heel of the commercial court process. They are committing securities fraud by creating a bond in your name to drag us into their courts. If they do not have a bond against you, they cannot pull into their courts. AVR has articles about this. You can dismiss the case with extreme prejudice. AVR has a strategy to tap into their funds instead of your own. AVR article #1220. "A court order is like an Order for french fries, Okay?" Watch "The Fearless Floyd Show" on Youtube. He "outs" unlawful court clerks and gives outstanding explanations of how to use liens and other paperwork to defend your rights in their courts.
