

Virginia Assembly Meeting Minutes, January 17, 2023

This meeting was held on Zoom. Attendance will be taken on the Google Drive spreadsheet. We are now using Google Drive to store Assembly documents. Google Drive is by Google and OneDrive is by Microsoft, we use Google Drive.

Announcements

Lorrayne explained the Treasurer role and how it may change going forward.

1. New Recording Secretary needed!!!! Thank you, Beth Doyle. We may have an interested party. Sally D. expressed her interest in the position. We will vote on her candidacy soon.
2. **Focus** (used to be Steering) **Committee** every Monday at 5pm EST – I will start sending out invites to ALL!!! ALL will get invite and all will get an agenda, beforehand. Any suggestions for a new day/time?

4. Committee Reports (announcements and info). PKTF, New Member Orientation, etc.

Marshall at Arms bridge call. Randell said there was no recent meeting. Steve and he continue to work on describing position duties. The 64 GB scandisk, download has been

done and he should get it in the mail soon with 4,000 literary items. David Gaul (sp?), Marshal at Arms from CA put together an election process. They sent it to AVR for review and approval, but she has not yet responded.

5. Intel from the Federation – Dunn & Bradstreet Reports. A lot of the states obtained their D&B reports, which are very detailed. Virginia still does not have its report. The purpose of getting them is to figure out their government/corporate structure. We need to find out who is in charge of their judiciary courts. In 2007 or 2008, AVR filed a UCC that claimed the land and soil back as fiduciary for Americans. We need to ensure that AVR's UCC filing is visible on D&B.
6. Anna's Monday night call. **We NOW have transcripts – on Google Drive!** Many people close to AVR have recently died, and all were jabbed. AVR said that the municipal side of the government and the territorial side are also at odds with one another.

Old Business

1. Vote to adopt minutes from 1/10/23. Tamara put forth a motion to adopt them, Steve seconded. Vote was unanimous. Patty made a motion to adopt the 1/3/23 minutes and Randell seconded. Vote was unanimous.
2. Any more old business?

New Business

1. Do we have a Quorum? Yes
35 Total members; 16 not in good standing; 19 active members; 15 in attendance; 10 to have a quorum; we have a quorum.
2. Any members wishing to come into compliance? Not tonight.
3. Google Drive for shared documents – **Email me for ACCESS!!!**
4. How do we find what current people are members of the Jural Assembly?
5. Banking Chairperson – Scott Severt. Anyone else? **We need to form a banking committee first. We will discuss this at the focus meeting. We will vote later.**
6. Jural Assembly Vote? (Roger Dallas – research?) We need to first figure out who is in the Jural Assembly. To be in the Jural Assembly you only need to be papered up (1779's or 928's). You also need to sign a Jural Assembly membership agreement and it should be recorded. To be a delegate(elector) you need to first create your family lineage. Trace back your family lineage as far back as possible using Ancestry.com. Kevin will put his family lineage on Google Drive as an example. Some say you need only to go back to before 1861, others think you should go back as far as possible. **Repeal, then re-vote.**

This needs to be put on hold until Roger Dallas gives us the timestamp of what time the vote was held. He already told us the date of the vote.

7. In person meet: Return to Thunder's Farm or other location? Suggestion: late April/early May.
8. PO Box vs. General Delivery (might need to re-visit this.....) Discuss: Physical location for Recording Books and Assembly Documents – At the Coordinator's House in a Fireproof safe. Secondary Access (Shirley, Steve, Lorraine, Tamara, Scott)

We have already voted as an Assembly on the physical location and having a fireproof safe, but we did not vote on who gets secondary access. We first need to create a bilateral contract between Kevin's family and those with secondary access. We need to talk about this more in depth. The need for physical secure storage is in the future. It is not a pressing issue now.

9. AVR Monday night from 12/26/22: 1) Claim Estate, 2) hold them accountable – Navy JAG? Lords of Admiralty? **Claim Estate vs. Reclaim Your Securities.**

11. Some VA Assembly members visited the David Straight Assembly last week, and they confirmed that they have a lot of venom for AVR. If you dig around Fearless Floyd's videos there are many that attack AVR and her husband. They are alleging things that occurred 40 years ago. Years ago Eric Dingus (sp?) was hanging out with Fearless Floyd as members in the Texas Assembly. For good reason, AVR fired them years ago and deactivated their TX assembly. Eric Dingus supposedly was CIA. This is what underlies the disagreement between the parties. AVR has been very open about these allegations, it had something to do with her step-daughter.
