Announcements

- 1. New Recording Secretary needed!!!! Thank you, Beth Doyle.

The Marshall-at-Arms position is now real. Randell received training on how to handle correspondence from the Federation from Scott Hayce (sp?). One of the Marshall's jobs is to get the mail. Because we are all scattered, the reality of just one person receiving all mail is impractical. It needs to be a team effort for now. Once we have a physical building, then it makes more sense.

We need to purchase a 64GB scandisk hard drive (Randell has done so and sent it to Scott H.). Scott H will send us a literary library with all kinds of info on how to get our assembly set up. The material is from archives from all around the country. It will be a great timesaver. It would be great if we can find what other assemblies are doing. At some point it may be a good idea if we were to meet and go through all the material on the hard drive. Kevin said we already have two computer hard drives for back-up purposes. We could load the data onto OneDrive or other cloud-based storage services, but they are not secure. We should look into other secure document storage ideas. Kevin

will back up the data. He thought of ways we can upload everything to our website so all can see.

From the Nevada Marshal at Arms, we can contact a Federation Recording Secretary to take any of our overflow. There is another Federal Recording Secretary in Indiana, Christine. There are 14 Recording Secretaries at our disposal. Tamara is getting the list of them.

We previously voted to keep completed Assembly record books/permanent archives in Kevin's safe. We just need to vote on who gets secondary access.

We need to spread the word, proudly fly our flag in front of the general public and let them know we are here.

Kevin has been working with someone in Maryland to try and hold local judges accountable using Navy and Army JAG. Read the AVR article #3856, The Long Night. Securities fraud has been rampant throughout the court system.

5. Intel from the Federation – Banking

There was a Coordinator call on Friday, December 29, 2022. Tamara attended.

- 6. AVR's Monday night call, 1/2/23. Tamara listened to it. Many patriot groups are going in all different directions and it would help if everyone got on the same page. AVR is trying to accomplish this. She found three more trust funds for Americans that are larger than the St. Germain Trust (\$39 trillion). Those trusts will also be named in our Declaration page. AVR's call of December 26, 2022 is also very important, and we should listen to the first two hours. We each need to claim our estates and send that out to a number of different agencies: The Bureau of Consular Affairs, Department of Justice, Secretary of State, the Secretary of State of your birth state and of your residence state, the Department of Treasury, and Provost Marshall. You can claim your estate up until your one hour mark. We should be making criminal claims of inland piracy to the Lords of Admiralty, and to the Navy and Army JAGs for violation of the Navy Distribution Act of 1864. Kevin works with John, Maryland Coordinator, and the TN and NJ Coordinators on such matters.
- 7. We have new Assembly members! Who are they?

Holly Pickle and Robert Combs signed their membership agreements. We have two new Americans on the land and soil, Benjamin Pierce and David Jenkins. Welcome!

Old Business

1. Vote to adopt minutes from 12/13/22. Tamara made a motion we vote, Steve seconded it. No abstentions, no negative or nay votes, all in favor said aye. It was unanimous.

2. Any more old business? None

New Business

- 1. Do we have a Quorum? Yes, 14 attending out of 21 active members in good standing.
- 2. Any members wishing to come into compliance? Anna Marie reaffirmed the rules of order of the VA Assembly, will now be back in compliance and her voting can start at the next meeting. Kevin can ask this question at the beginning of each meeting.
- 3. Banking Chairperson Scott Sevart. Vote next week. Scott could work with Tamara and/or we could form a committee.
- 4. In person meet: Return to Thunder's Farm or other location? Suggestion: late April/early May. Steve will reach out to Thunder about this. There is a nearby hotel (inexpensive) with a meeting room we could also use.
- 5. Discuss: Invite Letter for new (potential) Assembly members still to do. Kevin will do this.
- 6. Discuss: Physical location for Recording Books and Assembly Documents At the Coordinator's House in a Fireproof safe. Secondary Access (Shirley, Steve, Lorrayne, Tamara, Scott). Now we need to consider the new information Randell (Marshall-at-Arms) raised about protecting mail. We have not yet granted secondary access to anyone yet. We will put this back into the focus committee. It was suggested that we first write the contract before we vote people into this role.
- 7. Return of the Jural Assembly we voted on it, but is there a record of the vote? Previously we agreed to hold Jural Assembly and Virginia Assembly meetings on alternating Tuesdays. There would only be a video record of that vote. We may need to re-vote. Dallas will go through those Feb., Mar. Apr. videos to see if he can find and verify that vote.
- 8. AVR Monday night from 12/26/22: 1) Claim Estate, 2) hold them accountable Navy JAG? Lords of Admiralty? Claim Estate vs. Reclaim Your Securities.
- 9. Open Discussion: What do we do this year? Regulation Z/Working Groups on Mattermost are really on fire. They are giving notices to people/public officials. If we can lien them, they will become uninsurable and they won't be able to find work. You can learn how to send your bills each month to the IRS to offset them. The more of us who do this the better off we will all be. Some people have gotten into trouble doing liens even though they followed the letter of the law. It may be better to go to the Provost Marshall, Navy and Army JAGs to go over their heads. We can use Article 3 courts, if possible. Someone said there are no Article 3 courts favorable to us. We can start a Notices and Claims Committee. Kevin believes that all the notices have been sent out. We need to educate people about the notices in our communities, on bulletin boards, on Nextdoor and in-person.
