Announcements

- 1. Transfer of Recording Secretaries and duties, occurred during February 17 meeting: Sally and Beth and Tamara. Chris Dunlap also expressed his interest in volunteering to be a recording secretary. We will vote ON this next week.
- 2. **Focus** (used to be Steering) **Committee** every Monday at 5pm EST I will start sending out invites to ALL!!! ALL will get invite and all will get an agenda, beforehand. Any suggestions for a new day/time? They worked on the Jural Assembly agreement and need another week to finish it.

- 4. Committee Reports (announcements and info). PKTF, New Member Orientation, etc.
 - a. Randall: Sheriff Notes. Steve working on Marshal at Arms with Randall, working on Sheriff's Educational Handbook. Randy said there was a continental marshal bridge call (committee). Marshal at Arms at each state can appoint county level positions (until Jural Assemblies are stood up). They are writing affirmations for our state. Of 13 states present at the meeting, only one state had written affirmations (Alaska). Alaska is one county. Continental Marshals are backtracking on affirmations for now. Next education call is the following Friday. They discussed I.D. cards for state citizen office holders. When we have state jural assemblies up and running we can open a postal court. Continental Marshals have no clout now because there is no court behind them.

Lorrayne gave the treasury report. We have initiated the process of putting Tamara on the account as well as Kevin. Balance as of 1/31/23 was \$6,977.06; January inflow was \$611.94 for recordings and credential cards, \$13.34 for expenses (does not include % Square charges). \$797 will be refunded (previously donated for education fund), and she will send \$500 to federation for 2022 recordings. Sitting good for now.

- 5. Intel from the Federation Other Assemblies and Eric Dingess (years ago he was hired to create federal marshals but did nothing. He has ties to corporate side, and is active CIA. He was fired, he is trying to get active again but he is a fraud and works to sow confusion). Notice of Fraud and Treason (kevin is waiting to get a copy). Tamara showed us a piece from the Michigan Coordinator on why Anna Von Reitz is correct. We are the original and AVR has reclaimed our assets. We have put out international notices and are recognized and have authentic standing. We are the de Jure government.
- 6. Anna's Monday night call. We NOW have transcripts on One Drive! She speaks of self-governance, we must rule our own minds. We must envision our future and we have a lot of power. AVR believes we are not the only planet to support life. A lot of banks are failing and are being folded into other banks, which could potentially lead to one world

bank. AVR suggested that we get USPS money orders and hold them as back-up. It is not federal reserve money, it is U.S. currency. The de facto thinks there is an expiration date for these money orders. There is no expiration date noted on the money order itself (see sample money order below on page 8). If the USPS refuses to cash a lawful money order, then you would have the right to file a notice of claim against that agent, and the postmaster. This would be the start of your 3-step remedy process. In order to be effective, you must be knowledgeable, willing and able to follow through on all 3 steps. It would be helpful for us to hold a tutorial on this during our gathering in May/June.
