

Announcements

1. Transfer of Recording Secretaries and duties, occurred during February 17 meeting. Question about Recording Secretary costs (discuss below). When we get a document notarized, it has already been recorded and therefore the VA Assembly should not be charging for recording. All we can do at that point is publish the document(s). There was some discussion about charging for other documents, the ones aside from your 1779's and 928's. The notary is the person verifying, witnessing and recording the wet ink signatures. There needs to be more training in that area. This opens up an opportunity for us. We need at least 13 Recording Secretaries, one for each cluster. This is the cluster map.



2. Focus (used to be Steering) Committee every Monday at 5pm EST – I will start sending out invites to ALL!!! ALL will get invite and all will get an agenda, beforehand. Any suggestions for a new day/time? They worked on the Jural Assembly agreement and need another week to finish it. We are done with the general assembly member agreement. We went over the documents we want to send to the Trustees. Teri Sahm created the document, "Notice and declaration regarding unlawful exercise of right of distraint or levy". Thunder made a motion that we move forward to get the document done and it will be presented next week for all members to use. (Tamara was concerned about a deadline). This will solidify where we are going. Who is going to finalize the

document? Lorrayne seconded it. Lorrayne heard Thunder say he wants to make a motion that this be a document that as an Assembly move forward with (she did not hear the "by next week" part). Thunder said she is correct, but when he reiterated his motion he added a deadline. Lorrayne revoked her second. Cheryl feels where Thunder is coming from. The document is maybe one month old. Kevin said this information about the executive trustees was first discussed January 2. It was the meeting where Kevin played a short clip of the coordinator call and that was when Teri Sahm started working on the notice. Our Assembly only got the notice one week ago and started work on it immediately.

Kevin has put out 2 emails over the weekend about we are raising money for 6 people from TASA and AVR to go to see the Pope. He has finally agreed to our demands. We will get our trusts and land trusts back. Some offending corporations will be liquidated. The \$200,000 requested is for shipping artifacts, documents back to a secure warehouse.

Troy said we need to move forward with pace, because Virginia is lagging somewhat behind other states. Cheryl said we need to push through.
- 6. Recording Secretary expenses: cap at \$400? What about the \$501 cap in the Roles and Responsibilities? Sally needs some additional items to perform her new role. She needs a printer, file folders, stamp (seal), red and black ink pads, external hard drive, P.O. Box, etc. Chris will send her one of his extra, new external hard drives. Sally is paying for some of this out of her own pocket. Laura asked how will we track this equipment once someone steps down? Tamara stated that some former Recording Secretaries act as "reserves" if their services are needed and can step up on a moment's notice.

New Recording Secretary: Chris Dunlap has expressed interest. The reason Chris wants to help is his desire to speed up the process for others because his paperwork took months. He is a jack-of-all-trades. He is sure he can perform the necessary work and has the time to do it. He will officially be on board any day once he gets in his wet signature membership agreement and sends it to Sally. For training all we have is a manual and video but it needs to be finalized. He is papered up, recorded and published, just not through our Assembly yet but that is okay. Lorrayne proposed that we require our Recording Secretaries make a commitment to the Assembly for a minimum of one year. Chris has all the equipment he needs. Kevin made a motion that Chris be voted in as a Recording Secretary, Lorrayne seconded. One abstention, no nayes, all voted in favor. The motion passes.

April Thompson also expressed the desire to be a Recording Secretary. Thunder Lane motioned that we vote on her candidacy, Kevin seconded it. Lorrayne asked if April has the office resources she needs to perform the role. April has a scanner/printer, internet, computer, but not a back-up hard-drive or P.O. Box (not yet). She plans on being in the position for a while. She likes helping and learning new things and feels she would be a good asset. She is fully papered up but will need to submit her membership agreement. No abstentions, no nayes, all voted in favor. The motion passed.

7. Banking Chairperson – Scott Sevart is interested. Vote tonight. Need to define Banking Committee. We previously voted to have a committee. The committee will draft a list of

things we will be responsible for. The committee's role is to bring ideas and information to the Assembly. Not to make decisions. Kevin made a motion to vote Scott in, Randy seconded. Thunder Lane recommended we open it for discussion. We had a lengthy discussion. No abstentions, no nayes, all voted in favor. The motion passes. Scott emailed his resume and a brief description of what the committee might do to Kevin. This will be a starting point. Lorrayne volunteered to assist with the committee.
