- 5. Committee Reports (announcements and info). PKTF, New Member Orientation, etc.
 - a. PKTF met last night and they discussed old situations, found new info on sheriff, discussed jural membership agreement, he was unable to access the Friday Zoom meeting, continental bridge call.
 - b. New Member Orientation. Tamara thanked newcomers for joining the group. We are getting a lot of traffic. Shirley is taking a break. Tamara and Sally are trying to get up to speed as recording secretaries. Randy suggested new visitors/members introduce themselves. It will be done under new business.
- 6. Intel from the Federation Dunn & Bradstreet Reports. Executive Trustees!!!! (See below...) We are still waiting for our Virginia D&N Reports to identify the head of the snake.
- 7. Anna's Monday night call. We NOW have transcripts on One Drive!

A Universal Self-Governance course is being held on Sundays at 4p EST. They have met twice. Kevin will send us the email. MOCEE Mutual Offset Credit (debt redemption), Kevin has added a folder in our Drive explaining how to do this process. It is the most up-to-date, version 11. Militia training is online every two weeks (1/28 most recent meeting), go to Mattermost Militia Channel for the training meetings. They are recorded. They are looking for volunteers. Kevin did a MOCEE process regarding 2017 taxes the IRS pestered him, but since his MOCEE process he has not gotten any more letters so far. Tamara sent one out in December and another in January. Reg Z, MOCEE process is because (12 USC 95A) the Federal Government promised to pay our bills after they took our gold. We are making a stand. A former process was successful for awhile until they shut it down. Now we are doing it as a group. We are including another category of peoples, TRUSTEES, they are in charge of the account. There are 21 different areas across the U.S. We are area #4 and it includes VA, WV, NC and SC. We do not expect to be successful in the early phase, but it has great potential going forward. We are supposed to send an additional letter (928's) to the Executive Trustees to tell them to leave us alone. Our estates get charged when they come after us. They are supposed to take us out of the Public Charitable Trusts. The first thing the Assemblies want to do is contact the Trustees in the area and notify the Secretary of State explaining all the exemptions we are due as Americans. The Litigation Committee is formulating these documents. Kevin is considering doing it personally in the next several weeks. We should notice the Trustees and then immediately ask them what we need to do to make the MOCEE process a success.

- 8. Teri's Notice Package on One Drive. She is using these in her court case. There is a folder in Drive, called Teri's Notice, with documents for you to refer to.

Tamara explained the purpose of this segment of the meeting. Kevin has done a fabulous job of establishing a good foundation for the Assembly.

Scott said meeting in person with people can be very productive. He created a business card to try and recruit people. He sent it to Kevin and others.

Troy has heard that same day passport service at the State Department is working for some people. He may do a training. He recommended to take someone with you, because if the government lies to you, you have an emoluments case against them.

Randy has written a 500-word article and is submitting it to his local newspaper. He wants Appomattox County to lead our efforts. He will share it with Kevin.

Teodor said since 2013 the FBI has been distributing to sheriffs around the country about the oxymoron "Sovereign Citizen". There is no such thing. There are 4 articles about this on Paul Stramer's website (see link below) #223, 244, 284 and 3263.
