Virginia General Assembly Meeting Agenda for Tuesday, May 21st, 2024:

The meeting began at 7:03 pm eastern and is being recorded.

Randy read the Bevin's.

Bevin's Declaration: "Anyone here acting as an undisclosed federal agent or provocateur, anyone seeking to collect information for Third Parties, anyone working for some other agenda such as entrapment or solicitation or redirection of our group, and anyone who is not a declared and recorded American state national or state citizen, or is not in the process of completing their declarations is now ordered to declare themselves, or voluntarily leave this call." New Business:

1. Committee Reports

Banking Committee - AVR #4826, Hunter Aki is a billionaire and founder of the Global Family Bank. Its genesis began in 2007 after he witnessed the criminal "big short" on the Wall Street stock market. He reworked the concept of computerized banking and bank transfers, combining new mathematical systems and block chain technology, clean, secure, private, unique and not part of the old system. We will soon be able to bypass the Swift Transfer System. Mr. Aki did not charge anyone for anything. It's all free because he wants you to be free and to have the enjoyment of what is naturally yours. It's free because he does not need your money. From 2007 to 2021, all the burden was on Mr. Aki's shoulders. The Federation was pleased to charter The Global Family Bank and begin work on the Blue Dot Bank System three years ago.

May 14, 2024, AVR podcast

They are in a big discussion on how the credit unions can serve those with dual capacity or split jurisdictions (for example: postal clerks) who have reclaimed their American identity. We want to be able to serve everyone. This is why everything is not ready.

May 13, 2024, AVR webinar

AVR said that setting up our own bank and currency system is the quickest way out of this mess, and the corporations can be liquidated with no harm to anyone because they are not real. There is no reason they can't operate on the land and soil under public law and come under complete compliance of what they are supposed to be doing, operating in a lawful manner.

Peace Keeping Task Force – Steve said there was no meeting last night. They are going through the documents to sequence them correctly. Randy attended the 3rd week of discussion regarding using the ten commandments as part of common law. Anyone who is considering working on the federation level needs to be vetted. He is trying to catch up.

Jural Assembly, Lorrayne – Reviewed the court process. There were lots of suggestions, lots to do. They need to create documents. Next meeting is this Thursday, where we go forward and vote on policies and procedures. Come and vote.

New Inquiry, Cheryl, she continues to collaborate on Telegram, and do International Outreach.

Notice and Claims, Cheryl is trying to figure where to slide the meetings in, maybe Thursdays at 5? The group will hone in on directives by working on the justice and legislator notices. She is working with Luis. The next task for the focus committee is the Virginia justice notice. The consensus is to have it be short and sweet. They will model them off the Governor's notice. While listening to last night's podcast, "Who should already know", Cheryl was inspired on what to write. They are preparing the Sheriff notices packets.

2. Upcoming NAACP (Culpeper) meetings on June 22, 1-3 pm and July 27, 1-3 pm. Let's teach them some American History!!!! Words from Thunder? Special workshop on 1st amendments and freedoms. The NAACP is partnering with constitutional scholars and

they invited Thunder. He asked if he could bring friends and they agreed. It will be a great opportunity to interact with them. It will be held at the Culpeper Town Police Office/Community Center. If you can, plan to have a dinner or meeting afterward.

3. Banking and Credit Union Committee: (no need for vote). Scott, Shirley, Lorraine, Thunder, Jasmine, Patty, and Aaron. KBM emailed AVR an inquiry to start the process and got a reply but we need to send a follow-up email. The committee will review the first email exchange, discuss, and draft a follow-up email. Our first task will be to draft an email to AVR and review before the June 4th General Assembly meeting. The Federation offered to help us set up a bank. KBM forwarded us what AVR sent to him.

ASNs need a bank, split citizens need a credit union. Shirley and Aaron both have identified empty bank buildings in their respective areas that are potential bank sites for us.
