Traffic Stop: Here is a section from the minutes of one of The Idaho Assembly meetings:

"There have been some misconceptions with traffic stops; he reiterates the do's and don'ts; the first thing to do when stopped is ask "what is the emergency and how can I help?". If there is no emergency you calmly say "well that's interesting, because your emergency flashers on; are you aware that it is a felony to utilize emergency flashers in Idaho (KBM's note: I don't think this applies in Virginia. I've tried to find the statute to no avail.....) if there is no emergency?". Smile, be kind and cordial. They will say "license and registration". Calmly put your palm out holding your credential card and insurance card, and nothing else; you do not hand it to them, you allow them to take it from your hand (which is an important distinction); Be accommodating but not over eager. If they say "there's no registration or license" you say "well, what indication do you have that I'm functioning in commerce?" They'll usually come back with some sort of retort. Just smile be cordial, and say "well, I don't know what premise you're operating under, but here are my credentials, and here's my proof of insurance; is there anything else?". And that's all; if they write you a ticket, smile and say "thank you very much". The biggest issue that people have been getting into is trying to argue or claim their status, which isn't going to get you anywhere. If they give you a ticket, make sure within 72 hours you send an endorsed version of that ticket back "accepted for full satisfaction and accord". Make sure you include a certified copy of your fee schedule. That is why it is important to make sure your fee schedule is recorded on the de facto. The time to get your fee schedule is not after something has happened. If it's not provided at the time, it's not going to be useful. Optimally, if you do have a certified copy of your fee schedule, you can provide that at the same time as the traffic stop by handing it to the privateer. Additionally, you can obtain their business card (which is a very important thing to do). It's critical to film the entire encounter, from the moment the stop begins until it's over. If they comment on it, you just ask them if they are wearing a bodycam; if the answer is yes, then there shouldn't be any issue. You're just "making sure the interaction is filmed for the safety of both parties". Aside from that, after the ticket is endorsed, send it to the address on the ticket along with your certified copy of fee schedule, and if you want, a cover sheet explaining who you are and your status; you can include a copy of your credential card. And that's it. If it does go to court, record a certified copy of your 928's into the court docket. At that point, things should be dismissed fairly quickly."

1. Committee Reports

Notices and Claims, Cheryl – We will hold the next meeting on Thursday, August 29 at 5p.

<u>Outreach</u>, Cheryl – We have made website updates. We put a notice on Telegram on International Outreach and TASA. ASNs from New Jersey are considering attending the Danville/Gretna event.

Sean has asked for literature and flyers to send out.

What about having food truck(s) for the event, or we could order sandwiches?

<u>Jural Assembly</u>, Lorrayne – We meet once a month, next one is September 19. The next jural training meeting is on 9/5 where we will review the different positions and duties.

Lorrayne asked people to speak to their local sheriff. We have noticed all the sheriffs via mail, and email. She spoke to hers and it was a great experience.

You can print the sheriff notice off the website and introduce yourself politely with it to your local sheriff.

Website, Lorrayne – We update it Fridays but sometimes it does not update properly. The Public Square is the main page for us and shows what is happening.

International Business Assembly, Lorrayne – Planning and thinking possibilities.

<u>PKTF</u>, Steve – We are back focused on the militia side working on the loss of all communications plans. We are identifying rally points around the state. We will establish another committee inside PKTF. Everyone is militia, but we are establishing an organized one and will vet people to see where they best fit in, i.e. operators, or support staff. For national emergencies we will be making contact with the Virginia National Guard. In Virginia it is in Richmond, and James W. Ring is the Admiral General. We are working on the militia notice. A lot of the militia are corporate but they do not know it. PKTF is looking for more people to support their work. We meet every Monday night at 7:30p.

Court Document & Process Committee, Randell – Last Wednesday we completed the civil process. Now we are moving into a different phase, the citizen's arrest.

We have a public duty to help keep neighborhoods safe, and to be a witness when needed.

The process shifts from civil to criminal when one person shows malicious intent.

<u>Vetting Committee</u>, Randell – The committee is now active. Aaron Ashanti has applied for the public notary role and has passed the written process. The next step will be an interview Friday at 6p. If we approve him, the committee will nominate him. We are starting the vetting process now. Holly will go through the process, and the next step will be elections.

Treasury Report, Patty - Balance as of 7/25 was \$2,449.38 (actual \$1,869.30)

Recording secretary report July income: \$143

July expenses: Square \$6.22; GoDaddy website \$26.99 (monthly fee), and August too;

Domain.land \$32.16 annual renewal for domains;

Several USPS reimbursements, several clusters requested reimbursement for postage and printing of sheriff notices;

Rental of American Legion Building in Gretna, \$50 deposit;

Other checks written and cleared for AVR, including the monthly contribution, also for the credential card and recording packages. Several checks have not cleared. We have been drawing down reserves and need to replenish them.

\*New Item, Lorrayne nominated Holly Pickle as a Recording Secretary and Randy seconded. We will vote on this in one month.

- 2. Governor's Invite (update). We are working on notice #2 to the Governor. We still want to meet in Esse. We will vote on this next time, and it will be publicly recorded.
- 3. Sheriff notices? Cheryl & Steve are keeping a list of what is sent. . . we also need Delivery Confirmation. Certain clusters have sent out notices.

- 4. Update the Bevin's Declaration for meetings? Full Bevins on Website.
- 5. Legislature Notice (update). KBM obtained signatures for both the Legislature and Justice notices. We will meet Thursday, August 29 at noon at the Woodbridge Wegmans to obtain additional autographs. Bring a red ink pen and red thumb print pad to witness the notices. He will take both to Beth Doyle who will record and publish them on the LRO.
- 6. Justice Notice (update, see item #5 above).
- 7. Lorrayne's meeting with Ohio Chairperson. Lorrayne met Lisa 3 weeks ago. Ohio is one of two states that have stood their states up. All their documents, handbooks, are processes documented. AVR is looking at what is their process on all pillars. We don't need to hold public elections until after the process is complete. Ohio moved forward on Ex parte Milligan after they were approved. We have to be comfortable and confident on what we are going to do, not perfect, but have a good grasp. Ohio is in the process of buying a printer for credential cards and license plates (Z plates). The goal is to have our court standing by the end of the year.
