Declaration of Peaceful Intent

Greetings to all Sheriffs on Virginia,

We wish to take this opportunity to introduce ourselves as **The Virginia Assembly**; men and women standing as "we the people" of the original Land and soil Jurisdiction on Virginia. We represent Virginia state, the unincorporated **State of the Union**; a member of the **Federation of States** (*The United States of America, unincorporated*), and we are the **Lawful Governance** structure on Virginia, **and we hold superior concurrent General Jurisdiction**. Let it be known that this Declaration of Peaceful Intent expresses the unanimous Will of The Virginia Assembly, standing as and for the people on Virginia.

We live by the clear and simple Divine precepts of: Do No Harm, Be in Honor, Act in Kindness, and Leave Things Better Than You Found Them. We affirm that we are at Peace and will Keep the Peace and uphold the Public Law for the people. We extend our honor and our hands in friendship and Peace to the County Sheriffs on Virginia.

The flag on the upper-left of each page of this Declaration is the newly adopted Virginia Peace Flag, as symbolized by the white dove of peace on Virginia. The background of the flag illustrates the lush green forests and mountains of Virginia. The words on the Virginia Peace flag say: Love, Honor, Integrity and Virtue, of which all Virginians aspire to.

You may not recognize the unusual looking flag illustrated below. That is **America's Civil Flag of Peace** which was shelved and hidden from us along with the rest of our true American History and Inheritance. America's Civil Flag of Peace is the symbol of our Peaceful and Lawful intentions for beginning this communication with you, and all stated herein is factual and true to the best of our knowledge.



America's Civil Flag of Peace

The Lawful Governance structure on Virginia arises out of an assembly of "the people" who inhabit and operate in the Land and soil jurisdictions and hold superior concurrent General Jurisdiction as one of the union States. The true, Lawful Governance on Virginia is now standing as the assembled people of The Virginia Assembly and we are responsible for ensuring that each county on Virginia has an elected, Lawful Sheriff with a proper Affirmation of Public Office (Land jurisdiction) who will enact their Public Duty to protect the people and their property, enforce the Public Law and uphold the Peaceful Will of the people.

The Public Law (Law of the Land) is clear and concise. A crime in law requires a *corpus delecti*, that is, the "body of the crime" or an injured party. For an action to be considered a crime, actual harm or trespass to the body or property must occur. A corporation cannot be the body of the crime or an injured party because it is artificial; a fiction. Without a verified claim of actual harm to a living man or woman or injury to their property, there is no case and no crime.

Currently, many Sheriffs are operating in the capacity of a sea jurisdiction, Municipal, corporate sheriff and are enforcing the convoluted mess of corporate statutes, codes, corporate by-laws and regulations, rather than the simplicity of the Public Law. Corporate law enforcement and courts have no delegated authority to detain, ticket, search, arrest, fine or jail the people under statutory sea "laws" (corporate by-laws) that are not meant for the living people on the Land and soil.

Virginia is an American republican nation-state and is a nation unto itself. We are the employers of the Federal Service contractors that were employed, through service contracts called Constitutions, to provide supportive services for the unified nation-states but instead usurped our power, national sovereignty, identity, and assets during the "American Civil War", and continue to unlawfully wield undelegated authority against the people today. For decades we have been living under a corporatocracy and a technocracy implemented by the globalist "elite" (i.e., Central Banks, IMF, UN, WEF, WHO) and other unelected, international, corporate employees and entities that control governments, bribe politicians, influence policies, enslave the people and who are now acting in clear criminal trespass.

Our country, our nation-states and our people are amidst a global state of emergency due to unlawful and criminal actions taken by corporate, governmental service providers *posing* as lawful governments. Silence and acquiescence are no longer tolerable as the facts and evidence of harm are indisputable. In this moment we see the foreign (corporate) "governments" using extreme force against the people of our counties, our states, our country and our world. "We the people" stand united and we irrefutably and unequivocally denounce and deny the lies and criminality that underlies this momentum of harm against the people and all other aspects of Life. Virginia stands in Peace and "the people" will not be forced to succumb to tyranny under the guise of fictional, incorporated governmental service providers. We have researched history, we have heard their words, we have read their plans, we have now had to bear witness to the intended devastation, and we do not consent.

The people on Virginia require that the men and women who hold the Office of Sheriff be of integrity and honor, uphold the Public Law and protect the living people and their property. Those who currently hold the position of Municipal Sheriff (sea jurisdiction) are invited, through Lawful Conversion, to begin serving in the Office of Lawful Sheriff on the Land Jurisdiction of their county. This may take due diligence and study to ascertain and embody the proper education and procedures of a Land Jurisdiction Sheriff. This has been a tremendous learning process for the men and women of The Virginia Assembly who are now committed to reinstating Freedom for "we the people" on Virginia and to perpetuating Peace for our posterity by reinstating Virginia's Lawful Governance and American Common Law Court System on Virginia. The county Sheriff is instrumental in this process.

We have provided historical data and a questionnaire that will introduce some terms and begin to provide clarification of the duties and jurisdiction of a Lawful Sheriff, the proper delegation of powers and the fact that Municipal Corporations have no authority over the General Public. 
