Greetings Governor Youngkin and Lt. Governor Earle-Sears:

Virginia is an American, republican nation-state as declared in our Unanimous Declaration of Independence on July 4th of 1776; The Lawful Governance structure on Virginia is not a Democracy, we do not have political parties, and we are not a Commonwealth under British or Roman rule. 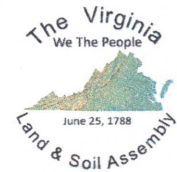

Public Notice of Harm – Cease and Desist

We have researched history, we have heard their words, we have read their plans, we now bear witness to the intended devastation, and we do not consent. “We the people” stand united and we irrefutably and unequivocally denounce, deny, and forbid perpetuation of the lies and criminal action that underlies this momentum of harm and trespass against the people and our ability to live peaceful, healthy, and meaningful lives. The attached *Notice of Harm – Cease and Desist and Public Notice of Harm 2023 – 2024 - “Exhibit A”* enumerates and substantiates a multitude of issues that require immediate attention and remediation.

Virginia stands in Peace and the people on Virginia will not be forced to succumb to tyranny under the dictates of incorporated governmental service providers acting in fictional and deceptive capacities. Our Federation of States has completed proper Due Process in all Jurisdictions (LAW) and any further usurpation beyond this notification is in clear betrayal of the people on Virginia and our Country. We require you to administer your Office in favor of the people on Virginia and not for your incorporated employers who are acting in open treason against the people of the American nation-states.

We realize that due to hierarchy and compartmentalization of information and employment, you may not be fully apprised of what is True; however, we consider this to be an additional Notice.
