1. Donations to the assembly for elections process and in esse meeting – See above note
2. VOTE: Read the newspaper public notice for election.
  1. Lorrayne Ham made the move to hold a vote to approve our public announcement regarding elections. Randy Rimbey 2<sup>nd</sup>d the move.
  2. We had a unanimous YES vote from all ASN's with 1 abstention (Melanie Carden was unavailable during the vote)
3. Discuss mock criminal trial committee (Lorrayne and Randy)
  1. We are seeking input from all ASN's regarding our mock trial. Randy suggested that we include a grand jury investigation which flows into a criminal case. We will meet on Thursday 2/20 at 7PM to brainstorm ideas.
4. VOTE: Submission for standing to federation. What that involves. (Lorrayne)
  1. Lorrayne Ham provided an update regarding Virginia standing up our Lawful government. She advised the group that we will submit our website as the baseline for all steps and procedures to the federation. Additional documents from the Jural Assembly will be provided. This cuts down on the paperwork which we will mail to the federation, thus saving time and money.
  2. Kevin Barry Miller made a 1<sup>st</sup> move to Vote on using our website as the basis of information to be sent to the federation for review. Cheryl Perko 2<sup>nd</sup>d the move.
  3. A roll call vote ensued: We had 21 Yes's and (3) who abstained. Shirly Bryant, Thunder Lane and Holly Pickle.

1. **Treasury Report:** We have aprox. \$1747 in our bank account (2) checks are outstanding at the moment. No new recordings were made in January. We had (4) donations totaling \$850. Wow! We have typical monthly expenses for Godaddy, square and zoom.
2. **Jural Docs Committee:** Randy Rimbey gave an update that we have almost completed the process. We hope to complete the criminal process within 2 or 3 weeks. Once finalized, the processes will be provided to the General Assembly for review and approval.
3. **Jural Assembly update:** The Jural Assembly will continue to meet 1x per month until further notice as the majority of the updates and work is being don ein the Jural Docs committee.
4. **Peacekeeping task force:** Steven Just has contacted the Sheriff association and has yet to receive any follow up or communications from them. Likewise, he has reached out to the militia group in Cambell county and has yet to hear back from these folks either. Steve also gave out his contact info and asked that anyone in need of assistance during the winter storm on 2/19 & 2/20 to reach out to him. Kimberly Taylor offered up a generator to anyone who may be in need.
