

Virginia State and County Election Process

Election Process generalities:

-No political parties! There should be no Republicans and no Democrats. We are all serving in a Republican form of Governance.

Public Office - Universal Requirements

- All Citizen positions require that all 1779 and 928 paperwork be recorded on the Public Record (LRO,GFG, other Land Recording system).
- Must be a Virginia State National in good Standing
- Must have lived on Virginia for at least 1 year and 1 day
- Must Not be a Dual citizen, Holding no licensure of any kind
- Act in Honor, Integrity, Virtue and Love
- All elected individuals on Virginia are properly affirmed State Citizens, not representatives. All State Citizens will act at the behest of the people who elected them and are accountable to the people for their actions .
- All Elected individuals can be recalled at any time through a formal Recall process. The affected Assembly simply votes to recall.

-Bar Association Members may not vote on any matter directly affecting the Virginia Assembly until they relinquish their dual citizenship. Holding of any licensure within the de Facto Territorial or Municipal government precludes you from voting on any item or in any elections until they become unlicensed.

-There is NO voter registration! All elections will involve the use of a passport/ASN ID, or Birth Certificate along with pictorial proof to document the elector's status as an American State National/Citizen on election day.

NOTE: A man or woman needs to be documented as an elector (1779 paperwork completed and recorded and other requirements stated in this document) within the Virginia Assembly.

State Level Virtual Elections

Until our assembly has branched into counties all state level elections will be held virtually. At the moment we are using Zoom.

Public Notice of Nominations

- a. The candidates must first be approved by the Vetting Committee (See Vetting Documents).
- b. A 30 day Public Notice of upcoming nominations complete with day, date and time of closing of nominations will be publicly posted. At the end of these 30 days nominations will officially close.
- c. During those 30 days the Assembly must advertise the nominated candidates to declare their intentions to the people by posting their 'platform/intentions' publicly in 3 places. The Assembly website, announcing it in the General Assembly meetings, and including local newspapers, public posters or appearances.
- d. After 30 days a detailed Roll Call vote by the General Assembly will be used to accept nominations.

The Virtual Election Process

- a. The Election Committee appoints election officials to call the roll call vote.
- b. Once nominated candidates are in place, another 30 day notice is given for the actual election. Advertisement of the election should be placed in at least 3 different sources. (Ie, Assembly websites, local newspapers, social media outlets, public posters etc.). The date, time and election process is included in the advertisement to educate your electors to elect your chosen candidate.
- c. Since the Court Guarantor, County Sheriff, MAA and those deputized along with the militia running security. The County Sheriff and County or State MAA can temporarily affirm and/or deputize ASN's and militia. A descriptive affirmation can be written to address the moderation, auditing,

counting and tallying votes as well as employ an autograph 'chain of custody' trail through each step. This will maintain the highest standard of election security, trust and honor in our process.

An example of an election affirmation follows (Please help refine this):

*"Do you **state your name** on county of _____ affirm your fiduciary responsibility to uphold the highest standards of all election processes, including: moderating, balloting, auditing, counting and tallying and delivering/transporting all votes with your autograph as set forth by the people of Virginia State or county of _____.*

Do you agree that in the event you allow any breach of the election process that the infraction can lead to dismissal or even being charged with a crime of altering the election process?

*By the will of the people, through the office of Marshal at Arms, (or Sheriff office) _____ **name** _____ you are temporarily affirmed into the position of Virginia Election Volunteer*

d. Zoom process for virtual elections:

- i. Open a Zoom window for a designated period of time, ie: 4 hours from 4-8pm (Could be expanded or shortened when needed)
- ii. Affirm and utilize at least two moderators to handle the influx of electors. **Moderators will be vetted and affirmed to the position by the Marshal at Arms.** (See example of Affirmation above.)
- iii. The moderators call one elector at a time to cast their vote. They will read off the candidates and the man or woman will verbally cast their vote for the recording
- iv. At the end of verbal voting the elector is instructed to go to the chat function and list their candidates by position.
- v. Upon completion of the elector listing their ballots they are instructed to leave the call.
- vi. Absentee balloting will be available if disabled, unable or unwilling to interact virtually. The process is as follows:

1. Notify the state election committee of your desire to elect via an Absentee ballot.
 2. The elector will be guided to the Absentee ballot on the website.
 3. You have 30 days to complete the ballot;
 - a. send it in to the election committee via postal service
 - b. A pdf fillable copy can be filled out and emailed back to the election committee
 4. A form of photo ID is mandatory, ie: passport, ASN credential card or de Facto Drivers License must accompany your ballot.
 5. It must be postmarked one (1) week before the election to ensure it arrives by election day
 - a. Any ballots received AFTER election day will not be counted
 6. Exceptions will be heard by the Election Committee BUT, must be due to a 'dire emergency' and be taken on a case by case basis.
- e. The elected man or woman, into the Citizen position, is then Affirmed to Office with a public, vocal Affirmation read aloud by an assembly official. If the new elected official chooses, they can read their own affirmation aloud to the assembly.. The affirmation must be witnessed and autographed by at least two ASN/C's.
 - f. The complete Affirmation is then recorded and uploaded to the LRO and a copy of the affirmation is listed publicly.

Post election process

Immediately after the election closes 3 Election Committee members including the Marshal at Arms and Court Notary confirm the Moderators tally. Then cross reference that tally with the Chat feature on the recording to double check the moderators count. This way the votes were counted and confirmed three times.

The Talley sheets are autographed by the three election committee members, including the Marshal at Arms, and witnessed and notarized by the Court Notary. The autographed Talley sheets are then sent to a Recording Secretary to record and upload to the LRO.

Once elections are completed and the winners are affirmed a 30 day post election window for communication will go out to the people. This is to publicly introduce and confirm the winners of each position to the people on Virginia. Means by which to do that are: Public news papers, Assembly website, posters, Assembly social Media (Facebook page)

What to know when County elections begin

What's needed to get your elections started?

Disclaimer! A county is a different jurisdiction than the state. A county may set up their elections as they choose. They do not have to use the state election process. However, we hope that you might use our process as a template to create your own. Feel free to use the process as is or edit to suit your needs.

Once you have your County Assembly formed, we recommend a minimum of 26 American State Nationals in your assembly you can engage in a lawful election process to choose your fiduciary county citizens. The ASN's in your assembly must have lived on Virginia for at least 1 year and 1 day. In the event that your assembly has less than 26 men and women you may invoke the "Last man standing clause" which would allow you to elect your positions with less than that number.

Suggested County Public Notice of Nominations

- a. The candidates must first be approved by the County Vetting Committee (See Vetting Documents).
- e. A 30 day Public Notice of upcoming nominations complete with day, date and time of closing of nominations will be publicly posted.
- f. During that 30 days a nominated candidate must then declare their intentions to the people by posting their 'platform/intentions' publicly in 3 places. Virginia Assembly website, announcing it in the Virginia General Assembly meetings, and include local newspapers, public posters or appearances.

- g. After 30 days county elections of nominees begin. Voting for nominees can happen en esse at precincts or virtual elections may take place. See en esse voting procedures below or virtual election processes above.
- h. Once nominated candidates are in place, another 30 day notice is given for the actual election. Advertisement of the election should be placed in at least 3 different sources. Ie, Assembly websites, local newspapers, social media outlets, public posters etc. The date, time and election process is included in the advertisement to educate your electors to elect your chosen candidate.

County Recommended Election Day Process

-Precincts will open for one day from 7 am to 7 pm and will be attended by 'qualified' volunteers vetted, affirmed and trained by the Jural Assembly Election Committee. Choosing an election chairman to assist in determining your county's process can help. The County Sheriff and/or County Marshal at Arms will assist with election security measures. The Sheriff can 'deputize' volunteers and ensure voting/balloting integrity. The MAA can deputize volunteers as well. They can also oversee the actual voting and securing and protecting the ballots when the precinct closes. Sheriffs, deputies and MAA and his deputies along with deputized militia scan the counting and transport the ballots to and from the precinct to ensure security. (See Marshal at Arms affirmation for election volunteers above.)

Absentee balloting will be available if disabled, unable to interact en esse. The process is as follows:

1. Notify the county election committee of your desire to elect via an Absentee ballot.
2. The elector will be guided to the Absentee ballot on the website.
3. You have 30 days to complete the ballot;
 - a. send it in to the election committee via postal service
 - b. A pdf fillable copy can be filled out and emailed back to the election committee
4. A form of photo ID is mandatory, ie: passport, ASN credential card or de Facto Drivers License must accompany your ballot.
5. It must be postmarked one (1) week before the election to ensure it arrives by election day
 - a. Any ballots received AFTER election Day will not be counted

6. Exceptions will be heard by the Election Committee BUT, must be due to a 'dire emergency' and be taken on a case by case basis.

County Positions for election

Elections for County Sheriff, Marshal at Arms, Justice, Coroner, Court Clerk, Court Recorder, Court Guarantor, Court Notary, Militia Commander and an Ombudsman. A partial list of duties of each position is found later in the document. (A query for Ombudsman, a Federal Position, dealing with 'conflict can also be sought)

The Court Guarantor, County Sheriff, MAA and those deputized along with the militia running security. The County Sheriff and County or State MAA can temporarily affirm and/or deputize ASN's and militia. A descriptive affirmation can be written to address the moderation, auditing, counting and tallying votes as well as employ an autograph 'chain of custody' trail through each step. This will maintain the highest standard of election security, trust and honor in our process. An example is found below.

- a. All voting will be a private matter via paper balloting. NO electronics!. Each election precinct will set up venues to show a picture ID and document your attendance. At such time a ballot will be given to you. You may then enter an enclosure and elect the candidate that best suits you.
- b. You will then carry your ballot to one of the ballot box stations where an attendant will observe you placing your **1 ballot** into the box.
- c. Ballots will be in a locked and sealed box.
- d. Election volunteers who have been vetted and affirmed by the sheriff or Marshal at Arms will monitor all voting.
- e. Ballots will be placed in a locked box and kept in a secure location until transported to election central for counting.
- f. Vetted and affirmed volunteers will count the ballots.
- g. Ballots will be audited for authenticity after counting (two sets of people to do it?)
- h. The elected man or woman will be announced publicly via a public venue, the assembly website, county courthouse and social media if available within 24 hours of election closure.

- i. The elected man or woman is then Affirmed to Office with a public, vocal Affirmation read aloud by an assembly official. If the new elected official chooses, they can read their own affirmation aloud to the assembly.. The affirmation must be witnessed and autographed by, at least two ASN/C's.
- j. The complete Affirmation is then uploaded to the LRO and a copy of the affirmation is listed publicly.

A sample election volunteer affirmation

An example of an election affirmation follows (Please help refine this):

*“Do you **state your name** on county of _____ affirm your fiduciary responsibility to uphold the highest standards of all election processes, including: moderating, balloting, auditing, counting and tallying and delivering/transporting all votes with you authorized autograph as set forth by the people of Virginia State or county of _____.*

Do you agree that in the event you allow any breach of the election process that the infraction can lead to dismissal or even being charged with a crime of altering the election process?

*Then by the will of the people through the office of Marshal at Arms (or Sheriff office) _____ **name** _____ you are temporarily affirmed into the position of Virginia Election Delegate (Not sure of the title?)*

County Recommended Post election process

Immediately after the election closes 3 Election Committee members including the Marshal at Arms and Court Notary confirm the Moderators tally by double checking and confirming the election results. Then the Talley Sheets are autographed by the three election committee members, including the Marshal at Arms, and witnessed and notarized by the Court Notary. The autographed Talley sheets are then sent to a Recording Secretary to record and upload to the LRO and with the county election office.

Once elections are completed and the elected Citizens are affirmed a 30 day post election window for communication will go out to the people. This is to publicly introduce and confirm the elected Citizens of each position to the people on Virginia. Means by which to do that are: Public news papers, Assembly website, posters, Assembly social Media (Facebook page)

County Position Descriptions (Partial listing of duties and responsibilities)

Public Office - Universal Requirements

- All Positions require that all 1779 and 928 paperwork be recorded on the Public Record (LRO,GFG, other Land Recording system).
- Must be a Virginia State National in good Standing
- Must have lived on Virginia for at least 1 year and 1 day
- Must Not be a Dual citizen, Holding no licensure of any kind
- Act in Honor, Integrity, Virtue and Love
- All elected individuals on Virginia are properly affirmed deputies, not representatives. All Deputies will act at the behest of the people who elected them and are accountable to the people for their actions .
- All Elected individuals can be recalled at any time through a formal Recall process. The affected Assembly simply votes to recall.

A. County Sheriff. (County election only.)

- highest ranking Officer of the Law.
- must have a bond for his performance of his duties (to protect him from damage claims)
- must take the proper non-religious Affirmation of Office required. The Sheriff elected by the local County Jural Assembly
- enabled to deputize as many Deputies as needed to keep the peace.
- He takes control of the operations of any and all Territorial and Municipal law enforcement agencies operating within his county.
- The Sheriff has an obligation to uphold and protect you from those who wish to violate your rights. This includes your right to free

speech, your right to religion, your right to assemble, your right to property, your right to bear arms, etc.

-It is the duty of the Sheriff to protect their counties from those that would take away your freedoms, your rights, and your property; from both foreign AND domestic entities.

- It is the Sheriff's duty to make sure that all warrants, federal or state, served within their county passes constitutional scrutiny.
- Defends the 4th amendment (Bill of Rights) for the people of his county. A constitutional sheriff upholds one's rights, property, and Public Law. "The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized."
- The Sheriff is responsible for the lawful implementation of the county correctional facility(s)

B. Coroner.

- Comprehends the functions of The Jural Assembly
- Organized
- Level headed
- Good communications skills
- Works well with people individually and in groups
- Possess sufficient medical training or other similar training and experience in pre-medicine, healthcare, peacekeeping, forensic science, criminal science, or mortuary science, etc., so as to be able to determine the cause and manner of an individual's death.
- Be fully apprised of all functions, policies and procedures as outlined in The Virginia Assembly Coroner's Handbook.
- Investigate and report the cause and manner of death
- Identify the deceased
- Document disposition of physical remains, forensic evidence and personal items found with a body;

- Complete death report;
- Identify and notify kin and order the removal of the body to a funeral home or other facility;
- Release evidence related to an ongoing criminal investigation by Peace Officers.
- Term: 4 years

C. Marshal at Arms

- Provide security of all State Jural, General, Business, and Militia Assembly meetings; by providing strong enforcement and protection services for our Common Law Court system;
- Maintain channels of communications between State Militia Commander, Continental Marshals, State Coordinators, and Federation of States;
- Coordinate meeting between other relevant and pertinent Peacekeeping entities as a result of judicial developments that involve other nation-states;
- The State Marshal at Arms is responsible for Outreach and Education to U.S. Military, U.S. Marshals service, and Corporate Law Enforcement (local and federal);
- The State Marshal at Arms works with the Continental Marshals for International (other nation-states) related to international business and communication
- The State Marshal at Arms works with county Marshal at Arms and provides guidance;
- To organize correspondence of county sheriffs - provide security & disruption mitigation - affirmation of office = public record
- Works with Committee of Safety to bring forward elected jurors, militia and peacekeepers
- Term: 4 years

D. Justice (Court session responsibilities)

- verifies that Recorder, Clerk, Assurance Guarantor and Notary are present in Court;
- verifies with Marshall at Arms that all participants have been identified and cleared to in Court;

- oversees Court decorum and order, may request Marshall at Arms to remove anyone who is not in order;
- oversees any inquiries to evidence, facts, testimony presented.
- keeps an active case moving forward with fairness;
- provides referee services to our Courts;
- Term: 4 years

E. Court Notary:

- Has completed rigorous training in Due Process Proceedings
- Must obtain a red ink Public Notary Stamp
- Organized and efficient
- Competent in Computer Document processes
- Level headed, works well with people
- Good communications skills
- Official Witness to business transactions and records for the State, and the People (Excluding items recorded by State Recording Secretaries)
- Official Witness to the business transactions used to secure our identities, control of assets, and invoke the Public and Organic Law
- Performs all duties as per Due Process
- Term: 4 years

F. Court Guarantor (previously Bondsman)

- instructs people on how to post an Assurance Guaranty;
- confirms the Assurance Guaranty Register for each day of the Court session;
- confirms receipt of Assurance Guarantying fees (in conjunction with the Court Clerk) at the close of each day;
- secures and locks the safe containing the Assurance Guaranty fees;
- takes charge of prisoners and ensures their safety and good conduct while in court;
- maintains security of the actual courtroom and directs traffic within it;
- seats people in the gallery (if one exists), assists disabled or physically injured people;
- distributes educational information to members of the Jural Assembly;

- administers Affirmation of Truth Testimony to both the Wo/Man who Presses a Claim and the Accused prior to giving their testimonies.
- Affirmation of Truth Testimony:
 1. Do you (*Name*) promise to tell what is true?
 2. Do you (*Name*) agree to abide by the Jury's decision?
- provides safety and security of the Court venue and all people* attending.
- Term: 4 years

G. Court Clerk (In session court responsibilities)

- determines venue and jurisdiction of the case
- Ensures all documents; ie: evidence, affidavits, writs and requests are in place for the case
- Invites the jury for the case(s)
- presents all evidence, facts, testimony that is the history of the case.
- calls to order for the Case Number;
- announces the man* or the woman* who Presses a Claim and the Accused;
- announces testimony from both the Wo/Man who Presses a Claim and the Accused, Wo/Man who Presses a Claim proceeds first, Accused follows
- Term: 4 years

H. Court Recorder

- maintains transcripts and records all Case proceedings;
- stops recording when Jury exits Court to deliberate;
- maintains transcripts and the records or Jury proceedings (archive)
- Term: ?

I. Treasurer

- Comprehends the functions of The Assembly
- Has basic meeting and management skills
- Is level headed
- Good communications skills
- Works well with people individually and in groups
- Ability to work with the Banking Committee, Global Family Banks

and Federation

- Is adept at carriage accounting
 - Is familiar with accounting functions
 - Ability to train others
 - Ability to manage the State Bank Accounts
 - Maintains Assembly Bank Accounts and Assets
 - Works with the Global Family Bank and the Prosperity Centers
 - Reports to General Assembly as determined by Assembly
 - Works with all Assembly Pillars and Committees for budgeting
- Term: 3 years

J. In the future, you will also elect three Fiduciary Deputies to attend a Congress of the States, we are talking about a Continental Congress of the kind that issued The Unanimous Declaration of Independence. (** A state level election through the Jural Assembly**)

Appendix of Documents

Email of election directions for the people

Hello Virginian's

This is your final Announcement for our Virginia State Public Elections tomorrow from 4-7pm

This email contains all the information you need to successfully use your voice in the first Lawful Public Elections on Virginia in over 160 years.

There will be moderators who will be assisting you to place your votes but you will need to educate yourself as to the proceedings, that information can be found on the Virginia Assembly website at www.thevirginiaassembly.org Public elections tab.

Voting should go very quickly... Please do not ask non-election questions of the moderators, this is serious business and as such needs to be focused on the actions at hand.

When you arrive on to the zoom meeting, ensure your camera and audio are off and that your full name is listed on your zoom place holder square.

Raise your hand to get placed in the que.

Once your name is called, Turn on your microphone and your video (no votes will be taken if you are not visible unless you have made prior arrangements to do so, instructions are on the website)

You will then be called on by the moderator. You will state your name, County and you will hold up your photo ID to the camera on your device so it is visible to the moderator. The moderator will then go through each of the 10 positions and nominee names, you will state yea or nay. **Make sure you send a copy of your photo ID to elections.virginia@proton.me prior to 5pm tonight, if you have no video capabilities. Also, please make sure your photo is uploaded to your Zoom profile.

Once your live voting has completed, TURN OFF YOUR AUDIO, you will be asked to go into the chat and again state your votes. To make the process easier and more efficient, you may place your votes as follows (providing you vote "YEA" for all 10 nominees you may just write in the chat something like

this... [Lorrayne Evangelyn Ham, Carroll County votes 1-10 Yea]. Each position has a corresponding number so you do not need to worry. If you have some yeas and some nays, you may need assistance from the moderator, again raise your hand and wait to be called on.
