


These Bearers are not voluntary residents of any Federated State of State and are not Parties subject to any foreign law. Their only contracts are with the Principals.

We DO NOT need to re-publish status correction

- When up loading your documents they must be in a PDF format. No screenshots like it is your Instagram or Facebook page. We must be able to legibly see each page of your documents. So please do not lay them out on your floor and take a picture of them. We must have your witness testimonies as well as your 1779 document or 928 documents to verify you are lawfully an American State National or Citizen. Remember this is a publishing site that issues credential cards. You would want people to be able to see and read each page of your documents.
- 9. When filling out the form for your business account, please fill out all * as your account will not go through.

(3) The only requirement is that you have reclaimed your natural and lawful political standing as a man or woman standing on the land and soil jurisdiction. Page 15 Those who have already recorded in either the LRO or LRS or who do so through the LRO in the future don't have to record anything again. They just have to provide enough information to verify that they declared, recorded, and published.
