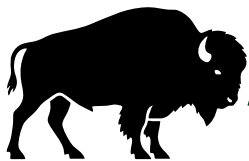

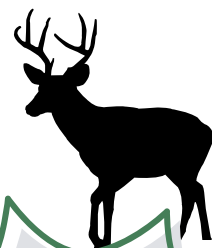

- NO PRIVATE SALES ON AUCTION PREMISES



ADDITIONAL BIRD SALE INFORMATION!!!



- Birds will begin selling at 10 am, please have them checked in before then!
- We are limiting the number of consignments to 300 cages, to reserve your spot please text us your name, pictures(optional, but we would like to post them prior to sale!) and how many cages you will be bringing.
- Out of state birds must have A. NPIP paper work with annual testing or B. a certificate of veterinary inspection (CVI) issued within 30 days prior to entry AND meet the testing requirements with a negative test within 30 days prior to entry.
- No rabbits, reptiles or guinea pigs allowed!!
- Once sold, buyer is responsible for picking up bird, and feeding it. We will not be storing birds in our barn for the remainder of the weekend.
- Online buyers must pick up by the next day!
- Cages & items in the cages will sell with the birds.
- Cages must meet USDA requirements, birds will not be sold if requirements are not met.

ALL CAGES MUST-

HAVE LIVE ANIMAL STICKER OR SIGNS ON SIDE AND TOP

HAVE SOLID BOTTOM, ESCAPE HATCH & HANDLES TO LIFT CAGES (NO CARDBOARD BOXES)

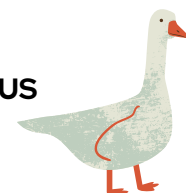
HAVE FOOD AND WATER INSIDE

HAVE ENOUGH SPACE FOR THE ANIMAL TO MOVE AROUND ACCORDING TO THE INDUSTRY STANDARDS FOR SUCH ANIMAL

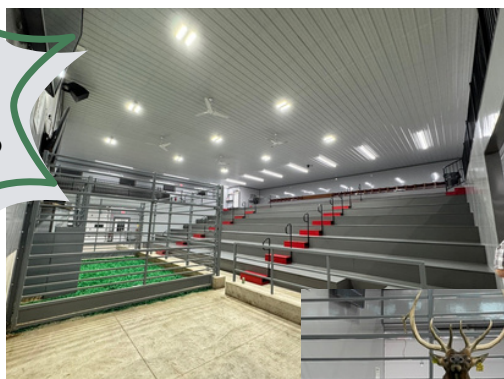
HAVE SUFFICIENT BEDDING ACCORDING TO THE SPECIES INSIDE THE CAGE

CAGES REQUIRING USDA LICENSE MUST HAVE BUFFERS ON SIDES

ALL CAGES MUST MEET OR BE ABOVE THE USDA REQUIREMENTS TO ENTER THE SALE FOR US TO BE ABLE TO CONTINUE THIS SALE!
