NOTICE OF PROPOSED RULEMAKING

California Code of Regulations, Title 23, Division 3,

Chapters 2, 2.7, and 2.8

Water Measurement and Reporting Regulations

The State Water Resources Control Board (State Water Board or Board) is proposing to revise the regulations for measuring and reporting surface water diversions. High quality, accurate water diversion data is essential for managing water supplies throughout the state. Proposed regulation revisions improve readability and refine key terms. The proposed revisions also require diverters to report data in a standardized format, provide an email address, identify measurement locations, and make other minor accompanying changes. The revisions are needed to align regulatory requirements with the Board's new online water rights data system, California Water Accounting, Tracking, and Reporting System (CalWATRS).
