As we do have kids, dogs, and old slow guys in the campground, we would like everyone to take it slow while riding in the campground! We recently put up some speed limit signs to help remind riders. Thank you.

BMW Motorrad International GS Trophy Challenge Qualifier, Midwest Region. Late in 2018, we were approached by BMW and asked if we would host the 2020 BMW Motorrad International GS Trophy Challenge Midwest Qualifier in May of 2019 at VTRA. With May being so close to the Show Me Dual Sport Ride and Adventure Ride, we worked with the AMA, US Forest Service, and The Missouri Mudders to come up with the dates of September 14-15 for our National Dual Sport Ride and Adventure Ride so that we could accommodate BMW to hold the Midwest Qualifier on May 17, 18 & 19. After getting all the approvals to change our 2-day rides

to September 14-15, we subsequently heard from BMW that we will NOT be hosting the BMW GS Trophy Challenge Midwest Qualifier this year. As it really is too late to change back to June for our 2-day events, we hope everyone will understand and support these new dates for 2019. We will reconsider the 2020 event dates later this year. If you have a preference, please let us know.

Course Change for Dual Sport Ride. Since the Show Me 2-day event dates have been changed to September this year, we will have additional time to make changes to our dual sport ride course. We plan to consolidate our previous A & B courses, with some changes. The course will be more of a dual sport ride rather than a 75 mile hare scrambles course. There will still be plenty of single track but we will have more open sections tying the overall course together. The Saturday and Sunday courses will be different, with the Sunday course providing an early out option at lunch for those that need to get a start on the journey home and a full length ride for those that have time to stay. We also plan to incorporate work days into our April and May ride weekends at the VTRA so that we can begin work on the trails. Everyone is welcome and invited to help out on those weekends. Workers can camp for free and the club may provide some grilled burgers or brats for those that volunteer.

<u>VTRA News</u>. In November of 2018, the Skunkwerks Moto group from Springfield, Missouri hosted their annual Middle of the Map (MOM) Rally at our VTRA facility. While temperatures that weekend were brutally cold, we think the event was a success. In fact, Skunkwerks was so impressed with the VTRA facility that they want to have one or two events per year at VTRA. We think this is great that the VTRA has evolved to the point where other groups now consider it a legitimate/desirable venue for their motorcycle events. Thanks to everyone for all your efforts getting the VTRA to where it is today!



## SHOW ME 500 - AMA NATIONAL ADVENTURE RIDE

PLEASE NOTE THE <u>DATE CHANGE</u>! (We changed the date from June to September to accommodate BMW to host the International GS Trophy Challenge Midwest Qualifier, only for BMW to cancel the qualifier.)

**September 14-15, 2019 --** The MTRA will again this year be hosting an AMA National Adventure Ride! The series is being sponsored by KTM in 2019, with events being held all over the U.S. The MTRA's AMA Show-Me 500 Adventure Ride will be held on the same weekend as our AMA Show-Me 200 Dual Sport Ride, but with a very different route. Riders of the Adventure Ride will share in the fun with our Dual Sport riders for the camping, meals, attendance prizes, and camaraderie. To ride the event, please fill in the entry form and send it back to the MTRA ASAP. The entry form can also be downloaded from our website. Entries and Cancelations must be received by August 30, 2019. Late entries will not receive meals, T-shirt, or attendance prizes.

The AMA Adventure Rides are geared more toward street orientated motorcycles, Super Ténérés, KLRs, GSs, V-Stroms, KTM adventure bikes, and about any street legal motorcycle, large or small, that will negotiate a gravel road. The route is generally 200 to 250 miles per day for two days, but it's easy to add more miles or short cut as the route is on mapped public roads. Riders ride at their own pace, with other riders, or by themselves. Lunch and gas stops are plentiful, and you can decide when and where based on our suggestions. Two-up riders are welcome as nothing is too challenging or difficult. The route covers gravel forest roads, paved back roads, and 2 lane highways, aimed at being a scenic, pleasant, easy-paced ride. Our goal is to keep our older riders interested, and bring in novice riders, riders that may not be up to the grueling pace and challenges of our Dual Sport ride but would like to be out there riding and joining in the fun.
