

**Declaration of Execution
Creating An
Unincorporated, Organized, Self-Supported Church Ministry
Hereby Named: The Church of the Flat Earth - SSM**

KNOW ALL PEOPLE BY THESE PRESENTS:

That the undersigned Executive Director and Managing Director have executed an UNINCORPORATED, ORGANIZED SELF- SUPPORTED MINISTRY (SSM) this 7th day of December, 2019, under the name of Church of the Flat Earth - SSM as described in Title 26, United States Code and Income Tax Regulations, June 26, 1977 Edition, published by Commerce Clearing House, Section 1.51 1-2 (ii) volume 1, page 33, 471 & 472.

In The Law of Tax Exempt Organizations by Bruce Hopkins, published by Lerner Law Book Co., 1977, page 107 it is stated:

“The term “church” (ministry) includes a religious order to a religious organization if such order or organization (a) is an integral part of a church, and (b) is engaged in carrying out the functions of a church, whether as a civil law corporation or otherwise.”

The Church of the Flat Earth is “otherwise” as a Self-Supported Ministry. It is Congregation of people with a unique perspective of the earth being essentially flat and unmoving and the sun, moon and stars close. The Firmament exists and there is no “space”. This perspective provides a shifted paradigm wherein our Spirituality and relationship to God is affirmed. Our “Religion” - as defined by the First Amendment - is thereby established.

This Declaration Explicitly States and Provides that:

This declaration hereby creates a Non-Denominational Ministry dedicated to awareness and reverence of the scientifically demonstrated Flat Earth and its Creation by a Creator. This Church as an organization respects the choices of individual congregants as to their personal definition of such Creator. The Church of the Flat Earth is a place of fellowship dedicated to the study, review and promotion of the Spiritual ramifications of humankind’s home being a Created Realm.

We dedicated our works - as the Church of the Flat Earth - to further the liberation of thought which a truthful perspective of cosmology lends to the world-view of a Spiritual journey. Throughout the world - we carry this message of an unmoving, essentially flat topography to better the health, education, and social welfare of all mankind.

The Executive Director and Managing Director shall have all rights necessary to fulfill the purpose of this indenture and to conduct any legal business not specifically prohibited by this banking authorization and establishment.

The Executive Director and Managing Director may or may not be ordained and serve without bonds of any nature being required.

This Declaration provides and states that The Church of the Flat Earth aka the Ministry, is not nor required by law to be a public entity such as a business partnership, corporation, joint stock company, or any other profitable form of association.

The Executive Director and Managing Director may appoint directors for a general Board of Directors. These directors agree to attend, direct and promote the preservation and advancement of the Church of the Flat Earth and its interests to their best abilities.

The Executive Director and Managing Director may not pay any income tax or funds from the ministry, as the Ministry does not receive or distribute federally privileged benefits or amounts of general federal revenue. Any "compensation for labor" is determined by the Executive Director and Managing Directors, in their sole discretion, as they deem appropriate to retain services and/or make additions to the assets of the Ministry.

ALL DOCUMENTS, CONTRACTS, CONVEYANCES, DEEDS, QUITCLAIMS, ASSIGNMENTS, ASSIGNMENT OF ALL OR PART OF ANY TITLE TO ANY ASSET OR PROPERTY of this Ministry and other legal instruments shall be executed by signing the name:

Church of the Flat Earth, SSM - by: the Executive Director

NOTICE IS HEREBY GIVEN TO ALL PEOPLE, PERSONS, CORPORATIONS, ENTITIES or other terms extending credit to, contracting with, or having claims against this Ministry or its Directors that they must look solely to the funds, property and other assets this Ministry for payment or for settlement of any claims, debts, judgments (decree), award, or other obligation which may become payable thereunder.

All action claims and/or suits against this private Ministry MUST be adjudicated by the Seventh Amendment of the Constitution for the United States of America. The Directors are not personally liable for the properties or matters of this Ministry nor is this Ministry personally liable for properties or business matters of the Directors.
