GRAND SECRETARY OFFICE UPDATES

FORM 23 - BYLAWS

With the adoption of Resolution No. 23, the positions of Senior and Junior Stewards have become optional.

The updated Form 23 is now available.

If your Lodge currently utilizes Form 23 or has similar language in its by-laws that does not reference Form 23, these documents must be amended in order to make the Stewards positions optional. If the Lodge decides not to implement this change, no amendment to the by-laws is required.

To amend your by-laws, you must submit them in writing, signed by the proposer, and presented at a Stated Meeting. Discussion and potential amendments may occur during this meeting. At a subsequent Stated Meeting, or a specially called meeting for this purpose, the amendment will be considered and voted upon without further revisions. Once the vote is completed, the secretary must sign and seal the updated Form 23 and submit it to the Grand Secretary's Office for approval.

INSURANCE PROGRAM AND SURVEY

We are aware of the exponential increase in insurance costs, and we are working on trying to find a property insurance solution for the Lodges of Texas. We are already on our 4th attempt, but we are determined to find something that utilizes our economies of scale to produce real savings for your Lodge. In order to get real quotes, we need real information about your property. Please take a few minutes to fill out this survey. This is not committing you to anything at this point. It will be used to obtain a quote which you can later choose to accept or reject, but by grouping hundreds of lodges across the State, we hope to receive substantial savings over your individual policies. The due date to fill out this survey and be considered in the initial round of this program is May 16th.

SERVICE AWARDS OPEN

Service Awards Requests are about to be opened for requests! You will be able to request any Service Awards that are for the 2025-2026 Masonic Year and any past awards that have not been presented.

Secretaries will see "Request Service Awards" on the left side of their dashboard.

Once there, it will automatically show you the upcoming awards.

You can then request to have them mailed to the Lodge, the Member's Home, or held to be presented at the 2026 ANCOM by the Grand Master.

NOTE 1: Any awards for the 2025-2026 Masonic Year not requested by June 30, 2025, will automatically be mailed to the HOME LODGE of the eligible members.

NOTE 2: If you do not see a member's award available, they are either ineligible or their award has already been requested by another Lodge.

The window for suspension will Begin May 1st to midnight June 23rd. Suspensions made after midnight June 23rd will not be accepted.

DUES CARD PROCESS

We will be updating the procedure for obtaining replacement Dues Cards. In the coming weeks, all replacement cards will be purchased through the online store using the link below.

A new member's card will automatically be requested once they have been updated as a Master Mason in Grand View. This will streamline the process and make it to where Secretaries no longer have to request cards.

MONTHLY LAW READING

As we prepare to install our new lodge officers, there are several qualifications for Worshipful Masters and Wardens, these are set out in Articles 276 and 276a.

Article 276. Qualifications – Any member of a Lodge in good standing, and who has previously served as Worshipful Master of a regular Lodge in another Grand Jurisdiction, or as Worshipful Master or Warden of a Lodge in this Grand Jurisdiction, and who is qualified according to the provisions of Article 276a of these laws, is eligible to be elected Worshipful Master. Such previous service may be either: (1) under election; (2) under appointment by the Grand Master in a Lodge Under Dispensation; or (3) under designation by the Grand Lodge in a newly chartered Lodge. The above provisions regarding service do not apply when a Worshipful Master is appointed by the Grand Lodge or designated by the Grand Lodge under the above circumstances, but previous requirements as enumerated in the following Article 276a apply to all such circumstances. (Revised 2011)

Article 276a. Additional Qualifications – Prior to his installation as Worshipful Master or Warden, a Brother shall in all circumstances first be qualified as follows:

- 1. To the satisfaction of the members of his lodge, he shall be proficient to properly open and close an Entered Apprentice, Fellowcraft, Master Mason's Lodge, and a Master Mason's Lodge of Sorrow in the manner prescribed by the Committee on Work and approved by this Grand Lodge, and
- 2. To the satisfaction of the members of his Lodge, he shall have completed a Grand Lodge approved course in the administration of his duties or the Lodge Instruction for Effectiveness program (L.I.F.E.) under the supervision of the Masonic Education Committee. The L.I.F.E. Program is to be administered by a Lodge Counselor appointed by the Worshipful Master, whose term expires upon the appointment of his successor in office. Any person who has previously served as Worshipful Master of a Lodge under the Jurisdiction of the Grand Lodge of Texas is exempt from the requirements of this article.
- 3. In all cases, unless otherwise exempt as hereafter provided, by attending at least one forum conducted under the auspices of the Committee on Work during the twelve months prior to his installation as Worshipful Master, Senior Warden, or Junior Warden. Brothers who hold a Class A, B, or C certificate, or are certified as proficient by the District Instructor for the Masonic District in which the lodge is located, a District Instructor at Large, or a member of the Committee on Work, are exempt from the requirement imposed by this paragraph. If an officer is being installed as a Worshipful Master or a Warden in multiple lodges located in different districts, the officer is only required to be certified as proficient by only one District Instructor, District Instructor at Large, or a member of the Committee on Work for exemption.

LEGACY BUILDER AWARD

This award can be achieved by adding \$500 to your endowment all at once or by adding increments each year until you reach the \$500. Please see your Lodge Secretary and fill out form 77b (linked below). There is no additional form, once you've added five units, the office will print your award and hold it for the Annual Communication. NOTE: this award is not retroactive so only units added after the 2025 Annual Communication are eligible.



CONSOLIDATIONS

The number of lodges in Texas has not decreased at the same rate as the number of members. Last year we lost 3% of our membership (mostly to deaths), but only 1% of our lodges consolidated, and that trend has continued for decades. For a number of, often good, reasons, lodges are slow to consolidate. Fifty years ago, when we had nearly a quarter million members, we averaged 245 members per lodge, with some lodges having over 1000 members. Today we average 86 members per lodge, and, honestly, that number is inflated as we now have endowed memberships which keep some people on the rolls that we haven't seen in years.

Fewer members per lodge doesn't just mean that you're supporting a building on fewer people. It also affects the Masonic experience.

In 1970, with lodge rooms comparatively packed, it was much more competitive to get a lodge office. As seen in Figure 1, of the members raised in 1970, only 28% ever got an office. Year-by-year, that percentage has steadily grown such that it's now near 70% (please note that the last few years shown haven't had as much time to be appointed, so those percentages will increase a little with more time). Going from 28% to nearly 70%, a huge




difference, is a change from most Master Masons practicing Masonry from the sidelines to most Masons practicing Masonry from the chairs. It's a change of focus from mostly helping with degrees and proficiencies to helping with leadership and administration. Make no mistake, leadership skills are something that people gain from Masonry, but it's not what makes Masonry "Masonry," or really what most people join for.

As seen in Figure 2, despite having more of our new masons taking leadership roles, we have fewer first-time Worshipful Masters. What was less than 13% repeating as WM has now become half of our WMs

being repeat Masters. That goes along with fewer members per lodge. Yes we're pushing those we raise into the chairs, but 31% of our lodges aren't even raising one person per year (over the last three years), making it impossible to add a new guy to the line each year. Obviously, those lodges tend to be the smaller ones.

In the 1970s, the top 50 lodges averaged 5 degrees per month, every month. Today that's 1 per month. Now you might say, "Hey, why don't we just divide the number of lodges by 5, going from 736 lodges to 147



lodges? Then we'll have more degrees, less administration, and more focus on Masonry." Well, as most of you know, it doesn't just work that way. There's a lot to factor in there.

One thing we need to try to mitigate with consolidation is the immediate loss of members. In 2023, seven lodges merged into other lodges. Following those consolidations, 19% of the dues-paying members failed to pay a single dues payment to their new lodge and are now suspended. Mergers may make us stronger in the long run, but they lose members at the start. I get it. People have an emotional attachment to their home lodge. If you're the WM of a lodge that just gained a lot of new members via consolidation, please do more than an email or letter inviting them to the next Stated Meeting. Try to get them to one of your lodge's big events, maybe do some kind of program at your next Stated regarding their old lodge and merging over, or at the very minimum, call and talk to each of them personally. We periodically have Grand Lodge membership programs. Maybe a few minutes at OLT, a GM Conference, or DDGM training about smoothing consolidations would be in order as well.

Another issue to consider with consolidations is loss of coverage. Most Masons live within 10 miles of their lodge, some a little farther out, but in practice, there's a limit to how far people will continually drive to lodge and be active. In the big cities, travel distances may not change much with a merger, but that's not the case when you get rural. In some areas we're already down to key lodges serving those counties, and if we lose them, we'll have no lodge left to serve the men in that area, a loss of coverage, and a loss of Masonry's influence. Divide the number of lodges by five, and you won't multiply the number of degrees per lodge by five. We'll lose influence in areas.

Overall though, we can help mitigate the loss of members and coverage from consolidations, and there are a great many benefits to having more members in a lodge. In addition to shifting the focus back to Masonry, there are also huge financial benefits. Not only do you have less overhead to maintain one building instead of two, but you also have a huge boost to your investments when you sell one of them. Consolidations are not just coming. They're here. Let's guide them to help make us better. - Zachary Haston

SECRETARY INSTRUCTIONS

The following information is intended primarily for the Secretary but may be meaningful to many of your members.

Lodge Suspense System:

Suspense Dates – Lodge Secretaries should create a suspense system (a reminder system) to alert the Lodge that certain documents are due. This list is offered as a "starter kit' for your consideration:

- a. January The Worshipful Master should appoint a Committee on Members in Arrears (Article 319a).
- May 31 W. B. and Brandon Carrell Award nominations may be submitted to the Grand Lodge Committee on Public Education for evaluation and recommendation to the Grand Lodge Trustees (Article 14b).
- c. Mid-June Look for the Annual Returns Format from GL. (Downloaded from the Grand View System after June 24th. Notify the GS staff if you need the returns mailed as a printout).
- **d.** June 23 Lodge elections must be completed at the last stated meeting prior to midnight of June 23 (Art. 292). Notify us of the new Lodge Officers immediately so they can be printed in the Directory of Constituent Lodges (do not wait for installation). Submission will be available on the Grand View System from May 24 through midnight June 23.
- e. June 23 Endowed Membership checks must be in the Office of the Grand Secretary by June 23 to start earning interest in order to receive returns by the next year (Art. 318a). Changes to the amount of endowments must be voted on at the same meeting as the Lodge elections, and notification to the Grand Lodge must be before June 24th. Endowed Membership applications received at the Grand Lodge on or after June 24 must be for the amount that the Lodge reported.
- f. July 15 Statements of Availability due GS Office. (6a).
- g. July 31 Lodge installations must be performed from June 24 to prior to midnight July 31 (Art. 298).
- **h.** August 15 Annual Returns Report due to Grand Lodge (Art. 493).
- i. August 15 Resolutions due in GS Office (Art. 172).
- j. September 15 Lodge Minimum Audit Report 71 is due to the GS Office NLT September 15 (Art. 284).
- **k.** September 15 Vanguard Applications are due to the DDGM NLT September 15 and to the Grand Secretary NLT September 30 (refer to Vanguard Application Instructions).
- October 1 Lodge By-Laws that must be reviewed by the GL Committee on By-Laws due the GS Office NLT October 1 (Art. 219).
- m. Nov 15 Form 990-N, Electronic Notice (e-Postcard), must be filed with the IRS by Lodges that have gross receipts of \$50,000 or less or do not meet the requirements for filing the IRS 990 or IRS 990EZ. (Lodges must file the appropriate Form 990 no later than the 15th day of the fifth month following the close of the organization's fiscal year.)
- n. Dec. 28 Proxy Certificates are due the GS Office NLT December 28 (Art. 4). You should always appoint a Proxy (in case of an emergency) but he would not vote if any of the top three officers were available. Remember, each brother can have no more than four votes. Therefore, a sitting Worshipful Master cannot be a proxy for another Lodge.
