## FROM THE GRAND MASTER

### PROCLAMATION No. 1 – 2026

**WHEREAS**, the Grand Lodge of Texas, Ancient Free & Accepted Masons, is an institution founded upon dignity, discipline, and reverence for the ancient landmarks and traditions of Freemasonry; and

**WHEREAS**, the officers of the Grand Lodge serve as the visible representatives of the Craft, both within tiled meetings and in public ceremonies, and their conduct and appearance reflect directly upon the fraternity as a whole; and

**WHEREAS**, the establishment of a consistent attire standard for Grand Lodge officers encourages uniformity, professionalism, and respect across all constituent Lodges within this jurisdiction; and

**WHEREAS**, the public image of Freemasonry is strengthened when its leaders present themselves with care, dignity, and professionalism during occasions where the Craft is represented;

**NOW, THEREFORE, BE IT PROCLAIMED**, that the officers (including District Deputy Grand Masters), committee members, and representatives of the Grand Lodge of Texas shall adhere to the *General Attire Protocols for Officers, Administrators, and Officials of the Grand Lodge of Texas, Ancient Free and Accepted Masons, MMXXVI* when attending any official event of the Grand Lodge of Texas, or when representing the Grand Lodge; including but not limited to the Grand Communication, conferences, workshops, official visits, officer leadership training, forums, exams, meetings of the board of trustees, funerals, corner stones, dedications, lodge anniversaries, processions, and observances.

### DECISION No. 1 – 2026

**QUESTION:** Is it permissible for the Tiler of a lodge to enter the room and sit in on the meeting once the opening ceremony has been concluded?

**DECISION:** No. The term *tile* is handed down to us from the stonemasons of the medieval era and is derived from the Latin *tegula*. Masonically, to tile is to seal a building to protect it from intrusion. A tiled meeting cannot be tiled if there is not a Tiler tiling the door. Every officer has a station or a place. The Tiler's place is outside the door. To permit him to enter the lodge room during a tiled meeting would be essentially the same as allowing the Senior Deacon to sit with the Secretary at his desk during the meeting.

The uniform code of bylaws for constituent lodges (Form 23) specifies that the Tiler shall be exempt from the payment of dues. He is not permitted to sit in on or participate in the business of the Lodge, so he is not required to pay dues.

*The Laws of the Grand Lodge of Texas* allow for some flexibility if a lodge does not desire to have one of its members missing out on the business of the lodge. Article 265 allows a lodge to appoint a Master Mason from another lodge to serve as tiler. Additionally, Article 221 allows for the payment of a salary to the Tiler for his services.

### DECISION No. 2 – 2026

**QUESTION:** Can an Entered Apprentice or Fellowcraft Mason serve as Tiler for a Master Mason's Lodge

**DECISION:** No. The tiler (elected or *pro-tempore*) must be a Mason of the degree upon which the lodge being tiled is opened.

### DECISION No. 3 – 2026

**QUESTION:** When a Master Mason's Lodge has been opened for the purpose of conferring the Master Mason degree on two or more candidates, can the lambskin apron be presented to multiple degree candidates at the same time.

**DECISION:** Yes. Article 431 specifies that the lecture and charge of the degree may be given to more than one candidate but is silent on the presentation of the lambskin apron. This portion of the degree was not in the original 1858 degree and was formalized in the early ages of the twentieth century. This ceremony occurs after the lecture and charge, which can be given to all candidates, therefore it is proper to make the presentation of the lambskin apron to all candidates at the same time.

## **GRAND LODGE INSURANCE UPDATE LIABILITY OPTION**

The Grand Lodge Property Insurance Program was announced in the 1 Nov 2025 Grand Secretary's Newsletter and is now in effect. I won't go over all the details of that again, but in brief, it is a totally optional offer for property insurance for your lodge at a rate of \$278.38 per \$100k of insured value per year and is being offered to all lodges. Coastal properties have an additional wind coverage cost on top of that. That is a better rate than you'll find on your own. You can still join now, and your rates will be prorated to the portion of the year left. That program is being offered through Lockton Insurance Brokers. Should you opt in, your payments will be made directly to Lockton, and if there is a loss, they will pay you directly.

Our desire was to add Liability insurance through Lockton as well, in one nice package. Unfortunately, we were unable to come to acceptable terms with Lockton on the liability portion and are here announcing another option that lodges can take advantage of for general liability insurance, through a different Agent, if they so choose. Again, like property insurance, this general liability insurance, while recommended, remains totally optional. It will operate much the same way as with property. There will be a form to fill out to get a quote specific to your lodge, which you will send to them. They will send you back a quote along with a form for the Worshipful Master of the Lodge to sign to bind. Just asking for a quote does not get or obligate you to insurance. They have to receive that signature to bind to actually put it into effect.


Lockton will handle property insurance. Higginbotham is offering to provide general liability insurance for all our lodges through Chubb as the carrier. With property, the key number that rates were based upon was agreed insured value. With general liability, the key number is the number of members in your lodge. Location matters too though, so I can't give you a set price per member. Figure 1 shows quoted general liability rates for several different lodges, across a range of locations and membership numbers. It's not a straight line due to location differences. The lodges quoted with 124 and 155 members were in higher risk areas than the one with 179 members. Use Figure 1 just as a general guideline to what the rates will be, and ask for a quote specific to your lodge. For most lodges, they will be in the hundreds of dollars per year.

The policy being offered here is for \$1,000,000 per occurrence/ \$2,000,000 aggregate per year general liability coverage with terrorism and hired and non-owned auto liability coverage included (covering the lodge for any officer doing lodge business in their own vehicle). Off-site events are not covered. This policy will cover your lodge for accidents on your property, but please note that it does not cover the Appendant Body or other renter themselves if both you and they are sued. We recommend Appendant Bodies and other renters get their own policy to cover themselves.

These policies, like with property, will extend through the end of 2026, and we will again be bidding them out together towards the end of this year for 2027 coverage. Hopefully, with more lodges on board, we'll get a great rate again, and hopefully, we can do both through one Broker/Agent instead of having to use two different ones. If you are an Agent and want to bid on the 2027 package, contact me.

General Liability interest forms will be uploaded to the Secretary's Resources next week, and emailed to the Secretaries, Masters, and Treasurers. To get a quote, please send them to the email address at the top of the form. Note that there are a couple of questions on that form that we could answer for everyone, but the carrier wanted each lodge to state it again for themselves. One such question is if you serve alcohol for a cost at your lodge. If your answer is yes, we need to chat.

## 2026 Grand Annual Communication Attendance

This year's Grand Annual Communication was again well attended. Last year we had 2675 individuals registered. This year we had 2617, a difference of only 2%. Of course, both of these last two years are off from the spike in attendance following the 2023 year, but they're still solid numbers, and while not the several hundred first-timers of a couple of years ago, we still had 300 voteless first-timers come this year.

Now registration does not necessarily mean attendance, and that comes into play particularly with lodge votes. We currently have 725 lodges in Texas, but only 541 (75%) registered to come, and only 466 (64%) actually picked up their lodge clicker. That doesn't mean that the other 36% of lodges didn't have members there. Most did. In fact, only 32 lodges didn't bring anyone at all, but the WM of those didn't show, and the Wardens and proxy didn't show either, or were otherwise representing. We have a challenge with plural memberships among lodge leadership. If you're WM of one lodge and SW of another, that other lodge needs to have another backup there for their vote. That applies to proxies too. By Grand Lodge Law, an individual can only have one lodge clicker, so if you are a Master or Warden of a lodge, you should be very careful accepting a proxy of another lodge you are a member of. Preferably, don't, as even well-orchestrated plans can fall apart if anyone doesn't show, and proxies, which have to be elected by the lodge beforehand, cannot be changed at vote time. Assign your proxy to someone who 1) plans to be there, 2) preferably isn't a WM or Warden anywhere, and 3) doesn't already have a proxy from another lodge. Secretaries, Treasurers, and Chaplains often satisfy the first two of those, but have to watch that third. Any MM from your lodge can be your proxy. Additionally, if you hold a proxy, even if you're real busy with Grand Lodge stuff, you need to check and make sure your lodge leadership actually showed and collected the lodge clicker. If in doubt, go check at registration.

Aside from registered but not attending and representation issues, we still had 184 (25%) of our lodges without anyone (WM, Wardens, or proxy) registered to represent them. Those 184 lodges represent 11,416 (18%) of our memberships, and all but 16 of those 184 are within 200 miles of Waco! Just as a reminder, when

Figure 1. 2026 Final Vote Distribution





Figure 2. Number of Lodge Memberships Held By Attendees





you are installed as Worshipful Master of a lodge, you promise regular attendance at the communications of the Grand Lodge. It's your job to get your lodge membership represented there. So, what did we have there? Figure 1 shows the final credentials report.

We've been inching closer to it, but for the first time, lodge votes outnumbered Past Master votes. As our lodge consolidation rate is slower than our membership decline rate, I expect this trend to, slowly, continue.

Figure 2 shows the number of lodge memberships that attendees hold. Statewide, 26% of our members hold a plural membership, but at the Grand Annual Communication, a whopping 56% of our attendees hold memberships in more than one lodge. These are, naturally, some of our most active Masons.

Please keep the plural memberships in mind when looking at Figure 3, which is the number of members a lodge brought to Waco last month. Because of all the plural memberships though, perhaps it's better to look not at the lodge, but at the home zip code of the individual voters, which is shown on the map below. On the map, a voter is only shown once.

If you compare the map of Texas voter to the map of Texas Master Masons, they look very similar with only subtle differences. We want everyone at the Grand Annual Communication, but the voter map is good as it indicates that the Masons of Texas are pretty fairly represented regionally. No one region is dominating their vote more than their population would warrant.

Finally, we had 521 Texas Master Masons attend this year who had not attended in either of the past two years. 39% of voters who came first the first time, or at least the first time in a while, carried their lodge votes, but that still leaves the majority who came for the first time in a while for other reasons. Some to vote. Some for the excellent fellowship.

My concluding paragraph would be the exact same as one year ago. I wonder if I'll be able to say the same thing next year. Seriously though, it was a good Grand Annual Communication. If you missed it, you missed great fellowship from the hallways to the hospitality rooms. Smiles and handshakes everywhere. It's an annual event. It's THE annual event!

## Lodge Spotlight

### Calling Over Coffee

#### ***A Simple Weekly Habit Strengthening Brotherhood Across Texas***

**At Arlington Lodge No. 438**, a quiet tradition has grown into one of the most meaningful outreach efforts in the district. Every Tuesday at 9:00 a.m., a small group of Brothers gathers for fellowship, a warm cup of coffee, and a shared purpose: checking on every Brother on the Lodge roster.

After reviewing the upcoming Lodge calendar, each caller takes a page of the roster and begins reaching out—regardless of where a Brother lives, how long it has been since he attended Lodge, or whether they saw him recently. If there is no answer, a friendly message is left. In some cases, the callers discover disconnected numbers that lead to obituaries, often becoming the only way the Lodge learns of a Brother's passing. Families frequently return the call with heartfelt gratitude, thankful that the Lodge cared enough to reach out.

When a Brother does answer, the conversation is simple and sincere:

**“We’re just checking on you. Is there anything you need? Here’s what’s coming up at Lodge.”**

Some Brothers are rushed but appreciative; others welcome the chance to talk. They may share health concerns, hardships, or the loneliness that often follows the loss of a spouse. The callers listen—patiently and without hurry. Many Brothers have returned to Lodge simply because someone took the time to call.

The Lodge's sickness and distress report has become far more accurate because of this effort. Brothers who would never call the Secretary or Worshipful Master often share important updates during these friendly chats. In several cases, callers reached Brothers only days before their passing, giving them one last moment of fraternal connection.

The goal is simple: **reach every Brother at least twice a year.**

When the roster is complete, the callers continue by reaching out to widows and members of appendant bodies. These conversations are met with deep appreciation. Sometimes the callers assist with small tasks—moving brush, mounting a TV, setting up a computer, or referring someone to a Brother with the right skills. Widows are often connected with the Blue Slipper Program offered by the Masonic Children & Family Services of Texas.

The inspiration for *Calling Over Coffee* began in 2015 when a Golden Trowel recipient was honored for personally calling his Lodge members. During the isolation of the COVID-19 pandemic, the idea resurfaced as a way to maintain wellness checks. When Lodges reopened, the weekly calls continued—because the need for fraternal love and concern never ends.

**Calling Over Coffee** is a reminder that a small habit can have a profound impact.

A cup of coffee, a phone call, and a few minutes of genuine care are strengthening the bonds of Brotherhood—one conversation at a time.

## MONTHLY LAW READING – PETITIONS FOR THE DEGREES

As we return to our lodges from the Annual Grand Communication, and get back to the business of making Masons, let us open the Law Book and examine what is actually required for a candidate to petition. All of the requisite articles can be found in Title IV Candidates.

**Art. 403 Petition for the Degrees: Requisites** – candidate for the degrees must file with the Secretary of the Lodge a petition in writing, which must be presented to the Lodge at a stated meeting only. The petition must state the name of the petitioner in full; his age; date and place of birth; his domicile during the preceding twelve months; and shall contain all other matters required by law and Form No. 26. Said petition shall be signed by the petitioner in person and shall be recommended and the application personally signed by not less than two members of the Lodge.

In the event of death, expulsion or suspension of either or both signers before the petition is received, it will be necessary to obtain other qualified signers.

A certified or photostatic copy of petitioner's birth certificate must accompany the petition, which shall be retained as a permanent record of the Lodge, or withdrawn by petitioner upon substituting a photostatic copy thereof; provided that, upon being furnished with satisfactory documentary evidence, the Grand Master may issue his certificate of approval in lieu of birth certificate, which certificate shall accompany the petition and be retained as a permanent record of the Lodge.

When a petitioner's name has been changed by law or other proper means from that shown in the birth certificate, and a full explanation thereof deemed satisfactory to the Lodge is attached to the birth certificate, the petition may be voted upon if satisfactory in all other respects.

**Art. 404 Petition for Degrees: Answers to Questions in Art. 398** – The petition for the degrees must contain the questions of Article 398 with the answers of the candidate thereto.

**Art. 398 Questions Answered by Candidate** – Before a candidate can be initiated, he must answer, in writing, each of the following questions:

1. Do you promise, upon your honor, to strictly adhere to and be governed by the Constitution and Laws of The Grand Lodge of Texas and the by-laws of this Lodge?
2. Do you sincerely declare, upon your honor, that, unbiased by friends and uninfluenced by mercenary motives, you freely and voluntarily offer yourself as a candidate for the Mysteries of Masonry?
3. Do you seriously declare, upon your honor, that you are prompted to solicit the privileges of Masonry by a favorable opinion conceived of the institution, a desire for knowledge, and a sincere desire to be of greater service to your fellow men?
4. Do you seriously declare, upon your honor, that you will cheerfully conform to all the ancient established usages and customs of Masonry?
5. Do you seriously declare, upon your honor, that you firmly believe in the existence of God, the immortality of the soul, and in the divine authenticity of the Holy Scriptures?
6. Do you seriously declare, upon your honor, that you have never before petitioned any Lodge of Masons for the degrees or any of them?



### **SECRETARY INSTRUCTIONS**

The following information is intended primarily for the Secretary but may be meaningful to many of your members.

**Lodge Suspense System:**

Suspense Dates – Lodge Secretaries should create a suspense system (a reminder system) to alert the Lodge that certain documents are due. This list is offered as a “starter kit” for your consideration:

- a. January – The Worshipful Master should appoint a Committee on Members in Arrears (Article 319a).
- b. May 31 – W. B. and Brandon Carrell Award nominations may be submitted to the Grand Lodge Committee on Public Education for evaluation and recommendation to the Grand Lodge Trustees (Article 14b).
- c. Mid-June – Look for the Annual Returns Format from GL. (Downloaded from the Grand View System after June 24th. Notify the GS staff if you need the returns mailed as a printout).
- d. June 23 – Lodge elections must be completed at the last stated meeting prior to midnight of June 23 (Art. 292). Notify us of the new Lodge Officers immediately so they can be printed in the Directory of Constituent Lodges (do not wait for installation). Submission will be available on the Grand View System from May 24 through midnight June 23.
- e. June 23 – Endowed Membership checks must be in the Office of the Grand Secretary by June 23 to start earning interest in order to receive returns by the next year (Art. 318a). Changes to the amount of endowments must be voted on at the same meeting as the Lodge elections, and notification to the Grand Lodge must be before June 24th. Endowed Membership applications received at the Grand Lodge on or after June 24 must be for the amount that the Lodge reported.
- f. July 15 – Statements of Availability due GS Office. (6a).
- g. July 31 – Lodge installations must be performed from June 24 to prior to midnight July 31 (Art. 298).
- h. August 15 – Annual Returns Report due to Grand Lodge (Art. 493).
- i. August 15 – Resolutions due in GS Office (Art. 172).
- j. August 30 – Vanguard Applications are due to the DDGM electronically no later than August 30 and to the Committee on Masonic Education electronically via [cme@grandlodgeoftx.org](mailto:cme@grandlodgeoftx.org) (refer to Vanguard Application Instructions).
- k. September 15 – Lodge Minimum Audit Report 71 is due to the GS Office NLT September 15 (Art. 284).
- l. October 1 – Lodge By-Laws that must be reviewed by the GL Committee on By-Laws due the GS Office NLT October 1 (Art. 219).
- m. Nov 15 – Form 990-N, Electronic Notice (e-Postcard), must be filed with the IRS by Lodges that have gross receipts of \$50,000 or less or do not meet the requirements for filing the IRS 990 or IRS 990EZ. (Lodges must file the appropriate Form 990 no later than the 15th day of the fifth month following the close of the organization’s fiscal year.)
- n. Dec. 28 – Proxy Certificates are due the GS Office NLT December 28 (Art. 4). You should always appoint a Proxy (in case of an emergency) but he would not vote if any of the top three officers were available. Remember, each brother can have no more than four votes. Therefore, a sitting Worshipful Master or Warden cannot be a proxy for another Lodge.
